Summary of Evaluation:

<u>Teaching</u> – Professor Mahalingam is an award-winning teacher who has taught a wide variety of courses at the undergraduate and graduate levels. Student evaluations of his undergraduate and graduate courses have consistently been in the upper quartile. Professor Mahalingam has also played a major role in mentoring students outside of the classroom by serving the Department of Psychology as the director of the Honors Program (the largest such program in the country) and the Accelerated Master's Degree Program (AMDP). In addition, he has mentored a large number of undergraduate and graduate students doing research in his laboratory.

Research – Professor Mahalingam's research focuses on different aspects of identity (e.g., race, class, ethnicity, gender), including how they intersect to influence discrimination and how people respond to discrimination. He has studied these issues in a wide range of marginalized populations in real-world settings. His work has provided important new insights into the causes and consequences of discrimination and how intersecting identities play a role in discriminatory behavior. Professor Mahalingam has produced fourteen articles and eight book chapters since his promotion in 2008 and he has seven additional articles under review. A number of these have appeared in high-impact journals and six of them have been cited over 50 times. In recognition of his growing stature among his colleagues, Professor Mahalingam was elected as a fellow of the American Psychological Association (2011).

In addition to directing both the Honors Program (2011-2016) and the Accelerated Master's Degree Program (2012-2016) in the Department of Psychology, he has served on the Executive Committee, Augmented Executive Committee, Undergraduate Committee, Graduate Committee, and an area admissions committee. Externally, Professor Mahalingam has served on three editorial boards and has been invited to review grant applications for the National Science Foundation, the National Institutes of Health, and the Department of Defense. He has also served on an advisory committee for a national association.
