Summary of Evaluation

<u>Teaching</u> – Professor Miller is a serious, committed, and successful teacher, who is dedicated to improving his teaching and incorporating innovative uses of instructional technology. He is a valued mentor and advisor, and has shown great success in identifying and nurturing students with untapped potential. Student evaluations of his courses have typically matched or exceeded those of previous teachers. At the graduate level, he has taught Economics 602, 604, and 620, and he excels at that level with the majority of his student evaluations in the upper quartile. Professor Miller has also been an active advisor of doctoral students in economic theory at Michigan.

<u>Research</u> –Professor Miller is a game theorist with a particular focus in the area of repeated games. This work engages important questions about how to sustain cooperation and achieve efficient outcomes in situations where there are repeated interactions among self-interested actors. Professor Miller has established an impressive record of placing high-quality pieces in top journals. He is a pioneer in the area of dynamic mechanism design, an area of burgeoning research activity with much of it verging on pure mathematics. His work is technically sophisticated but has economic content and relates to real world phenomena. Professor Miller is currently working on several new projects, including a promising new paper that examines the interaction between external enforcement and informal incentives in long-term relationships. He is also drafting papers on long-term employer-employee relationships and on multilateral enforcement in networks.
