Subject: Regental Action Required Under the State of
Michigan Conflict of Interest Statute

Action Requested: Authorization for the University to pay with Knowledge Village, LLC
(University of Michigan employee, Gabriel P. Dellavecchia, Partner and
Director).

Background:

The University of Michigan School of Education seeks approval to transact with Knowledge Village, LLC. Knowledge Village, LLC was the first place winner of a campus-wide social entrepreneurship competition in the Innovation in Action: Solutions to Education Challenge competition. The proposed agreement falls under the State of Michigan Conflict of Interest Statute as Gabriel P. Dellavecchia is a University employee as a Graduate Research Assistant with the School of Education and would be party to the agreement as Partner and Director of Knowledge Village, LLC.

However, the Statute allows the University to enter into such agreements if the following conditions are met:

- a) The public servant promptly discloses any pecuniary interest in the contract to the official body which has power to approve the purchase, which disclosure shall be a matter of record in its official proceedings.
- b) The purchase is approved by a vote of not less than 2/3 of the full membership of the approving body in open session without the vote of the public servant making the disclosure.
- c) The official body discloses the following summary information in its official minutes:
 - i) The name of each party involved in the contract.
 - ii) The terms of the purchase, including duration, financial consideration between the parties, facilities or services of the public entity included in the purchase, and the nature and degree of assignment of employees of the public entity for fulfillment of the purchase.
 - iii) The nature of any pecuniary interest.


The following information is provided in compliance with the statutory requirements contained in Section (c) above:

- i) The parties to the contract are the Regents of the University of Michigan and its School of Education and Knowledge Village, LLC.
- ii) The agreement is for a grand prize award of \$10,000 to the winner of a campus-wide social entrepreneurship competition. Knowledge Village, LLC will be supplying all the necessary resources and personnel to fulfill this contract. The remaining base contract terms and conditions are typical to those used in Procurement Services standard templates for other similar contracts entered into by the Regents,
- iii) The pecuniary interest arises from the fact that University of Michigan employee, Gabriel P. Dellavecchia is Partner and Director of Knowledge Village, LLC.

Gabriel P. Dellavecchia has met state law requirements with the disclosure of his pecuniary interest and formal appointment arrangements with the University of Michigan. Requirements, if any, that may be applicable by the supervisor of Gabriel P. Dellavecchia, under the Medical School's or OVPR's Conflict of Interest Committee's procedures are separately analyzed and managed.

We recommend that the Board of Regents approve the agreement between the University of Michigan and Knowledge Village, LLC subject to requirements, if any, that the supervisor of Gabriel P. Dellavecchia or the Medical School's or OVPR's Conflict of Interest Committee may impose.
