Subject: Research Agreement between the University of Michigan and Eli Lilly and Company

Action Requested: Authorization to enter into Agreement

Preamble:

A statutory conflict of interest situation was identified by the Office of Research and Sponsored Projects while reviewing the Proposal Approval Form.

This proposed research agreement (“Agreement”) falls under the State of Michigan Conflict of Interest Statute because Dr. Marschall Runge is an employee of the University of Michigan (“University”), and a paid member of the Board of Directors of Eli Lilly and Company. The law permits such an Agreement provided it is disclosed to the Board of Regents (“Regents”) of the University of Michigan and approved in advance by a 2/3 vote.

Background:

Marschall Runge, MD, PhD, the Executive Vice President for Medical Affairs and Dean of the Medical School, is a paid member of the Board of Directors of the for-profit company called Eli Lilly and Company (the “Company”). The Company wishes to fund a project entitled, “I4V-MC-JAJA: A Randomized, Active-Controlled, Parallel-Group, Phase 3b/4 Study of Baricitinib in Patients with Rheumatoid Arthritis” (ORSP #19-PAF06072) in the Department of Internal Medicine – Rheumatology under the direction of Dr. Patricia Cagnoli. The purpose of this project is to compare baricitinib (combined dose groups) to TNF inhibitors with respect to venous thromboembolism (VTE); to compare baricitinib (combined dose groups) to tumor necrosis factor (TNF) inhibitors with respect to key safety outcome; and to compare each baricitinib dose to TNF inhibitors with respect to key safety outcomes. Dr. Runge is not involved in any manner in this research project and was not involved in any manner in the negotiation of the Agreement terms.

Agreement Terms:

The terms of the Agreement conform to University policy. The period of performance for the project is approximately eight (8) years. The amount of funding support will not exceed \$330,000. Since research projects are often amended, this agreement includes provisions for changes in time and scope. University procedures for approval of these changes will be followed and additional conflict of interest review will be done as appropriate.


Impact of the Agreement:

The Agreement will support an effort by Dr. Cagnoli to use her expertise and University laboratory, as well as other University resources, to work collaboratively with the Company to compare baricitinib (combined dose groups) to TNF inhibitors with respect to venous thromboembolism (VTE); to compare baricitinib (combined dose groups) to tumor necrosis factor (TNF) inhibitors with respect to key safety outcome; and to compare each baricitinib dose to TNF inhibitors with respect to key safety outcomes.

Recommendations:

Dr. Runge has properly disclosed his service to the Company pursuant to the regular conflict of interest process and policies that apply to Executive Officers of the University. The president has put in place a management plan for this conflict which calls for Dr. Runge to recuse himself from any University decisions involving a business relationship with the Company and to inform the president when he is required to do so. In light of this disclosure and our finding that the Agreement was negotiated in conformance with standard University practices, I recommend that the Board of Regents approve the University's amending this Agreement with Eli Lilly and Company.
