Summary of Evaluation:

Teaching — Professor Burgard is an outstanding teacher and mentor in a wide range of undergraduate and graduate courses. She has done an excellent job building the health and society course that serves the numerous pre-med students who are now advised to take a sociology course before the MCAT. Student evaluations of this rigorous course have been outstanding. Professor Burgard also teaches the Department of Sociology's honors thesis courses and serves as a mentor to many honors undergraduate students. She is a stellar mentor at both the undergraduate and graduate levels having served on 43 dissertation committees and chaired 18 committees. The combination of Professor Burgard's teaching and mentoring in her role as the director of graduate studies has made significant improvements to Sociology's graduate program. She continues to innovate in the pro-seminar and through her series of professional workshops "Graduate School and Beyond."

Research – Professor Burgard's research examines how health disparities are produced across the life course, and why social disparities in health are so persistent despite change in the economic, social, policy and technological conditions, and contexts that affect health. She continues to work across several different large datasets (including two datasets she collected herself) and uses multiple sophisticated methods. She has published 45 peer-reviewed papers since tenure.

Many of these papers are in premiere sociological journals and many appear in a wide range of journals across public health, nursing, and medicine. She has twice won the American Sociological Association Section on Sociology of Population Distinguished Article Award.

Service — Professor Burgard has served as the director of graduate studies in the Department of Sociology for six years. She has done an outstanding job in that role, and she has invested great time and effort working through individual student issues with care and deep engagement. Additionally, she has worked with commitment on diversity, equity, and inclusion (DEI) issues in recruitment and climate. Under her leadership, Sociology's cohorts have become much more diverse across multiple dimensions. Professor Burgard is also serving as the DEI implementation lead for the Institute for Social Research. She contributes important leadership and service for the discipline via her involvement in the American Sociological Association and in her editorial board service.
