Summary of Evaluation:

Teaching: Professor Hoey's teaching contributions are valuable both to the Urban and Regional Planning Program and food-systems studies campus-wide. Her syllabi and course material reveal both reflection on course structure and content and attention to innovative and participatory teaching approaches. Professor Hoey's courses are well-attended and received, and her care in advising and mentoring of students is notable. She has supervised numerous research assistants, offering many of them opportunities in international fieldwork or article co-authorship, has served on eight doctoral dissertation committees, and has guided numerous master's projects. She has quickly moved to a central and indispensable position in the teaching mission of the Urban and Regional Planning Program. Professor Hoey's teaching contributions have also extended to urban-planning pedagogy nationally. With a colleague at another institution, she created, organized and secured funding for the International Planning Case Study Project, a series of on-line case studies designed to increase international-planning literacy among planning students worldwide. To date, educators from 143 universities around the world have registered to use the case studies as tools in their own classrooms.

Research: Professor Hoey is a leading advocate in the rise of food systems as a new and compelling area of research and teaching in urban planning. She has developed her scholarly expertise in three areas: food-systems planning, global and comparative urban development, and program evaluation. Her expertise in program evaluation has empowered her to not only be an advocate for food systems, but to also critically and carefully examine the varied success of new food systems and local food-governance strategies. Her extensive experience in global and comparative urbanism brings a rich set of international case studies to a field in which many innovations take place outside North America. Through this research, Professor Hoey has made a significant impact on the academy in several vital ways. She has actively promoted food systems as an important and timely new area of research and teaching in urban planning. She has built strategic and ongoing collaborations between her work in urban planning and food researchers in other disciplines, such as sustainability, public health and international development. She has greatly expanded planners' conceptions of what the research agenda for food systems can and should be. Her mix of co-authors and journals for her publications speaks to Professor Hoey's capacity to build cross-disciplinary and cross-institutional ties and reach cross-disciplinary audiences.

Service: Professor Hoey has engaged in diverse and substantive contributions to service and has made important commitments to service within the Urban and Regional Planning program, Taubman College, the campus-wide Sustainable Food Systems Initiative, and a host of local, national, and international programs and publications focusing on food-systems transformation. She has contributed to reviews of educational and funding programs in the larger world of scholarship that include serving in the Food Interest Group of the American Planning Association's Research Working Group and on the review panel for the USDA National Institute of Food and Agriculture. She is also on the Board of Directors for the Agriculture, Food, and Human Values Society. Professor Hoey also reviews manuscripts each year for leading journals in planning, such as the *Journal of the American Planning Association, Health Policy and Planning, Agriculture and Human Values*, and *Agriculture, Food Systems, and Community Development*.

It is with the support of the Taubman College Promotion and Tenure Committee and the Executive Committee that I recommend Lesli M. Hoey for promotion to associate professor of urban and regional planning, with tenure, A. Alfred Taubman College of Architecture and Urban Planning.
