## **Summary of Evaluation:**

Teaching: Professor Lapeyrouse taught seven different courses at the undergraduate and graduate level in Public Health and graduate courses for the Doctor of Nurse Anesthesia Practice program. Her teaching is primarily in face-to-face courses but she has also taught online. She served as primary reader for nine master's capstones/theses. Her student course evaluations range from very good to excellent. Professor Lapeyrouse's courses are well planned, intellectually stimulating, and engaging to various types of learners. She values and encourages student engagement utilizing multiple evidence based strategies, including the use of metaphors, technology (clickers, Text Connect), storytelling, content experts as guest speakers, and service learning projects. Students often comment positively on her ability to use examples and illustrations, innovative teaching methods, expertise in content and overall enthusiasm for teaching. Professor Lapyerouse has received numerous teaching awards being recognized for teaching excellence by students, faculty peers, dean and provost.

Research: Professor Lapeyrouse has focused her research efforts on understanding health disparities in Latinx populations, particularly with regard to mental health and health care access. Her research addresses national health priorities identified in Healthy People 2020 with work completed in the border-states with Mexico and in the Flint community. She has published seven peer-reviewed manuscripts since joining the University of Michigan-Flint faculty, with additional manuscripts under review. Professor Lapeyrouse involves public health students as co-researchers on her local projects. She has established significant research collaborations in the Latinx population in Flint and with other health disparity researchers in the state of Michigan. With these relationships now established, she has significant potential for future contributions to health disparities research with a focus on the Latinx population.

<u>Service</u>: Professor Lapeyrouse made significant service contributions to the community, profession, and university. Her community and professional service align with her research agenda. She is actively engaged with Latinos United for Flint and has engaged with the Prevention Research Center of Michigan in Flint. Nationally, she has served as a conference abstract reviewer for the Latino Caucus of the American Public Health Association. Professor Lapeyrouse focused her university service on committees and activities that support student centeredness and enhancing community engaged teaching across campus. She provided skillful leadership to the College of Health Sciences Academic Standards Committee and contributes significantly to the Faculty Advisory Committee for University Outreach.

These articles provided good quality data on the health behaviors, comorbidities, access and barriers to health care among Hispanic population living in that region. The results presented in these publications contribute to the understanding of health issues among Hispanics."

Reviewer (F): "I found all of Dr. Lapeyrouse's scholarly publications to be interesting and significant contributions to the public health literature. I especially was impressed by the article she co-authored in the journal, Behavioral Sciences titled, "Income and Self-Rated Mental Health: Diminished Returns

for High Income Black Americans." In light of the current political, economic, and sociocultural climate in the U.S., this article offers special insights for public health research and practice. It should be noted that this article was published in a psychology journal. This is notable because it lends significance to the broad scope of Lapeyrouse's research."

Reviewer (G): "She has definitely been busy with working within the Latino community as well her activities with professional organizations. These are true strengths as are her publications and presentations regarding health status among Latinos. Dr. Lapeyrouse has continually been making a significant contribution to her field and discipline as seen in her time spent with various professional organizations and being a reviewer for many journals."
