<u>Summary of Evaluation</u>:

<u>Teaching</u> – Professor Muehlberger's teaching is highly successful and student evaluations of her courses, from introductory as well as advanced courses, are exemplary. She has taken on the 200-level introductory lecture course in Middle East Studies (MES) and not only rebuilt the curriculum and enrollments, but she has also displayed her admirable breadth of knowledge by teaching across centuries and subject areas. Since 2015, she has served on eleven doctoral committees, two of which she chaired and two of which were external to UM. As the director of graduate studies in MES, Professor Muehlberger improved the mentoring and feedback systems for graduate students and implemented a program to speed new Ph.D. candidates toward completion of their first chapters. She initiated an investigation into ways to prepare graduate students for non-academic careers by broadening the scope of graduate education, receiving Mellon funding to explore this problem, and developing ways to address it.

<u>Research</u> – Professor Muehlberger belongs to a leading group of contemporary scholars who look toward Coptic and Syriac texts as key documents of late antique Christianity alongside the traditional canons in Greek and Latin. As a result, what once was considered "marginal" now has its place in "mainstream" research, showing the ways that ideas and texts circulated, built upon each other, and diverged across a broad, developing Christian space. Her new book, <u>The Moment of Reckoning</u>, impresses by virtue of its lean and elegant presentation. In the convergence of traditional patristics with the social and intellectual, it offers a timely argument about beliefs, morality, and the religious justification of violence, which is certain to initiate a sustained debate across the humanities.

<u>Service</u> – Professor Muehlberger has a strong track record of service within the university and within the scholarly community, domestically and internationally. She has gone above and beyond the requirements of her home units and has sought out ways to work toward equity in a variety of academic contexts. In MES, she has served as the director of graduate studies for two years. In History, she has served on the Diversity, Equity, and Inclusion Committee. She is also an elected member of the Executive Committees in both departments. She currently serves on the editorial boards of *Studies in Late Antiquity* and *Bryn Mawr Classical Review*, and she recently served on the editorial board for *Marginalia*. She is also serving as one of four editors of the massive, six volume <u>Cambridge Editions of Early Christian Writings</u>.
