Summary of Evaluation:

<u>Teaching</u>: Over the past five years, Professor Patel has taught the core theory course required for Health Behavior and Health Education master's in public health students, Psychosocial Factors in Health–Related Behavior (HBHE 600), a practice-based course, Materials and Method in

Health Education Programs (HBHE 641) and a new course to the department, Confronting and Addressing Racial/Ethnic Disparities in Healthcare (HBHE 710). Professor Patel's teaching philosophy is grounded in a belief that personalized learning, using programmatic skills and participatory approaches, can develop effective and committed future public health leaders. She has allowed herself to grow as an instructor, as demonstrated by improved student ratings and feedback. After Professor Patel's first year of teaching HBHE 600, she redesigned the course using the flipped-classroom approach to ensure that the material is relevant and applicable to all students.

In Materials and Method in Health Education Programs (HBHE 641), Professor Patel uses group-based learning experiences, enhanced by pairing students with local community-based agencies. In response to growing student interest in curricula focused on racial/ethnic health disparities, Professor Patel piloted a new course, 'Confronting and Addressing Racial/Ethnic disparities in Healthcare' in winter term 2018.

In 2016, Professor Patel was nominated and then elected to be among the inaugural cohort of the University of Michigan Interprofessional Education (IPE) Leadership Fellows program - an 18-month program to enhance skills as an interprofessional educator and leader. Through this program, Professor Patel has increased her skills with how innovative models of health professional training can lead to improved care outcomes. Outside of the classroom, Professor Patel is passionate about training the next generation of practitioners and researchers. Since 2012, Professor Patel has mentored 25 student research assistants, three Ph.D. students and has served on two dissertation committees. She has also mentored nine independent study students, four M.P.H. practicum students and two research trainees. Enough cannot be said about Professor Patel's efforts and successes in teaching. She is a most highly valued mentor to students and colleagues in the department.

Research: Broadly, Professor Patel's research focuses on optimizing the management and prevention of common chronic diseases through a) identification of factors that influence poor behavioral and health outcomes at multiple levels of influence, and b) the development and evaluation of behavioral interventions in disparity populations to improve outcomes. A particular emphasis of her work is access to care, health care navigation, and health-related financial toxicity. Professor Patel's research has already achieved significant recognition. Evidence of her research productivity and scientific value of her work is reflected in her successes in securing external competitive funding via established peer review federal and professional agencies. Since her appointment as assistant professor in 2013, Professor Patel has successfully acquired funding, serving as the PI or co-PI on five grants totaling over \$4 million. She received the Early Career Achievement award from the Behavioral Sciences and Health Services Research Assembly of the American Thoracic Society, Emerging Scholar award from the University of Michigan Institute for Healthcare Policy and Innovation (IHPI) and was appointed as the John G. Searle Assistant Professor of Health Behavior and Health Education.

Professor Patel's research productivity and quality is exemplary. She has 31 peer-reviewed publications since beginning her tenure track appointment in 2013, with an additional seven papers currently under review. She is first or second author on 24 of the 39 papers since 2008. Notably, most of the papers involving co-authors include students and colleagues, demonstrating

Professor Patel's leadership and collegiality on research teams. Many of her papers are published in prestigious journals (e.g., Health Education and Behavior, Journal of General Internal Medicine, Journal of Asthma, Journal of Racial and Ethnic Health Disparities, Journal of American Medical Informatics Association).

Service: Professor Patel is actively engaged in service opportunities that contribute to her research areas. Within the department, she has served on the Masters in Public Health Admissions, Doctoral Curriculum, 2017 Faculty Search Committee, Health Behavior and Health Education Publicity and Awards committee and most recently, as the chair of the Masters in Public Health Curriculum Committee. Within the School of Public Health and the university atlarge, she has served as the School of Public Health's representative on the curriculum workgroup for the Interprofessional Education initiative launched by the Michigan Center for Interprofessional Education. In the community, Professor Patel serves on the advisory council for the Diabetes Wellness and Prevention program for the Senior Alliance: Area Agency on Aging 1-C in Wayne County, Michigan and has been asked to serve on the Board of Directors of A Brighter Way. On a national level, Professor Patel provides editorial service to over a dozen journals in her field and has also served as an associate editor for BMC Health Services Research. She also regularly reviews abstracts for the American Public Health Association annual meeting and has been an active member of the Behavioral Sciences and Health Services Research Assembly through the American Thoracic Society. Professor Patel is a highly soughtafter speaker for professional associations as well as community organizations. These activities all demonstrate Professor Patel's significant and important service contributions.
