Summary of Evaluation

<u>Teaching</u>: Professor Richards-Schuster is a top teacher and curriculum leader at Michigan Social Work. Over her career, she has taught MSW and undergraduate courses in community practice and social justice. Since 2013, she has focused her teaching and curriculum leadership on undergraduate education, in the undergraduate minor that she designed, Community Action and Social Change (CASC).

She has earned superlative teaching evaluations from her students, who come from more than 50 different undergraduate majors on campus. Her courses and herself as an instructor are rated as overall "Excellent." Not surprisingly, students report that they learn a great deal from her courses (4.42-5.0 on the 5-point scale for her solo-taught courses). Professor Richards-Schuster is an innovative instructor. She participated in the creation of the social work micromasters and is a strong mentor for undergraduate and graduate students. She has participated in eight dissertation committees.

Professor Richards-Schuster's unique and outstanding teaching contribution has been her leadership role, vision, and creativity in the conceptualization and implementation of the CASC minor. In conceiving the minor, Professor Richards-Schuster wove her scholarship into the program. She used her research findings on youth civic participation and empowerment to build an outstanding minor. In the CASC minor, students from over 50 majors across campus engage in learning experiences that enhance their civic participation now and in the future. They identify their core civic values.

<u>Research</u>: Professor Richards-Schuster's research area is community organization, a specialty within social work that focuses on empowerment of people in communities as a force for social change.

Within community organization, her area of scholarly focus is youth civic engagement, a topic that focuses on youth participation in community change. Professor Richards-Schuster's scholarship is rooted on concepts of social justice, and is focused on marginalized youth from oppressed populations including low income youth and youth who are under-served and under-represented in American secondary and higher education. Since receiving her PhD, Professor Richards-Schuster has published 29 peer reviewed journal articles (17 since she became an assistant professor on 2013), 13 book chapters (5 since 2013), and she has served as a co-editor for special issues for *The Journal of Community Practice*, and the *Michigan Journal of Community Service Learning*.

Professor Richards-Schuster's research is based on community-based-participatory research methods. Thus, the voice of youth and their participation is part of the research process. This method embodies the values that Professor Richards-Schuster articulates in her personal statement and implements in her research studies -- partnership in the research process, the importance of collaboration, and a "subject" voice in the research agenda. This has led to a body of research that is highly original and has been very influential in the fields of community organizing and youth development. In 2003, Professor Richards-Schuster wrote one of the first articles in this then-new line of inquiry, "Youth Participation in Community Research and Participation."

<u>Service</u>: Professor Richards-Schuster is a strong citizen and contributor to her communities. She serves on several leadership committees at the school and she chairs a CASC advisory committee. She is a citizen of the university and serves on the Council for Engaged Civic Education to connect the university and Detroit, the UM Office of Development's Dobson Summer Internship Program, and the president's Citizen Alum Task Force to promote civically engaged alumni. Professor Richards-Schuster is on the faculty advisory boards for the Ginsberg Center for Community Service and Learning, and the University Musical Society.

Because her scholarship, teaching and service are so deeply integrated, Professor Richards-Schuster has already served the profession in significant leadership roles. She consulted for the National

Youth Volunteer Corps and the Regional Youth Leadership Series. She chairs the Youth Focused Evaluation Topical Interest Group within the American Evaluation Association. She leads youth civic engagement, empowerment, and youth voice special interest groups for the Society for Social Work Research. She has built a network of scholars aimed at strengthening youth participation in social work practice and research. She is also on editorial boards and is a journal and book reviewer.
