# Summary of Evaluation

<u>Teaching:</u> Professor Shaefer offers courses in the School of Social Work as well as in the Ford School. Since 2015, he has taught two courses in social work and one in public policy, Intersection of Social Work and Economics: Values and Perspectives (SW849), Social Work and Economics (SW875), and a PubPol 746, Welfare Policy, a course in the Master of Public Policy Program. The courses examine social welfare policy, understanding the economics underlying social policies, the evolution of welfare policy from 1965 to today, and American welfare policy compared to those of other nations. PhD, and MSW, and MPP students take the courses. Professor Shaefer's courses typically attract students from multiple programs. He receives distinctively strong teaching evaluations from students, in the 4.7-4.8 range (on a 5-point scale). Students are enthusiastic about the content and the caliber of the courses.

Professor Shaefer is also an excellent mentor. Over his career at the UM, he has engaged 21 students in coauthoring papers. He has served on nine dissertation committees in social work, economics, and sociology. Poverty Solutions also provides engaged learning opportunities for students from across the university, including undergraduates, in research and in social action.

Research: Professor Shaefer's research focuses on extreme poverty and social welfare policy, from Clinton's 1996 "welfare reform" to today's policies that are based on tax incentives for labor force participation and vouchers for housing, food, health, and child care. In \$2 a Day, and in his 45 scholarly articles (18 published since his last promotion), Professor Shaefer has established himself as a major scholar of contemporary American social welfare policy. Professor Shaefer's work lays bear the consequences of the 1996 welfare reform that effectively ended cash transfers for individual and for families with children, and that plunged families with few means into the challenges of unstable and atypical work situations with limited resources to care for children.

Professor Shaefer's book with Kathryn Edin, \$2 A Day, has won major awards including being named one of the 100 notable books of 2015 by the *New York Times*. His research adds important knowledge on to the contemporary study of poverty. For example, the lifelong negative effects of "Adverse Childhood Experiences," (childhood trauma) is an influential line of inquiry that links child development and

lifelong health outcomes. Professor Shaefer and his collaborators' influential 2018 article shows that family financial resources can significantly decrease the negative health effects of traumatic experiences, thus making a case for stronger income supports for the nation's poorest children. He also makes a case for better policies as he and colleagues propose the desirability and feasibility of a universal child allowance for American children.

As the leader of the university-level Poverty Solutions initiative, Professor Shaefer is redefining the way that University of Michigan faculty can and will engage with policymakers and communities to bring together science and the creation of better solutions to reduce poverty in Detroit and in Washtenaw County. Poverty Solutions' strategies combine rigorous research and action-based initiatives. Poverty Solutions created a Youth Employment Program in Washtenaw County, which had not previously sponsored such a program. Poverty Solutions is partnering with Detroit Mayor Duggan to provide more opportunities for employment in Detroit. These relationships are all characterized by respectful and mutually beneficial engagement, sensitivity to local needs and a commitment to the long term.

<u>Service</u>: Professor Shaefer's service is extensive and exemplary. He has served on the SSW and Ford School's executive committees, as well as on a university-wide committee envisioning what eventually became Poverty Solutions. His leadership of Poverty Solutions has resulted in important impact at the university, by engaging the university in providing formative work experiences for low-income youth, the region and the state of Michigan. Poverty Solutions serves as a model of community-engaged scholarship for the nation.

Outside of the university, he maintains a highly visible professional presence and is regularly sought for important national service posts such as National Academy of Sciences, National Research Council Panel on the Review and Evaluation of the 2014 Survey of Income and Program Participation (SIPP) Content and Design. He recently accepted an offer to serve on the U.S. Department of Health and Human Services ACS/OPRE Technical Working Group. He serves as a journal reviewer for important journals such as the *American Journal of Public Health, Demography*, the *Journal of Policy Analysis and Management, Social Service Review, Social Science Research, Social Policy and Society*, and the *Journal of Poverty*.
