ACTION REQUEST

Subject: Subcontract Agreement between the University of Michigan and
Therapeutic Systems Research Laboratories, Inc.

Action Requested: Authorization to enter into Agreement

Preamble:

A statutory conflict of interest situation was identified by the Office of Research and Sponsored Projects while reviewing the Proposal Approval Form which then triggered a review by the UMOR Conflict of Interest Review Committee. A plan for management of the possible risks associated with the conflict of interest was then developed and approved by the Committee and agreed to by the parties involved.

This proposed agreement (“Agreement”) falls under the State of Michigan Conflict of Interest Statute because Professor Gordon Amidon is an employee of the University of Michigan (“University”) and a partial owner of Therapeutic Systems Research Laboratories, Inc. (“TSRL”), and because Professor Gregory Amidon is an employee of the University and a paid member of the Board of Directors of TSRL. The law permits such an Agreement provided it is disclosed to the Board of Regents (“Regents”) of the University of Michigan and approved in advance by a 2/3 vote.

Background:

Dr. Gordon Amidon, a Professor in the Department of Pharmaceutical Sciences, is the partial owner of a for-profit company called TSRL, and Dr. Gregory Amidon, a Research Professor in the Department of Pharmaceutical Sciences, is a paid member of the Board of Directors of TSRL (the “Company”). The Company wishes to fund a National Institutes of Health (prime) Commercialization Readiness Pilot Program project entitled “NPP-669 for Treatment of DNA Virus Infections in Solid Organ Transplant Patients” (ORSP #20-PAF06748) in the Department of Medicinal Chemistry, under the direction of Dr. Andrew White. The purpose of this project is the preclinical development of the antiviral compound NPP-669, including working with a contract lab in order to produce chemical methodologies developed at the University on a larger scale.

Agreement Terms:

The terms of the Agreement conform to University policy. The period of performance for the project is approximately three (3) years. The amount of funding support will not exceed \$31,200. Since research projects are often amended, this agreement includes provisions for changes in time and scope. University procedures for approval of these changes will be followed and additional conflict of interest review will be done as appropriate.

Impact of the Agreement:

The Agreement will support an effort by Dr. White to use his expertise and University laboratories, as well as other University resources, to develop a new, more effective antiviral compound that can be used in the treatment of viral infections in solid organ transplant patients.

Recommendations:

This matter has been reviewed and approved by the UMOR Conflict of Interest Review Committee. In light of this disclosure and our finding that the Agreement was negotiated in conformance with standard University practices, I recommend that the Board of Regents approve the University's entering into this Agreement with Therapeutic Systems Research Laboratories, Inc.
