Subject: Central Student Government (CSG) Report

President Schlissel, members of the Board of Regents, and Executive Officers of the University,

We are pleased and honored to submit the following report to you on behalf of CSG:

Introduction

- Hello, our names are Nithya Arun and Carla Voigt and we are the newly elected CSG President and Vice President.
 - Nithya is a public health senior and uses she/her pronouns. Her previous work on campus has involved serving as the first year undergrad ex officio on the CSG Assembly, the Senior Policy Advisor for Health and Wellness, and most recently as the Senior Policy Advisor for Academic Affairs.
 - Carla is a mechanical engineering senior and uses she/her pronouns. Her previous work on campus has involved serving as an engineering representative on the CSG Assembly for three years and most recently held the position of Speaker of the Assembly.

Current Issues, Programs, and Policies that we are addressing:

- **The Healing Program:** The healing program is an initiative aimed to serve students who are affected by racial violence. It is crucial for students to not only have access to affordable or subsidized mental health care but for them to feel comfortable and safe when being seen by a mental health care professional. People of color benefit greatly from being able to speak to culturally sensitive and educated professionals and this program provides funding and resources to this student population.
- **Press Release - Sheikh Jarrah:** On Monday, May 10th we released a statement regarding the events in Sheikh Jarrah. CSG worked with several student organizations on campus including SAFE, the Arab Student Association and the Muslim Student Association to craft this press release and we continue to stand behind it. The intent of our statement was to stand in solidarity with the Palestinian community in response to the current violence in Sheikh Jarrah. We understand that this is a contentious issue and our goal was never to alienate the Zionist students on our campus, although it was taken as such by the affected. We acknowledge their feelings regarding the issue and are meeting with student groups such as iLead and Hillel.
- **Early Leasing Ordinance (ELO):** We are collaborating with the Graduate Employees' Organization (GEO) to extend the ELO from 70 days to 210 days. Students often times find themselves in unfavorable living situations because of the short time span between move-in and leasing. We will be releasing a statement announcing our support for this initiative in the coming weeks. and will be releasing a statement soon regarding off campus housing.

- **Menstrual Product Initiative:** This is an advocacy initiative that aims to provide menstrual products in all U-M bathrooms. It is crucial that all students be able to participate and exist in public spaces on campus without feeling the financial burden of purchasing overpriced products from nearby central campus stores like Walgreens or CVS or being forced to miss classes and travel to stores to be able to purchase emergency menstrual products.
- **COVID-19:** We provided shuttles for students to access vaccines in Meijer. CSG will continue to advocate and fund initiatives that promote vaccine uptake amongst the student community. We also plan on developing and disseminating a vaccine literacy program that informs students about what the vaccine is, how a student can access the vaccine, and who needs to receive the vaccine.
- **Dearborn/Flint Campuses :** We are currently in the process of communicating with and organizing events with U-M Dearborn and Flint to advocate for twenty million dollars to be allocated to U-M Dearborn and Flint every year for five years. All University of Michigan students regardless of the campus they attend deserve access to any and all resources and privileges associated with being a Michigan student. Additionally, we support the Lecturers' Employment Organization (LEO) bargaining efforts.

Below is an update on Student Government's transition from the Uptmor-Grolle Administration to the Todd-Shukairy Administration.

I would like to first introduce myself to the Board of Regents. My name is Levi Todd and I am a third-year student studying Political Science. I have been involved in Student Government for the past two years as a Senator and Director of Foreign Outreach. Now, I have the esteemed privilege to serve this great community as its next Student Body President. I would also like to introduce Amena Shukairy, who is a third-year Secondary Mathematics Teacher's Certificate Program major. She has been a part of Student Government for the past year as the Director of Student Relations. Now, she will serve as Vice President of the Student Body.

The Todd-Shukairy Administration has opened applications for the 2021-2022 Executive Cabinet. It is our responsibility to build a cabinet that represents our student demographic.
