Summary of Evaluation:

<u>Teaching</u>: Dr. Chang delivers instruction didactically in the National Clinical Scholars Program where she serves as a co-director and presents lectures as well as provides mentoring to the fellows. She also lectures to family medicine residents in the residency didactic curriculum. Dr. Chang also teaches through continuing medical education courses. She provides direct clinical teaching to residents and medical students in various settings, including at the Ypsilanti Health Center, the Corner Health Center, and the Regional Alliance of High Schools clinics where she teaches medical students and residents. In 2018 and 2002, Dr. Chang received the Token of Appreciation from Medical Students Award, attesting to her high quality medical student teaching. She has mentored 19 undergraduate students, one graduate student, 12 medical students, nine fellows and 18 residents. Her teaching excellence is reflected in teaching evaluations that reflect scores in the very good to excellent range.

Research: Dr. Chang has been enormously productive with her research, which centers around adolescent health. She conceptualized, developed and implemented MyVoice, which focuses on social media and texting, which are common ways of communication in this population. MyVoice is a text based data gathering program which obtains both objective and narrative data from adolescents around the country. MyVoice has generating significant national attention, including data and collaboration requests from numerous investigators and organizations. Dr. Chang has a particular interest in adolescent pregnancy and obesity, and was recently awarded an NIH R01 to study the potential for grocery delivery to promote healthy weight gain among low-income pregnant young women. Her research has yielded 60 peer-reviewed articles. She has disseminated her work widely and effectively through 26 extramural invited presentations regionally, nationally and internationally. Dr. Chang is well funded for her research as the principal investigator of six

current grants from the National Academy of Sciences, the NIH, Meijer and the University of Michigan.

Dr. Chang has received numerous awards as a result of her outstanding research programs, including the James C. Puffer, M.D. American Board of Family Medicine Fellowship from the National Academy of Medicine in 2017, and the North American Primary Care Research Group Pearl Award in 2018.

Service: Dr. Chang has been very involved in multiple local, regional and national committees and organizations. Institutionally, she has served as a member of eight committees, both for the Department of Family Medicine, as well as for the university over the past seven years. Nationally, she is involved with nine committees, and has served on study sections for the National Institutes of Health, and is an ad hoc reviewer for 20 journals. Dr. Chang is a peer reviewer for both the Society of Teachers of Family Medicine and the Robert Wood Johnson Clinical Scholars Program national meetings. She has also served as a board member for numerous high profile national organizations, including for the North American Primary Care Research Group and the Society of Teachers of Family Medicine as well as the Children, Youth and Families Board for the National Academies of Sciences, Engineering and Medicine (NASEM). Dr. Chang was recently selected as a co-author of a high impact NASEM consensus study focused on promoting positive adolescent health behaviors and outcomes in the 21st century. She is a past board member of the CAFM Education Research Alliance Steering Committee, a consortium of all major family medicine organizations, which focuses on surveying family medicine residency programs on various issues.

Reviewer A: "Dr. Chang has become one of the rising super-stars for research in Family Medicine on a national level and international level...I have been continually impressed by her superior intellectual attainment and creative achievement. Her CV is overflowing with accomplishments, awards, teaching activities, and mentorship...I recommend her fully for promotion at the University of Michigan. In fact, she might already qualify for Professor at our institution."

Her work using social media and texting technology to reach adolescents is ground-breaking and has pushed the envelope of adolescent medicine research. She easily meets your institution's criteria for promotion, and I believe she has already exceeded the criteria for Associate Professor at my own institution."

Reviewer D: "...my review of her packet today provided me a much deeper conviction that she merits the promotion that is under consideration...Dr. Chang is doing innovative and important work using novel online survey methodologies to access health-related views and opinions of youth. She has also developed a consistent line of research related to obesity prevention among pregnant women. She has published extensively along these lines of inquiry and has an impressive number of peer-reviewed publications for an assistant professor."

Reviewer E: "After carefully reviewing Dr. Chang's dossier, the key impression I wish to convey is that it seems to me she is a 'slam dunk' for promotion to Associate Professor with Tenure...Like all the best researchers, Dr. Chang seems to have an innate ability to quickly zero in on the most pressing issues and problems facing clinicians, the health care system, and our nation, speaking to the importance and potential impact of her work...I would wager there are very few if any other Assistant Professors of family medicine a mere seven years out of fellowship training who have fifty-four (54) peer-reviewed journals and publications — an average of 7-8 per year."

Reviewer F: "It is clear that Dr. Chang is a fierce innovator and brings not just a command of methods but a 'can-do' spirit to her work. These types of thinkers and researchers are rare and valuable. Reflecting the quality of her science and its value, her work has been published in high impact factor journals and has been an area of special focus [in] some journal issues. Several external barometers also clearly signal Dr. Chang's recognition as a rising disciplinary star. Dr. Chang's position as Chair of the STFM Research Committee is normally a position for a much more senior researcher. Additional she presented a keynote plenary at the 2019 NAPCRG meeting with significant acclaim for her work, again a role normally occupied by a more senior researcher."

Dr. Chang is an outstanding academic family physician whose rigorous research training and methodologic expertise had led to significant success as an independent investigator in the field of adolescent health, with clear national impact and admiration among her colleagues. She is an expert in the use of social media to address obesity in teenagers, and her recent R01-funded study will build on her strong foundation of accomplishment, and widen her influence as a national leader in family medicine and adolescent health.
