Summary of Evaluation:

<u>Teaching</u>: Professor Deng is a diligent teacher with long-term career impact for her students. She brings exceptional ability to apply abstract theories and analytic technologies to complex real problems in the economics and policy of housing. While often deeply technical, her courses cultivate independent interpretations and adaptations. By encouraging students to direct their skills toward their own concerns, she has been able to deepen their understanding. Professor Deng has also served on a dozen doctoral dissertation committees. Her teaching and mentoring is a strength, she is energetic and versatile in her teaching efforts, and her teaching portfolio represents a core asset to the Urban and Regional Planning Program.

Research: Professor Deng's research revolves around public programs that provide, or that incentivize the private market to provide, affordable and serviceable housing for low-income populations. Having established herself as an expert through her pre-tenure work on the most prominent affordable housing production program in the United States, the Low Income Housing Tax Credit Program, Professor Deng has extended her expertise since earning tenure through deep and nuanced analysis of that program in legacy cities with declining housing markets, represented archetypically by Detroit. She has also extended her international work on housing policy in China, and she is at the cutting edge of scholarly work addressing the provision of

affordable housing in that strong-state system through a public housing program that is transitioning to a more market-oriented approach. Professor Deng's journal publications have been in the top journals for the urban and regional planning discipline, as well as leading interdisciplinary and international journals addressing urban and housing issues.

Service: Professor Deng has a strong service record and is a respected administrator in the college and beyond, known for her ability in demanding roles and her efforts toward inclusion for international students. She recently completed a four-year term as the director of the Graduate Certificate program in Real Estate Development and is currently serving as the associate director in the Lieberthal-Rogel Center for Chinese Studies, one of America's more prestigious academic centers of its kind. Professor Deng has served the Association of Collegiate Schools of Planning as track chair for Housing and Community Development, one of the largest tracks in this main conference in the field. She was also on the board of the International Association for China Planning, for which she received the Excellence in Service Award in 2015. Professor Deng currently oversees North American manuscript submissions for the leading research journal, *Housing Studies*.
