Summary of Evaluation:

Teaching – Professor Jarman has taught six courses since being appointed as assistant professor: HMP 615-Introduction to Public Health Policy, HMP 619-Health and the Policy Process, HMP 622- Qualitative Methods for Health Policy Research, HMP 804 and HMP 805-Doctoral Seminar in Health Services and Systems Research II and III, and HMP 685-The Politics of Health Policy. HMP 615 and 685 require revisions each year due to rapid changes in society in the relevant topic areas. She developed as her own, HMP 619, with a strong emphasis on hands-on advocacy work outside of the classroom complementing in-classroom teaching and HMP 622, to address the need to teach integration of quality of methods into the research training of students. Overall, she has had excellent teaching scores with Q1 scores averaging 4.47 and Q2 scores averaging 4.70. Professor Jarman is highly sought after as an advisor and mentor for students in the department's doctoral program. She has served on 12 dissertation committees including four as co-chair, five as co-

advisor, and three as committee member. Five of her doctoral students have completed their degrees and moved on to successful careers in the field. She is currently a co-chair on three active doctoral committees, and a committee member on two others.

Research – Professor Jarman studies the effects of market regulation on health policy and governance in a variety of national and international contexts. Her approach to research is inherently interdisciplinary drawing on data from in depth focus group interviews, archive research, and documentary analysis. Professor Jarman’s research addresses four themes: i) the politics of trade and tobacco control, ii) the political economy of the European Union and its impact on health, iii) the alignment of commercial values with the public interest, and, iv) health policy implementation. She is considered a leader both nationally and internationally for her innovative and timely work in the intersections of political science, public policy, and public health having received national recognition for her research and scholarship. Her book, The Politics of Trade and Tobacco Control, has been used to educate staff in the Food and Drug Administration’s tobacco control unit about trade policy and was used as background reading by lawyers preparing for litigation between the state of Uruguay and Philip Morris International, a large tobacco firm. Her research, which used a World Health Organization (WHO) model of health systems building blocks to assess the likely impact of Britain’s exit from the European Union across the United Kingdom’s National Health Service, was referenced during United Kingdom parliamentary scrutiny of European Union withdrawal legislation and as background research by public interest attorneys bringing a national lawsuit against the British government. Professor Jarman’s work has also been referenced in evidence reviews conducted by the WHO and in the United States Surgeon General’s 2014 report commemorating 50 years of progress in tobacco control.

Professor Jarman’s work has been funded from several sources including the National Science Foundation, the Robert Wood Johnson Foundation, the Kresge Foundation, and the Institute for Health Policy Innovation. Beginning in July 2020, she is one of the two multiple principal investigators (PI) funded by the United States Army Engineer Research and Development Center to examine the factors contributing to the relative success or failure of European countries’ responses to COVID-19. She also currently is an investigator on a grant from the Nuffield Trust and a research associate on a European Union Erasmus+ Program. Professor Jarman has received national recognition for her research and scholarship receiving the prestigious John D. Thompson Prize for Young Investigators by the Association of University Programs in Health Administration (AUPHA) and the Leonard S. Robbins Award for best paper on health policy and politics during the American Political Science Association Annual Meeting in 2017. Professor Jarman is an author on five peer-reviewed books, which have been published since she was appointed as an assistant professor at the School of Public Health in 2014. Among these, she is the sole author of the book The Politics of Trade and Tobacco Control, published in 2015, and is the first author on the book Private Data and Public Value: Governance, Green Consumption, and Sustainable Supply Chains, published in 2016. As of October 2020, Professor Jarman has published 40 peer reviewed journal articles. Since 2014, she has published 29 peer reviewed articles (11 as first author, and one as second author where a student was first author), and two peer reviewed policy reports (one as first author). Her peer reviewed publication trajectory appears predictive of substantial future productivity. Her published work appears in high impact journals including *Milbank Quarterly*, *The Lancet*, and the *British Medical Journal*. In 2017 and 2019, articles she co-authored addressing the health consequences of the Britain’s exit from the European Union were singled out by Altmetric as the ‘most discussed’ research outputs across all subjects (99th out of 2.2 million research outputs and 41st out of 2.7 million research outputs, respectively). Her work and her commentary have been featured on prominent radio outlets (e.g., CNBC, BBC) and over 100 media outlets. Professor Jarman has

presented her work at various conferences in political science, public policy and public health 23 times since she was appointed assistant professor.

Service – Professor Jarman is actively engaged in service to the department, university, and profession. Within the department, she is currently a member and served as the chair of the Global Health Committee in 2016 and 2017 and was previously a member of the Residential Masters Committee. She is also currently a member of the Griffith Leadership Center Committee. At the university level, she serves as a board member at the University of Michigan Center for European Studies and on the Institute for Healthcare Policy and Innovation Education and Training Working Group. Professor Jarman previously served on the Institute of Healthcare Policy and Innovation Early Faculty Career Advisory Group from 2017-2019. In 2019, she received an Institute for Healthcare Policy and Innovation service recognition award and in 2020, she was selected as one of nine Public Engagement Faculty Fellows by the University of Michigan Office of Academic Innovation in a university-wide competition. Professor Jarman is a member of the board of directors and the executive board of the Michigan Public Health Institute where she previously served as the secretary. In terms of national service, Professor Jarman is a co-chair of the Public Policy Section of the European Union Studies Association and board member and conference program organizer of the American Political Science Association British Politics Group. She is also a grant reviewer for the National Science Foundation and the University of California, San Francisco Tobacco-Related Disease Research Program and reviews manuscripts for more than a dozen peer-reviewed journals.
