Zhaochu Li, assistant professor of accounting, School of Management, is recommended for promotion to associate professor of accounting, with tenure, School of Management.

Summary of Evaluation:

<u>Teaching:</u> Professor Li is a very effective teacher of various undergraduate and graduate accounting and tax courses with excellent evaluations by his students. In fact, he consistently ranks among the top 10% of the faculty at the school in course evaluation ratings. He uses lecture videos in his classes to improve student learning and incorporates small practice problems throughout his classes. In course evaluation comments, students report that they enjoy his video-taped lectures and his demonstrations of solutions to problems in his classes. His courses are based on case studies, as appropriate. He complements his lectures with debates on relevant developments in business such as tax policy.

Research: Professor Li has 13 publications, several of them in recognized peer reviewed journals. In addition, he has one paper with revise and resubmit status, and seven working papers. He is oftentimes the first author in these publications, demonstrating his ability to take the leadership position in manuscript development. This strong pipeline of research in progress foretells a continuing productive research agenda. His published research focuses on how research and development expenses are used to manage company earnings, and how governmental policies impact innovation. He has additional publications researching tax planning and strategies for individual taxpayers in accounting practitioner journals, and on enhancing student learning in online courses in accounting pedagogy journals.

<u>Service</u>: Professor Li has provided active service to the School of Management, the university, to his academic profession, and to the community. He is a regular participant at the school and department events and meetings. His openness to take on additional service commitments is evident from his committee assignments. He served on the school's Graduate Committee, several search committees for accounting lecturers and the university's Academic Affairs Advisory Committee, and represented the School at the university's Honors Program. In the meetings of these committees, he speaks up, and actively engages with other members.

Professor Li is known by his students to be resourceful, approachable, and willing to help them where needed. Professor Li has 13 publications in recognized peer-reviewed journals in accounting and taxation

with several in practitioner and pedagogy journals in his field, which illustrate his contribution to the practice of taxation and innovation in teaching of accounting subjects. Professor Li also provided fine service to the School of Management, the university, beyond a level that one would expect from an assistant professor in committees such as the Academic Affairs Advisory Committee. It is with the support of the Executive Committee of the School of Management that I recommend Zhaochu Li for promotion to associate professor of accounting, with tenure, School of Management.
