Summary of Evaluation:

<u>Teaching</u>: Professor Martin's teaching is rated excellent. She is an exceptionally knowledgeable and effective teacher who offers a range of interdisciplinary courses on gender and health to serve student needs in majors across two colleges and, through her general education courses, the entire campus. Her commitment to evolving and growing as an educator has resulted in contributions to course and curricular redesign that are highly valued. In student evaluations, students rate her as a highly engaging professor who creates a respectful and open classroom environment, holds them to high academic standards, and enhances their critical thinking skills. Peer classroom observations note her obvious commitment to student learning and success, as well as her great facility at transdisciplinary teaching.

<u>Research</u>: Professor Martin's research is rated excellent. She has published seven articles in peer-reviewed journals, and one book chapter, since receiving tenure in 2016. She has also been involved in over twenty academic presentations and has had ten grants funded. Her groundbreaking research on the complexities of providing care in a stigmatized field has had a significant impact on both academic and health provider communities.
