Summary of Evaluation:

Teaching: Professor Miller has an outstanding teaching record, across a number of different programs at Ross. She has taught in the BBA Core (in her first year at Ross), in the MBA core (two sections each for two years), a successful and a popular MBA elective class on health care markets and public policy, and several times in the PhD program. She has recently worked (with Professor Tom Buchmuller) on developing an Online MBA version of her elective class. She has also served as a faculty advisor for the action-based Living Business Leadership Experience course. She has excelled across programs, with high evaluation scores in BBA, MBA and PhD classes. Her Q10 average over three courses (post-2018) is 4.91, and her earlier Q8 average across ten courses was 4.72. The level of her teaching excellence merited her inclusion as one of the best 40 business school professors under 40, and being profiled as the professor of the week by *Poets and Quants* magazine.

Research: Professor Miller's primary area of research investigates the impacts of health policy on patients and providers, with a focus on health policies that expand health insurance coverage to lowincome or vulnerable populations. Her secondary area of research explores the drivers of financial choices of low-income households. Her overall research productivity both in terms of the number of research papers, as well as the quality of her work reflected in the number of 'A' journal publications and in the number of cites, is outstanding. Grants where she is the PI or co-PI total over \$1.89 million dollars. In addition, she is the PI on a \$3M grant submission to NIH that has received favorable initial review. This success in raising extramural research funds not only increases the prestige and visibility of the Business Economics and Public Policy group and the Ross School of Business, it also attests to the high quality, broad impact and ambitious nature of Professor Miller's work. She has won recognition in the field: she is a faculty research fellow of the National Bureau of Economic Research and is an associate editor at the top area journal in health economics (Journal of Health Economics), as well as at the American Journal of Health Economics. Professor Miller has a very impressive portfolio of research work that has made novel, timely, policy-relevant and impactful contributions. She has an equally promising pipeline of ambitious projects that portend continued excellence on the research front.

Service: Professor Miller always stands ready to help to meet teaching and administrative roles in the BE group. This is evidenced by her work as the PhD advisor for the BE group, which she agreed to take on in 2020-21 after another faculty member's departure. Professor Miller has served as a committee member for twelve PhD students, including as a chair or co-chair for three students. She has also been very active on panels, mock interviews, and mentorship activities for PhD students at Ross. Particularly noteworthy is her service as a mentor for students in the pre-doctoral "Bridge" program, which aims to help students from under-represented groups transition to PhD programs. At the university, Professor Miller serves on the faculty advisory council for the Institute of Healthcare Policy and Innovation (IHPI), and served earlier on IHPI's data advisory board. She has served as a faculty advisor for H2D2 which is the student-led lunch seminar for Ph.D. students in history, health, development and demography.

Professor Miller has been active in the broader academic community as well. She was recently invited to be the co-editor of the leading public finance area journal the *Journal of Public Economics*. She serves as an associate editor at two health economics journals: the *Journal of Health Economics* and the *American Journal of Health Economics*. She has been a prolific reviewer for a number of other journals; she has received recognition for the large number of high quality referee reports from the *Quarterly Journal of Economics* and the *AEJ: Policy*. She helped organize the 2019 Midwest health economics conference and is on the organizing committee for the 2021 annual meeting of the National Tax Association. She has served as a mentor at a graduate student event at the American Society of Health Economists.
