Summary of Evaluation:

Teaching: Dr. Regenbogen has made numerous significant contributions to education as a lecturer, clinical educator, and research mentor. He teaches medical students, residents, and fellows in the hospital and operating room, gives didactic lectures on topics such as gastrointestinal bleeding and inflammatory bowel disease, and has been a core faculty member of the Center for Healthcare Outcomes and Policy. Through his teaching efforts, he devotes a significant amount of his attention to developing and mentoring the next generation of academic physicians and surgeons. Institutionally, he is focused on the development of students and residents through didactics and practical learning sessions on the diagnosis and management of surgical diseases, and treatment of patients in the social context of their environment. Dr. Regenbogen has served continuously as a faculty facilitator for the junior medical student clerkship and course director for the senior sub internship in colorectal surgery service since joining the University of Michigan faculty. He receives consistently outstanding ratings and his teaching contributions have been recognized with both the Silver Scalpel Teaching Award and election in two separate cycles as Faculty Honorary of the Galens Medical Society.

Research: Dr. Regenbogen is a highly productive and internationally recognized translational clinician-scientist. His research program has produced unique and innovating insights into institutional strategies to improve the quality and costs of care around surgical hospitalization. His research has produced 114 publications in peer-reviewed journals such as *Health Affairs*, *Journal of the American Medical Association*, *JAMA Surgery*, *Annals of Surgery*, *Diseases of the Colon and Rectum*, and numerous book chapters. He has an established track record of extramural funding, including an NIH K08 and R03 and several foundation grants. Rather than transitioning directly to R01 funding, he became the co-director of the Michigan Value Collaborative, a \$1.4 Million annual contract to operate a statewide collaborative focused on improving hospital

efficiency. He is now the principal investigator of a large, multi-year grant from the Donaghue Foundation Greater Value Portfolio.

Service: Dr. Regenbogen has an extremely strong record of institutional and national society service. He has served on numerous hospital and medical school committees in clinical operations, quality and safety, and health system strategy. He has been the chief of the Division of Colorectal Surgery since 2014, and is now the associate chief clinical officer for Surgical Specialties in the University of Michigan Medical Group, leading ambulatory care operations for a surgical service line that encompasses four surgical departments. Nationally, Dr. Regenbogen has served on numerous committees in the American Society of Colon and Rectal Surgeons, including as the chair of the Quality Assessment and Safety Committee and the co-chair of the 2020 annual meeting. He serves as an ad hoc reviewed for more than 20 journals, is the associate editor for *Diseases of the Colon and Rectum*, and on the editorial boards of three other major surgical journals, including *Annals of Surgery* and *Surgery*. He also serves on the grant review study sections for the American Society of Colon and Rectal Surgeons Research Foundation and the Surgical Research Network of the Crohn's and Colitis Foundation.
