Summary of Evaluation:

<u>Teaching</u>: Dr. Sripada serves as the associate training director of the Veterans Affairs Serious Mental Illness Treatment Resource Evaluation Center (SMITREC) Advanced Post-doctoral Fellowship Program. This program is an APA-accredited post-doctoral program affiliated with the national Veterans Affairs Advanced Fellowship program and the Michigan Medicine Ann Arbor Veterans Affairs Psychology Post-doctoral TrainingProgram Consortium. She co-facilitates a twice-monthly Professional Research Development seminar which discusses specific topics relevant to the development of professional research and conveys fellow research presentations and faculty feedback.

Dr. Sripada is a member of the Ann Arbor Veterans Affairs Psychology Training Committee where she provides individual teaching and clinical supervision to pre- and post-doctoral psychology interns and fellows. She provides group training and supervision to pre-doctoral interns learning evidence-based treatment for PTSD. Dr. Sripada supervises trainees and reviews video recording interactions between patients and trainees providing detailed feedback. As one of the few faculty members in the department with special expertise in PTSD, including effective treatments, Dr. Sripada is frequently sought out as a primary research mentor. She mentors postdoctoral fellows from the Veterans Affairs Advanced Fellowship program and Veterans Affairs Center for Clinical Management Health Services Research and Development post-doctoral program. Her mentoring role has led to six peer-reviewed manuscripts as senior author on three and second author on two.

<u>Research</u>: Dr. Sripada has developed an independent research program investigating prevalence and obstacles to the receipt of high-quality, evidence-based treatment for posttraumatic stress disorder(PTSD) as well as disparities in access to treatment. Her early research revealed a critical need to improve the availability of evidence-based treatment and adapt evidence-based interventions to better fit the context in which they are delivered. She received a Veterans Affairs Career Development Award to identify best practices and test novel delivery strategies for evidence-based treatment in Veterans Affairs PTSD residential programs. Dr. Sripada recently completed a quality improvement project funded by the Michigan Department of Health and Human Services, and the Frances and Kenneth Eisenberg Innovation Award. This project was developed to test thefeasibility of delivering another evidence-based trauma-focused treatment, Prolonged Exposure for Primary Care, by telehealth to patients in Federally Qualified Health Centers. Her study foundthat Prolonged Exposure for Primary Care was feasible and acceptable and led to large decreases in PTSD and depression symptoms that were sustained at two and four month follow-up appointments. She received a second grant, the Frances and Kenneth Eisenberg Innovation Award, to initiate a PTSD treatment training program for Employee Assistance Program counselors who treat healthcare workers on the frontlines of the COVID-19 pandemic across four healthcare systems. Dr. Sripada recently received notification of an R01 from NIMH to conduct a sequential, multipleassignment, randomized trial (SMART) to develop a stepped-care intervention for PTSD in Michigan Federally Qualified Health Centers. She also received a newly funded four-year multisite Veterans Affairs Merit Award to adapt Cognitive Processing Therapy into a brief format using the Multiphase Optimization Strategy. Dr. Sripada's current projects will help move the field in the promising new direction to make effective treatment more widely available to individuals with PTSD. She is an implementation scientist and a fellow of the Implementation Research Institute.

Dr. Sripada as a national leader in the field of PTSD health services research and one who is already having an impact on the provision of evidence-based PTSD treatment. She has published 56 peer-reviewed articles in many high-impact journals, including *JAMA Network Open*, *Biological Psychiatry*, and the *Journal Consulting and Clinical Psychology*. She has been invited to present her research as part of the Veterans AffairsNational Center for PTSD Consultation Program Lecture Series, and has completed two visiting professorships and several extramural invited presentations.

Service: A large focus of Dr. Sripada's work is determining prevalence and obstacles to the receipt of high- quality, evidence-based PTSD treatment. She is a clinical psychologist with over 10 years of clinical experience delivering evidence-based treatment to individuals with PTSD and other anxiety disorders. She spends one day a week providing evidence-based psychotherapy to Veterans in the Mental Health Clinic at the Ann Arbor VA. Dr. Sripada evaluates the delivery of trauma-focused treatment and identifies ways to improve treatment access. She serves on local, regional, and national committees. She is an active member of the International Society for Traumatic Stress Studies where she shares her expertise on PTSD interventions and health services research. Dr. Sripada is an ad-hoc reviewer for 36 peer-reviewed journals and is an ad hoc member of SERV (Mental Health Services Research Committee) Scientific Review Group within the National Institute of Mental Health. She also served on the Scientific Review Panel of the Veterans Affairs and Department of Defense Consortium to Alleviate PTSD and the Communications Committee of the National Veterans Affairs Measurement Based Care Initiative. In October 2020, she began providing training and consulting in evidence-based PTSD treatment to counselors from Michigan hospital Employee Assistance Programs care for frontline healthcare workers with COVID-19 - related PTSD symptoms. This consultation opportunity is now being expanded to national providers.

<u>Reviewer D:</u> "Dr. Sripada's work is very impactful in understanding implementation and effects of evidence[-]based PTSD treatment, particularly in the Veterans Affairs (VA) healthcare system. Her work is helping to inform for whom and under what circumstances these treatments are most effective and to understand what strategies are most effective in making these treatments widely available in VA. She has been extremely productive in her time as an Assistant Professor, with

over 50 publications in total, many as first author. Her papers get published in high impact and high visibility journals and some of her papers have been selected to be highlighted in various VA publications and media outlets. I am particularly impressed with her series of papers using VA wide data, including from electronic medical records, which has been extremely informative in regard to who gets and who benefits from evidence-based PTSD treatment within VA. This is very novel work answering important questions on a large scale."

<u>Reviewer E:</u> "Dr. Sripada has developed a national reputation for the quality of her work and her acumen in parsing complex problems in health care. The number and impact of her papers, and the quality of the journals where she has published are commensurate with other mental health services researchers promoted to Associate Professor...I believe she would meet promotion criteria at my own institution."
