Summary of Evaluations:

Teaching: In all aspects of Dr. Waljee's professional life, she is committed to education and mentorship. As a clinical surgeon, she spends substantial time each week in the operating room and outpatient clinics with learners of all levels where she provides education on the clinical aspects of surgical management and the technical aspects of executing surgical procedures. She provides multiple didactic lectures throughout the year for our trainees on key topics in Hand Surgery and serves on the Hand Surgery Program Evaluation Committee to design the curriculum of Plastic Surgery Hand Fellowship. She is a career mentor to multiple residents per year through institutional and national programs and has published and spoken extensively on best practices in mentorship and career development. As the director of the Center for Healthcare Outcomes and Policy, she has the opportunity to teach students, residents, fellows, and early career faculty the principles of health services research through project-based learning as a mentor and in weekly didactic seminars.

Research: Dr. Waljee's research interests include the application of patient-reported outcomes toward surgical quality and the development of strategies to promote optimal opioid prescribing and stewardship during perioperative care. These areas are of high importance, given the escalation of opioid-related morbidity and mortality in the United States in recent decades, and the contribution of excessive and risky opioid prescribing during surgical care toward the opioid epidemic. A patient-centered approach is critical to creating effective strategies to appropriately prescribe opioids to manage post-operative pain. Dr. Waljee's work applying patient-reported outcomes to develop provider-level strategies to optimize opioid stewardship has generated positive change in

perioperative opioid prescribing in the United States. She has published a total of 276 peer-reviewed manuscripts and 36 book chapters. Dr. Waljee has flourished in her grant funding having acquired numerous grants in the past five years with 13 grants still current from funding sources such as the National Institutes of Health (NIH), and the Michigan Department of Health and Human Services (MDHHS).

Service: Dr. Waljee has an extensive service record in multiple capacities institutionally and on a national level. Institutionally, Dr. Waljee serves as the vice chair for Health Services Research and as the director of the Center for Healthcare Outcomes and Policy, where she has led a large consortium of faculty researchers and fellows focused on advancing health services research in procedural care. She is the co-director and co-founder of the Michigan Opioid Prescribing Engagement Network. She also serves on the Institute Leadership Team for the Institute for Healthcare Policy and Innovation. Nationally, she served as a member of the Opioid Workgroup of the Board of Scientific Counselors of the National Center for Injury Prevention and Control in 2021. She has served on numerous committees for the American Association of Hand Surgery, and the American Society for Surgery of the Hand, including as governor for the American College of Surgeons representing the American Society for Surgery of the Hand. She is a member of a National Academies of Science, Engineering, and Medicine committee tasked with creating a framework for opioid prescribing guidelines for acute pain in 2019, and a member of the Opioid Prescribing Estimates Workgroup for the Centers for Disease Control and Prevention in 2018. She has been on numerous external grant review panels through the NIH, Patient-centered Outcomes Research Institute (PCORI), and Agency For Healthcare Research And Quality (AHRQ) as an expert in opioid prescribing. In addition, Dr. Waljee served as the deputy methodology editor for the *Journal of Hand Surgery*, is on the editorial board for *Annals of Surgery*, and is an associate editor for two additional journals. She has been a reviewer for 19 journals, including the *New England Journal of Medicine*, *JAMA*, and *Anesthesiology*.


