Summary of Evaluation:

<u>Teaching</u>: Professor Yorke is an exceptional teacher who effectively engages students both inside and outside the classroom. Since her promotion to associate professor, Professor Yorke has taught five distinct lecture/lab courses and served on six PhD dissertation committees, co-chairing three of them. In addition, she has advised one case report research group annually, advised one service-learning group annually, and served as an academic advisor to approximately 12-14 students per year. Professor Yorke's teaching evaluations are consistently above 4.0 on a 5.0 scale for all courses. She consistently receives Golden Apple awards from students each year in recognition of her teaching excellence.

Professor Yorke's teaching philosophy is that students learn through the act of doing. She therefore has incorporated highly effective active learning experiences into her courses. Not only do students practice physical therapy skills on each other in her lab courses, but she works with the local community to bring people with neurological conditions into the lab sessions for the students to work with. When students are learning about various neurologic conditions, they get to apply their knowledge immediately in the assessment and care of community members who have those conditions, providing an exceptional learning experience for the students and a

service to these community members. Professor Yorke is a highly effective team leader in interprofessional education engaging students from other professions both within the university and from other institutions. She is an Interprofessional Leadership Fellow through the University of Michigan and a Fellow in the National Academies of Practice. She has mentored many junior faculty members in teaching both within her department and the college. Professor Yorke clearly satisfies our criteria for promotion with respect to her teaching.

<u>Research</u>: Professor Yorke is a nationally known scholar in the fields of neurological rehabilitation and neurological physical therapy education. From her oft cited manuscript on vestibular/ocular motor screening in persons with concussion to standardizing outcome assessments for persons with Parkinson's Disease, Professor Yorke's research focuses on translating research findings into practice.

Professor Yorke is a prolific researcher with 23 peer-reviewed publications since promotion to associate professor. Of the 23 publications, students co-authored 14. She has garnered \$44,053 in external research funds and is seeking additional external funding. Since her promotion, Professor Yorke received a Social Responsibility Ribbon from the Global Health Special Interest Group of the Health Policy and Administration section of the American Physical Therapy Association for her knowledge translation research on implementing clinical practice guidelines in a student run pro bono clinic.

<u>Service</u>: Professor Yorke effectively integrates her research agenda with her service to the American Physical Therapy Association (APTA), Academy of Neurologic Physical Therapy (ANPT) and to the College of Health Sciences pro bono service (Health Equity, Action, Research, Teaching - HEART). She is currently the co-chair of the Knowledge Translation Task Force for Vestibular Rehabilitation for Peripheral Hypofunction Updated Clinical Practice Guideline for ANPT. She has also served on the ANPT Multiple Sclerosis EDGE Task Force creating clinical guidelines. Professor Yorke has provided exceptional service to HEART by expanding the rehabilitation services provided at HEART and elevating the organization, connection to curricular content, and level of care provided by the students to members of our local community. Within the department, Professor Yorke worked on transitioning the program to a holistic admissions process and is actively engaged in the curriculum and assessment committees.

As a practicing vestibular rehabilitation specialist for over 20 years, her work was very well-received and will be viewed as a 'sentinel' paper already cited over 93 times since its publication in 2017."
