## **ACTION REQUEST**

Subject: Regental Action Required Under the State of

Michigan Conflict of Interest Statute

<u>Action Requested:</u> Authorization for the University to enter into an agreement with

EnlivenWork, Inc. (University of Michigan Employee Monica

Worline, Owner and Stockholder).

## Background:

The University of Michigan Department of Health Information Technology and Services (HITS) seeks approval to enter into an agreement with EnlivenWork, Inc. for professional development services.

The proposed agreement falls under the State of Michigan Conflict of Interest Statute as Monica Worline is a University employee as Intermittent Lecturer with Stephen M. Ross School of Business and would be party to the agreement as owner and stockholder of EnlivenWork, Inc.

However, the Statute allows the University to enter into such agreements if the following conditions are met:

- a) The public servant promptly discloses any pecuniary interest in the contract to the official body which has power to approve the purchase, which disclosure shall be a matter of record in its official proceedings.
- b) The purchase is approved by a vote of not less than 2/3 of the full membership of the approving body in open session without the vote of the public servant making the disclosure.
- c) The official body discloses the following summary information in its official minutes:
  - i) The name of each party involved in the contract.
  - ii) The terms of the purchase, including duration, financial consideration between the parties, facilities or services of the public entity included in the purchase, and the nature and degree of assignment of employees of the public entity for fulfillment of the purchase.
  - iii) The nature of any pecuniary interest.

The following information is provided in compliance with the statutory requirements contained in Section (c) above:

- i) The parties to the contract are the Regents of the University of Michigan and its Department of Health Information Technology and Services (HITS) and EnlivenWork, Inc.
- ii) The agreement is for a duration that will expire after the delivery of the training services at a total cost not to exceed \$3,500. EnlivenWork, Inc. will be supplying all the necessary resources and personnel to fulfill this contract. The remaining base contract terms and conditions are typical to those used in Procurement Services standard templates for other similar contracts entered into by the Regents.
- The pecuniary interest arises from the fact that University of Michigan employee, Monica Worline, is owner and stockholder of EnlivenWork, Inc.

Monica Worline has met state law requirements with the disclosure of her pecuniary interest and formal appointment arrangements with the University of Michigan. Requirements, if any, that may be applicable by the supervisor of Monica Worline, under the Medical School's or OVPR's Conflict of Interest Committee's procedures are separately analyzed and managed.

<u>We recommend</u> that the Board of Regents approve the agreement between the University of Michigan and EnlivenWork, Inc. subject to requirements, if any, that the supervisor of Monica Worline or the Medical School's or OVPR's Conflict of Interest Committee may impose.
