Summary of Evaluation:

<u>Teaching</u>: Dr. Admon is an active educator whose teaching activities include mentorship at multiple levels and clinical teaching and training. Learners include faculty members, post-doctoral fellows, medical students, and graduate and undergraduate students. She has also served on dissertation committees as a committee member. She gives ad hoc lectures to medical students and learners. In 2021, she was appointed as the associate director for pathway of excellence in health policy and economics at the Institute for Healthcare Policy and Innovation (IHPI). In this role, she has coordinated new seminars for the curriculum that reflect her expertise in health equity and provides mentorship to medical.

Research: Dr. Admon has conducted impactful research evaluating maternal outcomes and the influence of racial and economic disparities and inequities on the outcomes of maternal healthcare delivery. In fact, she is one of a handful of OBGYNs dedicated to health policy and her work has already had a meaningful impact in the field. Dr. Admon has had consistent and impressive grant funding. She is currently funded as a principal investigator an R01 and K08 through the Agency for Healthcare Research and Quality (AHRQ). Currently, she is the principal investigator of one the National Institutes of Health (NIH) R01 grants, to evaluate postpartum Medicaid eligibility extension through the Agency for Healthcare Research and Quality (AHRQ). Past funding sources include the NIH, the Department of Health and Human Services, society and foundation awards. She has authored 47 peer reviewed

manuscripts in high-impact journals such as *JAMA*, the *American Journal of Public Health*, and *Obstetrics & Gynecology*. Her work has attracted significant local, national, and international attention with more than 40 interviews or citations in the public press. She has been invited 13 occasions to present her work nationally. The AcademyHealth Annual Research Meeting awarded Dr. Admon with the Best Women's Health Abstract and the Best Medicaid, Coverage, and Access Abstract in 2022 and 2023 respectively.

Service: Dr. Admon has an outstanding service record at the institutional and national levels. Nationally, she has been a member of the Women and Gender Health Interest Group Steering Committee. She has served as an ad hoc study section reviewer for the Center for Disease Control (CDC), AHRQ, NIH, and March of Dimes. recognition of her research expertise, Dr. Admon has been invited to serve on several national organizations and federal agencies as a research consultant or advisory board member for an NIH/NICHD-funded project on community co-led maternal sepsis care practices, the American College of Obstetricians and Gynecologists, the CDC's Division of Reproductive Health, and the Medicaid and CHIP Payment and Access Commission, all focused on reducing maternal health disparities. Dr. Admon serves on the editorial board of *Obstetrics & Gynecology* and performs peer review services for several journals including Maternal and Child Health, the American Journal of Obstetrics and Gynecology, and Annals of Internal Medicine. Her peer review service for the journal of Obstetrics & Gynecology was recognized in 2021 through receipt of a Top 10% Reviewer award. Additionally, she was awarded several "Best of ARM" awards from the AcademyHealth Annual Research Meeting for best abstract for her

themes (2021, 2022, and 2023). Regionally, Dr. Admon is a member of the Michigan Health and Hospital Association's Health Equity Task Force. Institutionally, she is the associate director of Health Policy and Economics Pathway of Excellence and serves on the Senate Advisory Committee on University Affairs (SACUA) and as SACUA's liaison to the health system's Medical Affairs Advisory Committee. She also performs service at the department level by examining residents and serving on residency interview committees. Dr. Admon's commitment to DEI is clear through her research program and service roles.

Dr. Admon maintains an active clinical practice as a laborist in the Birth Center where she provides full-scope maternity care including surgery and emergency care. She is a member Division of Women's Health and has worked to mentor her colleagues to become more research and scholarship-oriented.

External Reviewers:

Reviewer A: "In addition to serving as an outstanding editorial board member at the Green Journal, Dr. Admon is a prolific researcher. She has published several manuscripts with our journal, which only accepts ~8% of submitted papers. Her research portfolio intersects with Medicaid policy, health disparities (racial and urban/rural), mental health, and severe maternal morbidity and mortality (SMM). These critical issues must be addressed to improve reproductive health for all people in the United States. Dr. Admon's research tackles these problems pragmatically and with methodologic rigor. Her research takes the difficult, but much-needed leap, from problem definition to solution-driven interventions."

Reviewer B: "Given her expertise, she has been asked to be an advisory board member for the National Institute on Minority Health and Health Disparities, a study section member for NIH and AHRQ, a member of the Editorial Board for Obstetrics and Gynecology, and a reviewer for multiple journals. She also has mentored numerous individuals at all levels of training. Presently, she is the Associate Director for the Health Policy and Economics Pathway of Excellence at the University of Michigan Medical School."

In addition, to the impact and quantity of her publications, she has significant research funding as PI of [an] RO1 on maternal and child health and postpartum Medicaid eligibility extensions and as the recipient of a K08 on the impact of insurance disruptions on maternal and child health outcomes. Dr. Admon has built an impressive career as a junior faculty member at the University of Michigan."
