Summary of Evaluation:

<u>Teaching</u>: Professor Cooper's teaching philosophy is congruent with the commitment to excellence in teaching and scholarship, student-centeredness, and engagement with community partners at the University of Michigan-Flint (UM-Flint). Since promotion to associate professor in 2019, Professor Cooper has taught numerous courses for adult primary care in the Graduate Nursing program. In 2021, Professor Cooper was asked to assume an interim role as the director of graduate nursing affairs, which within a year became her official title. She took on a major undertaking, coordinating an entire redesign of the curriculum for the Graduate programs. Professor Cooper led the redesign by first benchmarking a wide variety of schools on quality, admission, enrollment, and retention. She also reviewed national accreditation standards and the certification requirements.

As an experienced member of the faculty, Professor Cooper mentors junior and new faculty. She describes her philosophy of teaching as "reciprocal learning" where the faculty facilitate learning with self-directed adult learners who are recognized for bringing past experiences to the classroom and "teaching and learning occur in both directions."

Professor Cooper is an expert teacher who uses her extensive knowledge as an educator and practitioner to inform her leadership as the director of graduate nursing affairs and to contribute to teaching and learning for students. Her performance in teaching is consistent with the

standards set by the University of Michigan-Flint School of Nursing. She has clearly demonstrated effectiveness as a leader in nursing education.

<u>Research</u>: Professor Cooper has a comprehensive and diverse body of scholarship. Her primary research line focuses on urinary tract infections (UTIs) among elderly in long-term care settings. She developed the Cooper Tool and the Cooper Urinary Tract Infection Program (CUTIP), which have been adopted by numerous nursing homes with documented improvement in desired outcomes. Professor Cooper's secondary research line revolves around improving student educational outcomes, with a focus on interprofessional communication, cultural competence, and simulation methods.

Professor Cooper has a number of publications, disseminating her research and other scholarship in peer reviewed journals for nursing, medicine, physical therapy, education, infection control, primary and community health, long-term care, and home healthcare. She has a career record of 19 peer-reviewed publications. Since the last promotion in 2019, Professor Cooper contributed to 13 publications in peer-reviewed journals, eight of which she is first or second author and five of which are published DNP projects for which she served as the chair or co-chair. In addition, she currently has four manuscripts in progress/under peer review. She has a career record of 28 peer-reviewed poster presentations and three peer-reviewed podium presentations. Since earning tenure in 2019, Professor Cooper has contributed to seven national/state peer-reviewed presentations one podium and six poster presentations), as well as one invited presentation.

Professor Cooper has a successful track record in management of internal university and extramural federal and private source grants. She is co-leading a grant of over \$1 million from the Department of Health and Human Services (HRSA) aimed at addressing the shortage of psych/mental health nurse practitioner providers. She also has co-managed a HRSA residency grant of over \$1.6 million, that focuses on supporting the transition to practice for psych/mental health nurse practitionally, Professor Cooper successfully secured funding from the CVS Foundation in both 2021 and 2022, totaling \$7,000, to support graduate NP students at the university.

Professor Cooper demonstrates a strong potential for sustained contributions to scholarship in the future. She is highly motivated to continue to advance her scholarly contributions, and her success to date points to a confident prediction that she will continue on this path.

As a director in the SON, she serves on the Executive Committee (ex Officio) and the Leadership Council. She has also contributed her expertise to a number of staff and faculty search committees. At the university level, Professor Cooper has served on committees and events that include: University Elections and Nominating Committee; University Student Health Services with Ann Arbor; University Faculty Grievance Board; and University Curriculum Coordination Committee. Professor Cooper joined the NONPF Special Interest Group Leadership (2022-present) and is a reviewer for several professional journals including: the *Journal of Applied Gerontology* (2021-present); the *Journal of Nursing Care Quality* (2019-present); and *Geriatric Nursing* (2021-present). At the community level, Professor Cooper participated in the following events: Meals on Wheels (2020-present), and in Nurses' Week (2019-present). Additionally, she served as the president for the Hartland High School Booster Board (2019-2020).
