## Summary of Evaluation

<u>Teaching:</u> Professor Friedline has made significant contributions to the education of both M.S.W. and Ph.D. students, and her efforts are particularly impactful in the domain of macro practice within the M.S.W. program. Consistent with her scholarly expertise, she situates matters of social justice, diversity, and oppression in within historically rooted causes of economic inequality and engages students in learning about historical examples of resistance movements to inspire them to act as forces for change. Her evaluation scores are consistently strong and her efforts are strongly appreciated by students. Professor Friedline is a dedicated mentor of students at all levels and her role as a mentor to Ph.D. students, particularly those from marginalized backgrounds, is especially noteworthy. She has advised nearly 200 M.S.W. students and employed M.S.W.-level students on research projects, providing them with hands-on research experience and publication opportunities.

Research: Professor Friedline's scholarship seeks to illuminate and interrogate the ways that financial systems, predatory lending, and financial technology are oppressive and harmful to communities of color. Her research occupies a distinctive niche within a discipline (social work) in which the health impacts of systemic racism are readily acknowledged but seldom linked specifically to financial systems and practices. Through careful analyses of a diverse array of data, she exposes the ways in which taken-forgranted assumptions and practices in banking and lending systematically disadvantage underrepresented communities, largely escaping the awareness of those involved in these practices on an everyday level. Adopting a liberatory approach rooted in abolitionism, she seeks to advance consciousness-raising and political education for those affected by inequitable systems to empower them to advocate for change. As one of the rare scholars within the field of social work researching the systemic impact of financial systems on the well-being and health of people of color, her scholarship is distinctive and leading edge, notable for its alignment with social work values and for the degree to which it has generated public interest and engagement.

Taken together, Professor Friedline's recent book, her research articles, and her publicly engaged scholarly efforts (which include accessibly-written commentaries for non-academic audiences as well as public speeches and addresses) make for a compelling dossier for promotion to professor. Her rate of article and book productivity is quite strong and bibliometric statistics show that her work is highly cited. The attention that Professor Friedline's work has garnered in the media and the fact that her expertise has been sought after by the Consumer Financial Protection Bureau, the Federal Deposit Insurance Corporation, the Biden-Harris Campaign Economic Policy Council, and the Board of Governors Federal Reserve System attest to the deep impact her scholarship is making on policy and practice.

Service: Professor Friedilne, at the university and the school level, is a highly contributory and responsible faculty member who takes on extra assignments aligned with her strong commitment to inclusion and social justice. She has served on many significant school committees (doctoral program, promotion and tenure, dean's search) and has volunteered to convene a bimonthly policy discussion series at faculty meetings to stimulate conversations about policy matters that are of collective concern to our faculty. She also steps up for ad-hoc task forces such as a current effort to revise and modernize our promotion and tenure standards to incorporate community and public engagement. At the professional and community level, Professor Friedline's service efforts are high magnitude and offer opportunities to make her expertise visible and relevant to contemporary policy issues. She has contributed time and expertise to state and federal bodies that advise on issues such as consumer protection and financial regulation. At the professional level, she has been active in professional organizations and is a willing leader in convening important public conversations about social justice. In all of these ways, Professor Friedline employs her service in ways that benefit the school and the university and carry forward her deeply-held passion for social justice and radical social change.
