Summary of Evaluation:

<u>Teaching:</u> Professor Liu is a respected teacher as reflected by high course evaluation ratings by his students and the teaching awards he received. This is particularly noteworthy given the different number of courses he teaches each semester. Additionally, he taught in a variety of settings, formats and programs. He developed two new courses in response to the demands of the market and professional CPA standards. Professor Liu's classes go beyond accounting knowledge with emphasis on improving his students' presentation, teamwork, and critical thinking skills. He engaged his students outside the classroom when advising Beta Alpha Psi student organization.

Research: Professor Liu has nine publications, two of them in top tier high impact peer reviewed journals. In addition, he has four other articles under review in academic journals, and five working papers. This strong pipeline of research in progress foretells a continuing productive research agenda in years ahead. He has collaborated with various individuals on his research, reflecting his wide network of scholars. His expertise lies on two main research streams: determinants and consequences of financial reporting quality, and choice of auditors and audit quality. Professor Liu also published in widely read professional journals of accountancy making a strong impact on the practice as well.

<u>Service</u>: Professor Liu has provided active service to the School of Management, and the university. He is an engaged participant at the school and department meetings and attended events such as graduation, convocation, assessment, commencement, and honor society induction ceremonies in person. He served on the school's Undergraduate and Graduate Committees, several search committees for accounting and business law lecturers, and represented the school at the university's honors program. In these committees, he was instrumental in wide-ranging tasks from revision of admission requirements of the school's graduate programs to drafting high-impact journal lists for the accounting discipline.
