ACTION REQUEST

Subject: Regental Action Required Under the State of Michigan Conflict of Interest Statute

Action Requested: Authorization for the University to enter into a contract with MU Consulting, LLC (University of Michigan Employee, Marianne Udow-Phillips, Owner).

Background:

The University of Michigan Center for Health & Research Transformation (CHRT) seeks approval to enter into a contract with MU Consulting, LLC for consulting services.

The proposed contract falls under the State of Michigan Conflict of Interest Statute as Marianne Udow-Phillips is employed by the University as an Adjunct Lecturer with Ford School of Public Policy and an Intermittent Lecturer with the School of Public Health and would be a party to the contract as owner of MU Consulting, LLC.

However, the Statute allows the university to enter into such contracts if the following conditions are met:

- a) The public servant promptly discloses any pecuniary interest in the contract to the official body which has power to approve the purchase, which disclosure shall be a matter of record in its official proceedings.
- b) The purchase is approved by a vote of not less than 2/3 of the full membership of the approving body in open session without the vote of the public servant making the disclosure.
- c) The official body discloses the following summary information in its official minutes:
 - i) The name of each party involved in the contract.
 - ii) The terms of the purchase, including duration, financial consideration between the parties, facilities or services of the public entity included in the purchase, and the nature and degree of assignment of employees of the public entity for fulfillment of the purchase.
 - iii) The nature of any pecuniary interest.


The following information is provided in compliance with the statutory requirements contained in Section (c) above:

- i) The parties to the contract are the Regents of the University of Michigan and its CHRT and MU Consulting, LLC.
- ii) The contract is for a duration of eighteen months at a total cost not to exceed \$28,000. MU Consulting, LLC will supply the necessary resources and personnel to fulfill this contract. The remaining base contract terms and conditions are typical to those used in Procurement Services standard templates for other similar contracts entered into by the Regents.
- iii) The pecuniary interest arises from the fact that University of Michigan employee, Marianne Udow-Phillips, is owner of MU Consulting, LLC.

Marianne Udow-Phillips has met state law requirements with the disclosure of her pecuniary interest and formal appointment arrangements with the University of Michigan. Requirements, if any, that may be applicable by the supervisor of Marianne Udow-Phillips under the Center for Health & Research Transformation (CHRT) or OVPR's Conflict of Interest Committee's procedures are separately analyzed and managed.

We recommend that the Board of Regents approve the contract between the University of Michigan and MU Consulting, LLC subject to requirements, if any, that the supervisor of Marianne Udow-Phillips or the Center for Health & Research Transformation (CHRT) or OVPR's Conflict of Interest Committee may impose.
