On the recommendation of the Executive Committees of the Department of Economics and the College of Literature, Science, and the Arts, we are pleased to recommend the appointment of Daniel A. Ackerberg as professor of economics, with tenure, College of Literature, Science, and the Arts, effective September 1, 2010.

ACADEMIC DEGREES

Daniel Ackerberg received his Bachelor of Arts from Carleton College. He attended Yale University where he completed his Master of Science in 1993, Master of Philosophy in 1994, and his Doctorate in 1997.

PROFESSIONAL RECORD

Professor Ackerberg began his teaching career as an assistant professor at Boston University in 1996 and went to the University of California, Los Angeles at that same rank in 2000. He accepted a position as an associate professor, with tenure, at the University of Arizona in 2003. In 2004 he accepted a position as associate professor, with tenure, at UCLA. He resigned his position at the University of Arizona in 2006 and remained at UCLA at the same rank.

SUMMARY OF EVALUATION

Professor Ackerberg's field of expertise is industrial organization (IO) with an emphasis on the statistical analysis of structural models of firms and consumer interactions at a micro-level. He has made substantive contributions to core issues in IO as well as to econometric and computational methods. He has published several high quality, high impact papers in the top journals in the field. Professor Ackerberg has been an associate editor of *RAND Journal of Econometrics* since 2004, and associate editor followed by co-editor of the *International Journal of Industrial Organizations* (2002-2008).

Professor Akerberg is an award-winning teacher whose classroom contributions will be welcomed in the Department of Economics. Student evaluations at the undergraduate and graduate levels are outstanding. He has advised 23 graduate students and several of them have gone on to top academic programs.





On the recommendation of the School of Music, Theatre & Dance Executive Committee, I am pleased to recommend the appointment of Michael T. Hopkins as associate professor of music, without tenure, School of Music, Theatre & Dance, effective September 1, 2010.

ACADEMIC DEGREES

Professor Hopkins received his bachelor's of music education degree from Colorado State University in 1990. He then attended the University of Michigan and earned a master's in music education degree and a doctorate in music education in 1995 and 2001, respectively.

PROFESSIONAL RECORD

Professor Hopkins' academic career began at Colorado State University where he was the jazz band director in the Department of Music, Theatre and Dance. From 1994 through 1999, he held a variety of appointments in the Department of Music Education at the University of Michigan. He joined the faculty at the University of Vermont as an assistant professor of music in 1999, and was promoted to associate professor of music, with tenure, in 2005.

SUMMARY OF EVALUATION

Professor Hopkins showed himself to be a fine director of high school orchestras when he conducted and taught the Huron High School Concert Orchestra. He was very comfortable in the role, and in that context his personality shone. The ensemble clearly sounded better by the end of rehearsal. He used humor appropriately and connected well with the students. In his undergraduate teaching, he showed excellent musicianship and received positive results through his pedagogical approach. He listened well and was thoughtful with the students, demonstrating strong pedagogical values. It was evident that Professor Hopkins is a gifted musician and conductor. He has a national reputation in the K-12 string community, due in large part to his compositions and arrangements. He will be a strong attraction for state teachers and will be

actively and extensively involved in outreach in the state and nationally through conducting and clinics.

EXCERPTS FROM EXTERNAL REVIEWS

Reviewer A: “Dr. Hopkins’ varied experiences in the professional music world seem to have influenced his work in higher education, allowing him to understand and address with particular clarity important issues in contemporary string education. His curriculum vita suggests an integration of the theoretical and the practical with strengths in both areas. Reviewer B: “His work as composer and arranger of music for school string orchestra is prolific, and these works have been brought out by some of the leading school music publishers. He is one of the emerging leaders in string education of his generation. Given the prestigious platform that your position presents him, I have confidence that he will grow quickly in national prominence, will become a worthy successor to the historical heritage of Elizabeth Green and his mentor Robert Culver, and will continue your proud tradition of a national and international center of string education.”

Reviewer C: “Dr. Hopkins’ creative output appears to be centered in the areas of conducting and composition. Additionally, he has produced several compositions and arrangements that are commercially available. Dr. Michael Hopkins is known in the profession of string music education most notably for his string pedagogy web site.”


PROFESSIONAL ACTIVITY

At the University of Vermont, Professor Hopkins conducted the University Symphony Orchestra and taught string techniques, conducting, and music technology courses. He has a substantial record of creative activity, with 27 compositions and arrangements for string orchestra, with about half published by the renowned Alfred Publishing, Inc. He has been commissioned to compose works regularly since 2003, ranging from the Vermont Youth Orchestra Association and the Jackson Youth Orchestra to the Burlington Choral Society and the Belle Voce Women's Choir, Burlington. He has published in a premier music education research journal, *Journal of Research in Music Education*, as well as mainstream journals read widely by instrumental music teachers, *American String Teacher* and *The Instrumentalist*. His research is focused on problems of intonation for young/beginning string players. Perhaps his most significant contribution to the string education profession is his online *String Pedagogy Notebook: A Resource for Teachers and Performers*. This source is used intensively by teachers and has gained for him a strong reputation among string education practitioners.

SUMMARY OF RECOMMENDATION


Professor Hopkins has developed a national reputation as one of the leading string educators through his publications, compositional work and success as a conductor. He shows every indication that he is also a gifted teacher with strong pedagogical values and instinct. Professor Hopkins will make an excellent addition to the faculty in the Department of Music Education. Hopkins as associate professor of music, without tenure, School of Music, Theatre & Dance, effective September 1, 2010.



She is currently working on another book entitled *The History of Egalitarianism: a Thematic Approach*.

Professor Anderson is a splendid teacher who is especially well known for her undergraduate offerings. She teaches a number of large, popular courses, including "Law and Philosophy" and "Political Philosophy," as well as a senior seminar and three upper-level classes for graduate students. Her teaching evaluations are consistently among the highest seen in the Philosophy Department. Professor Anderson is also a dedicated and tireless graduate advisor who has served as chair or co-chair on nine Ph.D. dissertation committees that completed between July



This professorship was established in 1995 through a bequest from the estate of Maude T. Lane. The purpose of the bequest, under the direction of the Department of Surgery, is intended to promote research to determine the cause and possible cure of cancer.


Dr. Lubman has been a faculty member at the University of Michigan since 1983, beginning his academic career in the Department of Chemistry. In 2005, he joined the Medical School faculty as professor of surgery, with tenure, and was designated as the Maude T. Lane Professor of Surgical Immunology at that time. Dr. Lubman holds a joint appointment as professor of chemistry, without tenure, and a secondary appointment as professor of pathology, without tenure, was added in 2006.

Dr. Lubman is an internationally recognized leader in the area of chemical proteomics. The funds provided to Dr. Lubman by the Maude T. Lane Professorship have been critical in his efforts to establish a program in development of technology for biomarker detection. This effort has involved the establishment of a proteomics laboratory for detection of protein markers of cancer for early detection and progression. The technology developed involves approaches based upon novel microarray platforms, capillary separations and affinity methods, bioinformatics, and mass spectrometry. These methods have been applied in a number of collaborative projects with clinical investigators in the areas of pancreatic, colon, liver,

esophageal, breast, ovarian, prostate, melanoma, and bladder cancers. Among the more recent notable efforts by Dr. Lubman's research group is the discovery of markers of cancer based upon changes in phosphorylation and glycosylation structures using various microarray and affinity methods developed in the laboratory. These efforts have resulted in several glycoprotein markers for pancreatic and hepatocellular cancers that are now undergoing validation studies and have attracted attention by the Early Detection Research Network of the National Cancer Institute.

Dr. Lubman is a nationally and internationally recognized chemist and educator whose work provides a bridge between basic scientists and clinical disease. Since becoming the Maude T. Lane Professor in 2005, Dr. Lubman has continued to make valuable contributions to the research and educational programs in the Department of Surgery. I am very pleased, therefore, to recommend his reappointment as the Maude T. Lane Professor of Surgical Immunology, Medical School, effective September 1, 2010 through August 31, 2015.

Much of his work is centered on cell signaling pathways, which meshes extremely well with the interests of numerous investigators in the Department of Cell and Developmental Biology.

Dr. Hammer has been a longstanding contributor to the growth and development of the Center for Organogenesis and was named center director in December 2009. Through his center activities, he also has been an important contributor to the educational programs in the

I am pleased to recommend for Regental approval the appointment of Jeffrey K. MacKie-Mason as dean of the School of Information, for a five-year renewable term, effective July 1, 2010 through June 30, 2015. This recommendation follows an internal process that was guided largely by input from the School of Information faculty who, overwhelmingly, supported him as the next dean. Based on the high opinion in which he is held, the School's current momentum, the fact that a national dean search for the School concluded just three years ago, and the desire of the faculty to forego the traditional dean search process, the position was offered to Professor MacKie-Mason.

A member of the University of Michigan faculty since 1986, Professor MacKie-Mason earned tenure in the Department of Economics and served on the core faculty of the Ford School of Public Policy. Since 1996, he has been on the faculty of the School of Information, retaining his faculty appointments in economics and the Ford School. Since 2008, he has also served as the associate dean for academic affairs in the School of Information. In 2010, he was the recipient of a University of Michigan Rackham Distinguished Faculty Achievement Award.

Professor MacKie-Mason earned his A.B. *magna cum laude* in environmental policy from Dartmouth College in 1980, his Master's of Public Policy from the University of Michigan in 1982, and his Ph.D. in economics from the Massachusetts Institute of Technology (MIT) in 1986. He was a national fellow at the Hoover Institution at Stanford University in 1990-91 and a university partnership fellow with IBM in 1998-2001.

Professor MacKie-Mason is well known for his pioneering research on the economics of the Internet. He also works on the economics of other information technologies and of competition in high-technology markets. He has more than 80 publications appearing in scholarly journals in the areas of economics, computer science, and public policy, reflecting the multidisciplinary nature of his research. His recent


work focuses on the economics of information content and usage, including projects on spam reduction, peer-to-peer resource sharing, and incentives to increase information security. His teaching includes courses on incentive-centered design for information systems, the economics of information, information policy, human choice and learning, and antitrust.

In addition to his contributions to forming the School of Information, Professor MacKie-Mason was the founding director of the Program for Research on the Information Economy (PRIE), a cross-campus research program at the University of Michigan supporting multi-disciplinary research on social, economic and technical issues concerning new information technologies, which became the Socio-Technical Infrastructure for Electronic Transactions (STIET). Under his leadership, STIET has received over \$9 million in funding for doctoral fellowships and research seminars, and engaged the collaborative multidisciplinary research of over 20 faculty members from five schools and colleges at the University of Michigan and four departments at Wayne State University. He was also the research director for the first large-scale field experiment on electronic commerce for electronic access to scholarly journals (PEAK).

Professor MacKie-Mason has advised the National Science Foundation, the U.S. Department of Justice, the U.S. Federal Communications Commission, and other government agencies. He presently serves on the Advisory Committee to the National Science Foundation Directorate of Social, Behavioral and Economic Sciences (SBE), and on the Advisory Committee to the NSF Directorate of Computer and Information Science Engineering (CISE). He serves or has served on the editorial boards of *IEEE Security & Privacy*; *RAND Journal of Economics*; *Netnomics: Economic Research and Electronic Networking*; *Telecommunications Systems*; *Electronic Commerce Research*; and *Information Economics and Policy*.

Provost-Designate Hanlon and I are extremely pleased that Professor MacKie-Mason is assuming the leadership of the School of Information at this time of dramatic change for the School and within the field of information resources and technology. We are confident that he will provide impressive leadership for the School of Information, strengthening the School's international reputation of excellence in providing innovative education for the next generation of library science and information professionals. I recommend his appointments with the greatest enthusiasm, effective July 1, 2010.


executives to speak to our graduating students, enhancing the value of our MAcc program. Professor Shakespeare also serves as an advisor to our doctoral students.

Dr. Todd came to the University of Michigan in 2008 to undertake a clinical fellowship in movement disorders and neurogenetics. In January 2010, he joined the instructional faculty at the University of Michigan as an assistant professor of neurology.

Dr. Todd's current research is focused on the mechanisms underlying RNA-mediated neurodegeneration in fragile X tremor ataxia syndrome (FXTAS) and myotonic dystrophy, and how these mechanisms may overlap and inform our understanding of other neurodegenerative disorders. 

This professorship was established in May 2010 and is intended to support the activities of a tenured faculty member in the Department of Surgery with expertise in burn surgery.



On the recommendation of Michael W. Mulholland, M.D., Ph.D., the Frederick A. Coller Distinguished Professor and Chair of the Department of Surgery, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the establishment of the Cyrenus G. Darling, Sr., M.D. and Cyrenus G. Darling, Jr., M.D. Professorship in Surgery, Medical School, effective June 1, 2010.

This endowed professorship is made possible through a generous gift and pledge from Mr. David P. Darling and endowment funds in the Department of Surgery. Mr. David Darling is a graduate of the University of Michigan, receiving the B.B.A. degree in 1961 and the M.B.A. in 1962. In recognition of the donor's grandfather, Dr. Cyrenus G. Darling, Sr., who was renowned as a skilled teacher and clinician, this professorship is intended to support the activities of a tenured faculty member in the Department of Surgery who has demonstrated teaching and clinical excellence. The initial term for the Darling Professor will be five years and the appointment may be renewed.


Cyrenus G. Darling Sr. received his M.D. degree from the University of Michigan in 1881. In 1890, he joined the faculty of the Medical School (then the Department of Medicine and Surgery) as assistant to the professor of surgery and clinical surgery. In 1891, he became a lecturer on oral pathology and surgery in the College of Dental Surgery and served as dean from 1903-1907. Dr. Darling was named as the acting head of the Department of Surgery in 1914. In 1917, nationally known as an authority on oral surgery, Dr. Darling provided the inspiration for the development of the oral surgery training program at the University of Michigan Hospital. In 1919, he retired from the medical faculty, but retained his position as professor of oral surgery in the Dental College until 1927. Dr. Darling was one of the founding members of the American College of Surgeons. Outside of his connection with the University of Michigan, Dr. Darling was mayor of the City of Ann Arbor in 1894. In 1911, he was instrumental in establishing St. Joseph Mercy Hospital in Ann Arbor and was its chief of staff until a short time before his death in 1933. He was known during the latter part of his life as the "dean of Michigan surgeons."

David Darling's father, Cyrenus G. Darling, Jr., also was a graduate of the University of Michigan Medical School. He became a medical doctor in 1925 and went on to become the chief of surgery at St. Joseph Mercy Hospital in Pontiac, Michigan. He was on staff at Pontiac



As a general surgeon before the age of specialization, he had a broad range of competencies. He loved medicine and was highly dedicated to the profession. Dr. Darling passed away in 1968.




The Hunein F. and Hilda Maassab Endowed Professorship in Epidemiology is funded with \$2 million proceeds from FluMist. Hunein Maassab is professor emeritus in the School of Public Health, having served on the School's faculty from 1957 to 2002. He chaired the Department of Epidemiology from 1991 to 1997. Professor Maassab devoted his career to developing an influenza vaccine based on live attenuated virus that could be administered intra-nasally. His research culminated in the development of the product called FluMist which continues to protect millions of people from H1N1 influenza. The professorship is intended to honor Professor Maassab for his enormous contribution to science and to public health. The professorship will provide support for an outstanding faculty member whose primary appointment is in the Department of Epidemiology. The first holder will be a scientist who will focus on infectious disease epidemiology.

Appointments to the Hunein F. and Hilda Maassab Endowed Professorship in Epidemiology will be made by the Dean and Executive Committee of the School of Public Health. The holder will be selected from tenured faculty with demonstrated teaching and research expertise in epidemiology and/or related public health fields.
