On the recommendation of the executive committees of the Department of Psychology, the Department of Afroamerican and African Studies, and the College of Literature, Science, and the Arts, we are pleased to recommend the appointment of Isis H. Settles as professor of psychology, with tenure, and professor of Afroamerican and African studies, with tenure, College of Literature, Science, and the Arts, effective September 1, 2016.

ACADEMIC DEGREES

Isis Settles received her Bachelor of Arts from Harvard University in 1993. She attended the University of Michigan where she completed her Master of Arts in 1997 and Doctorate in 2001.

PROFESSIONAL RECORD

Professor Settles began her instructional career as an assistant professor at Michigan State University in 2001 and was promoted to associate professor in 2009. She has been a core faculty member of the Consortium for Multicultural Psychology Research (2006-present) and of the Center for Gender in Global Context (2006-present). Professor Settles has also served as the chair of the Social/Personality Area in the Department of Psychology (2010-2014).

SUMMARY OF EVALUATION

Professor Settles' research interest has long been grounded in women's and gender studies; her dissertation focused on the "multiple identities" of women in the sciences. Her work has looked squarely at African American women's identity. In her current research, Professor Settles employs both qualitative and quantitative methods to study black identities as shaped by race and gender, and ultimately how black identities impact on mental health outcomes. Her findings on differences between black men and women bring hard data and nuanced understanding to intuitive notions about black women's sense of self being more tied to family and community and black men's sense of self perhaps being tied to their position within a privileged group (as men). Professor Settles has received significant grant funding from the National Science

Foundation (to study diversity in STEM research teams) and the National Institute of Mental Health (to study race and gender identity functions) as well as additional funding from Michigan State University (MSU). She has published 23 articles, seven book chapters, and currently has four articles/chapters under review. Professor Settles was awarded the 2014 Excellence in Diversity Award at MSU, and the 2006 Carolyn Payton Early Career Award for her significant contribution to understanding gender in black women's lives. Professor Settles is a fellow in the American Psychological Association's (APA) in Division 9 (Social Issues) and Division 35 (Psychology of Women). She has performed a wide range of service roles at MSU and within APA (where she holds two elected positions), and she has expressed a strong interest in serving in leadership positions in the Department of Psychology and/or in the Department of Afroamerican and African Studies (DAAS).

Professor Settles has accumulated a considerable teaching portfolio with a diversity of experience over the course of her ten years in the profession. She has taught large and small courses as well as undergraduate and graduate courses in a range of topics from social identity and prejudice to the psychology of gender. In DAAS, which is currently an undergraduate unit in the main, Professor Settles is well prepared to teach courses on black identity, stereotype and stereotype threat, and African American women's psychology. DAAS has a longstanding interest in increasing the number of faculty who can offer courses on gender, sexuality, and race. We expect Professor Settles will develop courses of joint interest to undergraduate students in both departments.



On the recommendation of the executive committees of the Department of Communication Studies and the College of Literature, Science, and the Arts, we are pleased to recommend the appointment of Jan Van den Bulck as professor of communication studies, with tenure, College of Literature, Science, and the Arts, effective September 1, 2016.

ACADEMIC DEGREES

Jan Van den Bulck attended Katholieke Universiteit (KU) where he completed his Bachelor of Arts in 1985, Master of Arts in 1987, and Doctorate in social sciences in 1996. He attended the University of Hull where he received a Master of Arts in political science in 1989 and a Doctor of Science in epidemiology from Erasmus University of Rotterdam in 2006.

PROFESSIONAL RECORD

Jan Van den Bulck completed his Doctorate in social sciences at KU in 1996. Following a three-year post-doctoral fellowship at KU (1997) and at the Fund for Scientific Research in Flanders (1998-2000), he was appointed as an assistant professor in KU's Department of Communication and promoted through the ranks to professor in 2008. Professor Van den Bulck has held a courtesy appointment as a professor in the Brian Lamb Department of Communication at Purdue University since 2008. He was also an associate dean of research in the social sciences at KU (2010-2013).

SUMMARY OF EVALUATION

Professor Van den Bulck is a quantitative media effects scholar who focuses on media psychology, especially on the study of children and media. He has established an international reputation for his contributions to the field of communication, primarily in media effects, epidemiology of media and health, and youth and media. His work maintains a strong focus on cause-and-effect reasoning and validity of measurement. Professor Van den Bulck's total publication record is impressive: 90 peer-reviewed journal articles, two edited books, and eleven book chapters (in English), and eleven peer-reviewed articles and seven book chapters (in Dutch). Many of these publications appear in top communication and public health journals.

Professor Van den Bulck will bring courses to the Department of Communication Studies that fit squarely within their curriculum, and which will be attractive to undergraduate and graduate students. He will easily be able to move into several of their undergraduate and graduate-level core courses. He has taught truly large lectures (800+ students) and smaller seminars, and won teaching awards for his efforts.





Summary of Evaluation:

Teaching: Professor Yoon has invested a substantial amount of effort in her teaching. This resulted in successful improvement on all counts, increasing her quantitative evaluations to 4.3 on average across her three sections. Additionally, the doctoral student body at Ross chose to select Professor Yoon this year to receive the Ph.D. Teaching Excellence Award. Ph.D. students reward those faculty members who play particularly important mentoring and advising roles in the program by giving them an award. In explaining their choice of Professor Yoon, the Ph.D. students noted that she “is a passionate teacher, whose pedagogical style reflects her passion and dedication in mentoring new generations of academic scholars. Thanks to [...] her seminars and mentorship, she has fostered an open and collaborative environment that is conducive to learning, research, and career development for all students.”

Research: Professor Yoon is well recognized as a major expert and leader in two important and understudied areas of research – the use of neuroscience in marketing and the psychology of the aging consumer. She has published papers in top journals in both of these areas, co-edited special issues of top marketing and consumer psychology journals and organized several conferences and Ph.D. consortia. Her research leadership in advancing neuroscience in marketing is particularly noteworthy, as it is a complex area, from both a theoretical and applied point of view. Professor Yoon has also built research bridges across departments and schools at the University of Michigan, resulting in work that has impact across disciplines. In addition, her work on novel areas of research such as neuroscience (two top journals have devoted an entire issue to this topic, testifying to its importance among the marketing community) enhances the reputation of the Ross School as a cutting edge research school.

Service: Professor Yoon has worked hard to serve the marketing Area, the Ross School, the University of Michigan and the consumer behavior field. At the field level, this is evidenced by (a) her editorial board positions at top journals (including associate editor at the *Journal of Marketing Research*), (b) leadership in organizing or co-organizing 11 high-profile academic conferences and workshops since 2006, including the 2015 North American Association for Consumer Research annual conference, and (c) editorship of special issues in top journals e.g., she has been the guest co-editor of a special issue on neuroscience at two top marketing journals (the *Journal of Marketing Research* and the *Journal of Consumer Psychology*). At the university, she has served on multidisciplinary committees and as a member of multiple centers and initiatives. At Ross, she has served on the Curriculum Committee (as the marketing Area representative) and on the Diversity Committee, and currently served on the Ph.D. committee. Within the marketing area, she has been a willing volunteer for area work, including serving as Ph.D. advisor for the area, and serving on recruiting committees and on the external review committee. Finally, she has worked with many doctoral students, especially mentoring students that have had a difficult time in the program. It should be noted that according to her colleagues, if she had been asked to

provide more service for the area, she would have done so with no hesitation. Professor Yoon has distinguished herself with respect to service to the University and the field of consumer research.

With the endorsement of the Executive Committee of the School of Nursing, I am pleased to recommend the appointment of Lynae A. Darbes as associate professor of nursing, without tenure, School of Nursing, effective September 1, 2016.

ACADEMIC DEGREES

Professor Darbes received her Bachelor of Arts in psychology from the University of Michigan in 1988. She received her Master of Arts in clinical psychology from the University of Colorado, Boulder in 1996. She participated in a clinical psychology internship at the Boston Consortium in Clinical Psychology from 1999-2000. She received her Doctorate of Philosophy in clinical psychology from the University of Colorado, Boulder in 2000.

PROFESSIONAL RECORD

Professor Darbes has held a number of academic and non-academic positions including therapist at the Raimy Psychology Clinic - University of Colorado, Boulder from 1994-1999; psycho-diagnostician at the University Hospital - University of Colorado, Boulder from 1995-1998; co-facilitator at the University of Colorado, Boulder from 1995-1997; community mental health worker at Boulder County Mental Health Services from 1996-1998; co-facilitator for the Boulder County AIDS Project from 1995-1998; intern at the Multicultural Center at the University of Colorado, Boulder from 1996-1999; senior public administrative analyst (2000-2001), project director (2000-2001, 2002-2005), and specialist step II (2001-2004) at the University of California, San Francisco (UCSF); consultant at World Bank from 2002-2003; core staff at the Institute for Global Health from 2002-2003; assistant professor from 2004-2012, and associate professor without tenure in the School of Medicine at UCSF. She has held an appointment in the University of Michigan (UM) School of Nursing as an assistant research scientist since March 2016.

SUMMARY OF EVALUATION

Professor Darbes has taught psychology students and medical students. Most, she taught in the School of Medicine at UCSF and her teaching load included teaching small group seminars with medical students. She taught a two-year seminar to three cycles of medical students with the focus

on improving interviewing and interpersonal skills with patients (e.g., taking medical histories) and improving students' comfort-level and skill-level with regard to discussing sensitive topics such as sexuality, spirituality and death and dying. Student evaluations from the seminars suggest that Professor Darbes works well with small student groups. Students rated her performance on a 5-point Likert scale from 1 = poor to 5 = excellent. Her teaching prior to 2012 as a small group facilitator and lab instructor is solid, her reviews in the good to excellent range, and comments from students positive. Professor Darbes engages students well and communicates appropriately. There is evidence to suggest that Professor Darbes relates well to students and this is an important characteristic for successful teachers.

Professor Darbes has successfully mentored several junior faculty members and two PhD students. She has seven manuscripts either published or under review with her mentees as co-authors, five with mentees as the first author. She has been successful in getting funding for her mentees and is the primary mentor on a faculty member's K01 from *National Institute of Mental Health (NIMH)* and a scientific advisor on another faculty member's K01 from NIMH. In addition, she mentored a pre-doctoral student on her research team and she currently serves as a primary mentor on this student's dissertation committee at the Bloomberg School of Public Health at Johns Hopkins University.

Professor Darbes is highly committed to understanding how primary partners can influence health behaviors, which can ultimately impact one's morbidity and mortality. This is a particularly important issue with the transmission of HIV, as primary partners are the source of HIV infections in the majority of cases. Most of the intervention work for HIV prevention focuses on individuals, but Professor Darbes has taken on the challenge of studying couples. She conducts both qualitative and quantitative studies in domestic and international populations. She has been conducting research in this area for 15 years and is a pioneer in this field. She has developed and tested a theory-based couples-based intervention designed to increase rates of couples-based testing for HIV, by improving positive relationship dynamics and communication skills. Much of her work has been conducted in Africa, but she has also conducted studies of domestic couples examining relationship-based predictors of sexual risk behavior.

The high quality of Professor Darbes research is illustrated in part by the fact that her research is regularly funded by the National Institutes of Health (NIH), the highest level of peer review. She just completed an R01 grant and is currently the primary sponsor on one K01 award and a scientific sponsor on another K01 award. She has been the principal investigator (PI) on a total of four NIH awards including the R01 and a competitive supplement to her R01, a K08 and an R03. In addition, she has been a co-investigator on multiple NIH grants and was the PI on two internal grants. Professor Darbes publishes in a wide array of journals including some of the most respected journals in her field: *Archives of Sexual Behavior*, *Social Science & Medicine*, *AIDS Care - Psychological and Socio-Medical Aspects of AIDS/HIV*, *AAIDS and Behavior*, and *AIDS*. She has published a total 32 peer reviewed papers with nine as the first or senior author, and three as co-author with student/faculty mentees. She currently has seven manuscripts under review. She has also authored 18 abstracts presented in national and international meetings. Her rate of publications has increased throughout her career and since promotion to associate professor in 2012 at UCSF, she published 20 data-based papers. Scopus reports that Professor Darbes' work has been cited 617 times and three papers have been cited more than 50 times. This suggests that the impact of her work is valued by her peers and she is making a meaningful contribution to the field.

In addition to her publications, Professor Darbes has been visible in regional and international research endeavors. She has been an invited speaker at conferences both nationally and

internationally and presented her research at peer-reviewed conferences, including the prestigious International AIDS Conference. Her ability to disseminate her research findings to interdisciplinary audiences speaks to her abilities as a researcher and academic. Professor Darbes is recognized as an expert in the study of couples as evidenced by her invitations to speak at international and national meetings and her invitations to serve as a reviewer for research grant applications. She has given a total of 14 invited presentations, and since 2012 she has given three invited presentations at international meetings: Gay Men's Sexual Health, A focus on couples in San Juan, Puerto Rico (2012), Contemporary issues in gay men's sexual health, San Juan, Puerto Rico (2014) and AIDS Impact Conference in Amsterdam (2015). She has also served as an invited research reviewer for foundations, NIH and the Centers for Disease Control and Prevention (CDC). Twice she served as an ad hoc reviewer for the NIH and once for the CDC. Professor Darbes' contributions to the interdisciplinary field of HIV research has been recognized by her service as an ad hoc reviewer for the study section on HIV, Special Emphasis Panel at the CDC in 2006. In addition, she served as a reviewer for the AIDS Fond in The Netherlands, the CUNY Collaborative Incentive Research Grant program in New York and for the University of Wisconsin-Milwaukee for their Research Growth Initiative. In addition, she is periodically invited to critique systematic reviews for the Cochrane Collaborative and these reviews only go to experts in the field. Taken together this is strong evidence that Professor Darbes is recognized as an expert in her field of research at the national and international level.

Professor Darbes contributes service to her profession, mostly in the form of peer review of research as described above. She regularly performs peer review for multiple journals and in the last five years has reviewed 34 manuscripts. She reviews research grants for NIH, Centers for Disease Control and Prevention (CDC) and the AIDS Fond in the Netherlands, all of which require the highest level of peer review. She was active at the departmental level and served on multiple groups for the Center for AIDS Prevention Studies at UCSF. In addition, Professor Darbes is a member of multiple professional organizations including American Public Health Association, Society for Behavioral Medicine and International AIDS Society. This represents a steady and meaningful level of service to the scientific community.





With approval of the Executive Committee of the College of Literature, Science, and the Arts, we are pleased to recommend the reappointment of Patrice Speeter Beddor as the John C. Catford Collegiate Professor of Linguistics, College of Literature, Science, and the Arts, for a five-year renewable term, effective September 1, 2016 through August 31, 2021.

The John C. Catford Collegiate Professorship in Linguistics was established in the Provost Office and was named in August 2011. John C. Catford was a faculty member at the University of Michigan from 1962 until his retirement in 1986. A stipend funded from college resources will accompany this professorship.

Professor Beddor is internationally recognized for her field-defining research. Her work reflects the talents of a rigorous and innovative scholar who receives consistent praise from colleagues across the academy. Professor Beddor's research specialty is phonetics, the branch of linguistics that studies the physical manifestations and interpretations of speech sounds. She is recognized as one of the few phoneticians who address the boundaries of production and perception in ways that connect to higher-level models of the human capacity for language. Indeed, she is a pioneer in this area.

Professor Beddor is perhaps best known for her research on the phenomenon of co-articulation, in which sounds are influenced by nearby sounds in the speech stream. Her investigations of the perception of co-articulation have made important methodological contributions to the field, particularly in disentangling the relationship between articulatory gestures and the acoustic properties of speech sounds. Many of the experimental paradigms that she has employed are now standard in the field, and are even used for investigating other phenomena. The success and importance of Professor Beddor's research can easily be assessed by external measures. She has consistently been awarded grants from National Science Foundation (NSF), including her most recent one in excess of \$390,000 (2015-2018). Among her numerous publications are articles in the major phonetics journals (*Journal of Phonetics*, *Journal of the Acoustical Society of America*, *Phonetica*) and two articles in *Language*, the most prestigious general linguistics journal in the world. Her co-edited book, *Experimental Approaches to Phonology* (2007), is still widely praised and illustrates her rare ability to branch out from phonetics as narrowly conceived into other subfields of linguistics. Professor Beddor has given numerous national and international presentations, with highlights

including a keynote lecture at the 18th International Congress of Phonetic Sciences (2015), the largest international phonetics conference; and a plenary lecture at the annual conference of the Linguistic Society of America (2012), the largest professional organization of linguists. Other signs of her ongoing standing in our field are her election to the International Phonetic Association Council (2015), her appointment as senior editor to the Oxford Handbooks Online series (2015), her membership on numerous editorial boards, and her ongoing service to the NSF as a member of its College of Reviewers for its program in Perception, Action, and Cognition (2013-present).

Professor Beddor's teaching record is also impressive, with multiple indicators of instructional and advising success. She is hugely popular as a teacher of both undergraduate and graduate courses, and student evaluations attest to that fact. She recently led the task force charged with the creation of the new Cognitive Science major in the College and the subsequent establishment of the Weinberg Institute for Cognitive Science, on whose advisory board she continues to serve. The current director of the Weinberg Institute, Samuel Epstein, acknowledges Professor Beddor's fundamental role in that effort. Professor Beddor has served as the chair or co-chair of sixteen dissertation committees and as a committee member on sixteen more. Her students are well-placed in the field of phonetics. Her colleagues in the field consistently remark on the importance of her mentorship of graduate students. She also mentors faculty colleagues at Michigan and elsewhere.

Professor Beddor's service to the university has been nothing short of outstanding. In 2010, she completed her second three-year term as chair of the Department of Linguistics. Her wildly effective and successful service as chair is perhaps the most notable among the many service commitments she has taken on. However, Professor Beddor has been an overly generous steward of her department, the college, the university, and of the broader scholarly community.

Professor Beddor is an extraordinary researcher, a caring and rigorous instructor, a committed mentor, and an exemplary citizen, a set of qualities. We are very pleased to recommend the reappointment of Patrice Speeter Beddor as the John C. Catford Collegiate Professor of Linguistics, College of Literature, Science, and the Arts, for a five-year renewable term, effective September 1, 2016 through August 31, 2021.

Collier Distinguished Professor and Chair of the Department of Surgery, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the reappointment of Andrew C. Chang, M.D. as the John Alexander Distinguished Professor of Thoracic Surgery, Medical School, effective September 1, 2016 through August 31, 2021.

The John Alexander Distinguished Professorship in Thoracic Surgery was established in September 1996 as a memorial to Dr. John Alexander, long regarded as the father of American thoracic surgery. He served as the first head of the section of Thoracic Surgery at the University of Michigan from 1928 until his death in 1954. 



With approval of the Executive Committee of the College of Literature, Science, and the Arts, we are pleased to recommend the reappointment of Xuming He as the Harry Clyde Carver Collegiate Professor of Statistics, College of Literature, Science, and the Arts, for a five-year renewable term, effective September 1, 2016 through August 31, 2021.

The Harry Clyde Carver Collegiate Professorship in Statistics was established in the Provost Office and was named in September 1997. Harry Clyde Carver was a professor at the University of Michigan from 1918 to 1961. A stipend funded from college resources will accompany this professorship.

Professor He is one of the leading researchers in the world in statistical theory and methodology. His most recent work is centered in three general areas: (1) Quantile regression methods which focus on the validity of posterior inference for Bayesian quantile regression analysis, which has highlighted a common misuse of Bayesian inferential methods in practice and provided a remedy; (2) Bayesian model selection for highly dimensional data which has led to a new algorithm that scales up for highly dimensional data; and (3) Interdisciplinary work on brain network scores for the study of concussions where collaborative work with colleagues in the Department of Kinesiology and in the Medical School has produced results on the stability and reliability of brain activity scores in an objective study of athletic concussions. He continues to maintain a vigorous rate of refereed publication (at about five papers/year).

Professor He's extramural and intramural service work is exemplary, highlighted by his activity, starting in 2015, as chair of the Department of Statistics. He has received numerous honors, including election as a fellow of the American Association for the Advancement of Science and the 2015 Distinguished Achievement Award of the International Chinese Statistical Association. Professor He works with a large number of students. One student successfully completed a Ph.D. in 2014 and is now on the faculty of Fudan University. Three more are expected to complete their work in 2016.



Professor Hitchcock's research program has been continuously funded by NIH grants since 1987.

Dr. Kretzler received his M.D. degree from the University of Heidelberg in 1993. He joined the faculty at the University of Michigan in 2005 as an assistant professor. In 2009, he was promoted to professor in internal medicine, and research professor in Computational Medicine and Bioinformatics. Dr. Kretzler's research focuses on the use of modern molecular biology tools to better understand disease mechanism activated in human renal biopsies. He evaluates novel tools for molecular diagnosis of kidney and transplant failure in international multicenter studies. He has established the preeminent research program for translational medicine and systems biology in the United States and has established research networks and partnerships with academia and industry that span the globe. Dr. Kretzler has developed a standardized clinical and sample procurement protocol for integrative -omic analysis in renal disease cohorts. His laboratory has also completed a 14 year study to identify comprehensively non-invasive biomarkers in chronic kidney disease and validate them in studies across three continents. Dr. Kretzler continues to be prolific in his research, with 213 peer-reviewed articles to his credit, and continuous funding from the NIH and private foundations. In 2014, he was appointed as a distinguished fellow of

the European Renal Association. He serves on the editorial board for the *Journal of the American Society of Nephrology*, *Clinical and Experimental Nephrology*, and *Kidney International*.

Dr. Kretzler is a leader in translational research for chronic disease, and developing therapeutic targets and diagnostic molecules. He has established a full, seamless research pipeline to provide molecular target identification in humans, drug compound development, target validation in animal model systems and clinical trial execution. 

He believes that clinical translation is possible within five years based on advances and ongoing work. Dr. Mychaliska is the director of the Fetal Diagnosis and Treatment Center. Working with his multi-disciplinary team, he has effectively created a comprehensive fetal therapy center that is nationally recognized for its clinical excellence and innovation.




On the recommendation of the Executive Committee of the Medical School, I am pleased to recommend the reappointment of Yoichi Osawa, Ph.D. as the Warner-Lambert/Parke-Davis Professor of Medicine, Medical School, effective September 1, 2016 through August 31, 2021.

The Warner-Lambert/Parke-Davis Professorship in Medicine was made possible by an endowment from the Warner-Lambert Company in 1993. Funds generated by the initial endowment reached a sufficient level to permit the establishment of two additional professorships in April 2006 to support Medical School investigators in scientific research in the fields of basic chemistry, molecular biology, biotechnology, genetics and/or human gene therapy. The appointment period is up to five years and may be renewed.

Dr. Osawa received his Ph.D. degree in pharmacology from the University of Michigan in 1987, and joined the faculty in 1995 as an assistant professor of pharmacology. He rose through the ranks to professor in 2007. Dr. Osawa is renowned for his novel and significant work in the field of biochemical pharmacology. He is an expert on drug metabolism and has been studying the chemical mechanisms of inactivation of P450 enzymes by drugs, environmental toxins and other chemical substances that are foreign and harmful to living organisms. Dr. Osawa's research continues to be productive with important biomedical applications, including increased understanding of the mechanism of tissue damage in the aging process. He has published 78 peer-reviewed articles, and is the director of the Biomedical Mass Spectrometry Facility at the University of Michigan. His research is funded by the American Heart Association and the NIH.

Dr. Osawa is a successful mentor and teacher to students at all levels. He serves on national committees, and continues to be an innovative and outstanding scientist. I am, therefore, pleased to recommend the reappointment of Yoichi Osawa, Ph.D. as the Warner-Lambert/Parke-Davis Professor of Medicine, Medical School effective September 1, 2016 through August 31, 2021.



After working as a research assistant at the Massachusetts Institute of Technology, he joined the faculty at Yale University as an assistant professor in 1993. In 1996, he was appointed at the University of Michigan as an assistant professor in the Department of Electrical Engineering and Computer Science. He was promoted to associate professor in 1999 and to professor in 2005. He was appointed as the chair in 2011. He has also served as president, chief scientist, and chairman of the board since 2005 of Cyclos Semiconductor, Inc.

Professor Papaefthymiou's research interests are in the area of energy-efficient computing. He is the recipient of several awards, including the NSF CAREER Award, the ARO Young Investigator Award, multiple IBM faculty awards, and U-M faculty awards. His research has been recognized by multiple best paper awards. In addition to his extensive publications on the topic of energy-efficient computing, Professor Papaefthymiou holds 21 issued patents on energy-efficient computer technologies. He is the co-founder of Cyclos Semiconductor, a University of Michigan spinoff that commercializes semiconductor intellectual property for energy-efficient computers. Cyclos' technology is currently used in high-performance computer chips manufactured by AMD and IBM.

Professor Papaefthymiou has demonstrated that he possesses the experience, ability, and commitment to fulfill the important responsibilities of a department chair in the College of Engineering. 

The Denise Riley Collegiate Professorship in the History of Art and Women's Studies was established in the Provost Office and was named in August 2011. Denise Riley was a visiting faculty member at the University of Michigan during winter term 2004. A stipend funded from college resources will accompany this professorship.

Professor Siegfried is a superb scholar whose intellectual integrity, accomplishments, leadership, and service to her field are widely recognized as exemplary. Her formidable presence in the field of eighteenth and nineteenth century studies is based on a substantial body of impeccable scholarship. She is the author of three books, an edited volume, and an important exhibition catalogue, plus substantive articles on a range of topics, several of which have been of foundational importance for further research. She has also curated two substantial exhibitions. Professor Siegfried has made a mark in the study of the sociology of art (showing intimate knowledge of its markets and institutions) and in the study of gender and gendered viewing. At present she is also spearheading the humanities-wide interest in problems of materiality. In recognition of her standing in her field, Professor Siegfried has received a series of awards and fellowships, including a Paul Mellon Senior Fellowship, Center for Advanced Study in the Visual Arts, National Gallery of Art; a Michigan Humanities Award, 2014-2015; and a Clark Fellowship at the Clark Art Institute, 2010.

Professor Siegfried is a greatly admired teacher and mentor who has had substantial impact on her field as much through her scholarship as through the quality of instruction she has offered and the numerous dissertations she has directed and advised. She has taught regularly at every level. Professor Siegfried's lectures are famously engaging and compelling, and she attracts the interest of students from many concentrations. In response, students have high praise for her erudition, humor, generosity, and her unique ability to pique their interest in historically distant worlds. She has played a critical role in the graduate program having served as its director (2003-2005) and as an advisor/mentor to many graduate students at one point or another in their careers.



Following graduation, he joined the Caltech Jet Propulsion Laboratory as a research scientist. He moved to NASA in 1986, taking a position as a discipline scientist for magnetospheric physics in the Space Plasma Physics Branch. From 1987 to 1989, he served as a staff scientist in the NASA/GSFC Laboratory for Extraterrestrial Physics. He served as head of the Electrodynamics Branch at NASA from 1990 through 2004 and then as director for the Heliophysics Science Division from 2005 to 2011. Professor Slavin joined the University of Michigan as the chair in 2011.

Professor Slavin teaches space plasma physics and space engineering, advises five graduate students and conducts research on the structure and dynamics of planetary magnetospheres. He has published over 400 scientific and technical journal articles. Professor Slavin is the recipient of two NASA Exceptional Achievement Medals (2004 & 2008), eight NASA Group Achievement Awards, a University of California Regent's Fellowship in Space Physics (2006) and he was elected a fellow of the American Geophysical Union (2012). Currently, Professor Slavin is a science investigator for the Magnetospheric Multiscale, BepiColombo, JUICE and Europa missions that will discover the fundamental plasma processes occurring in the space environments of Mercury, Earth and Jupiter.




Professor Solomon has published articles in such publications as *Proceedings of the National Academy of Sciences of the United States of America*, *Journal of Infectious Diseases*, *Current Opinion in Colloid Interface Science*, *Applied and Environmental Microbiology*, *Soft Matter*, *Korea-Australia Rheology Journal*, *Physical Review Letters*, *Nature*, and *Macromolecular Rapid Communications*, and *Langmuir*. His research interests are in the area of complex fluids and his group has applied new 3D confocal microscopy methods to generate discoveries in nanocolloidal assembly, colloidal gelation, and the biomechanics of bacterial biofilms. His work has also included discovery of a universal scaling for polymer scission in turbulence that identifies the limits that scission imposes on turbulent drag reduction. Other research interests have included the rheology of polymer nanocomposites, the microrheology of complex fluids and the microfluidic synthesis of anisotropic particles.

Professor Solomon was awarded the Department of Chemical Engineering Faculty Excellence Award in 2013, in 2011 Soft Matter Lectureship which is given annually by the Royal Society of Chemistry's journal Soft Matter, the College of Engineering's 2010 Education Excellence Award, and a 2008 Faculty Recognition Award from the Rackham Graduate School. In 2006, the University of Michigan Chapter of the American Society of Engineering Education named him Outstanding Professor of the Year and in 2003 he received the University's Henry Russel Award. In addition to his academic achievements, Professor Solomon has extensive administrative experience at the University of Michigan, currently serving on the Department of Chemical Engineering's Undergraduate Committee, as a member of the Rackham Graduate School's Mentoring Others Results in Excellence (MORE) Committee, and as faculty advisor to the University's Leadership and Integration in Faculty Transitions (LIFT) program. He has served as the College of Engineering's Accreditation Board for Engineering and Technology (ABET) Review liaison to the College of Literature, Science, and the Arts (2010-2011), as chair of the Chemical Engineering Faculty Search Committee (2009-2011), as a member of the Faculty Recognition Award Selection Committee at the Rackham Graduate School (2009-2012), as chair of the Chemical Engineering Undergraduate Program Committee (2005-2009), and as a member of the College of Engineering's McIvor Award Selection Committee (2007-2011).

Professor Solomon's teaching, research, and administrative service have equipped him well to carry out the duties of associate dean. On the recommendation of the deans of the Stephen M. Ross School of Business and the College of Engineering, we are pleased to recommend the appointment of Izak Duenyas as the Herrick Professor of Business, Stephen M. Ross School of Business, for a five-year renewable term, effective September 1, 2016 through August 31, 2021.

The Herrick Professorship in Manufacturing was created in 1994 by a generous gift from the Herrick Foundation of Troy, Michigan and formerly rotated between the Ross School and the College of Engineering. The gift agreement was amended to establish two separate professorships, one in each school. The professorship was renamed the Herrick Professor of Business in the Ross School in September 2012.

Professor Duenyas has been a member of the University of Michigan faculty since completing his Ph.D. degree in 1991. He began as an assistant professor in the College of Engineering, was promoted to associate professor, with tenure, in that college before joining the Stephen M. Ross School of Business in 1999, where he was promoted to professor in 2000. Professor Duenyas served as an associate dean from 2002-2006 and served as area chair of the technology and operations area from 2008-2014. Professor Duenyas served as the Ford Motor Company co-Director of the Joel D. Tauber Institute for Global Operations from 2014-2015. He is currently leading the Ross School Executive MBA Program as faculty director.

Professor Duenyas' research is focused on operations management problems that are of significant industrial relevance, particularly in developing analytical models of manufacturing systems that managers can use to develop insights into the main tradeoffs that they face. His particular strength, and what sets him apart, is his ability to interact with industrial sponsors, distill important problems from these interactions, and rigorously analyze them while

maintaining an allegiance to the problem, rather than focusing on analytical tractability as an end unto itself. His colleagues have described his research as superb, important, exceptional and path breaking.



Professor Finelli received her B.S.E. in electrical engineering from the University of Michigan in 1988. She remained at Michigan to receive her M.S.E. and Ph.D. degrees in electrical engineering (systems) in 1989 and 1993, respectively.

Following graduation, Professor Finelli was appointed as an assistant professor at Kettering University and promoted to associate professor, with tenure, in 1996. In 2000, Professor Finelli founded the Center for Excellence in Teaching and Learning (at Kettering), serving as the director until 2003. In 2003, she joined the University of Michigan as the coordinator of engineering education, CRLT and then as the managing director for CRLT North. Since 2007, Professor Finelli has served as the founding director of the Center for Research on Learning and Teaching in Engineering (CRLT-Engin, formerly CRLT North). Professor Finelli was also appointed in 2004 as an associate research scientist in engineering education. She was promoted to research associate professor in 2010. In 2015, she was appointed as a research associate professor in the School of Education. She was appointed as an associate professor of electrical engineering and computer science, with tenure, College of Engineering effective 2015.

Professor Finelli has a long history of research in engineering education, with a focus on questions of student learning in post-secondary engineering settings. Professor Finelli is known for her excellence in engineering education research and for her leadership of CRLT North, which is focused on developing teaching and learning opportunities on North Campus. Professor Finelli has served as the director of CRLT North, which she also founded, since 2007.

Professor Finelli actively engages in engineering education research. Her current funded research includes projects that study faculty motivation to adopt effective teaching practices, that change the culture of teaching and learning at the University of Michigan, and that explore ethical decision-making in undergraduate engineering students. She leads an international initiative to create a keyword outline for the field of engineering education research. Professor Finelli is the author or co-author on 27 peer-reviewed journal articles and 68 refereed conference papers. She has received a number of awards for her activities in engineering education, most notably her election to the Academy of Fellows by the American Society of Engineering Education (ASEE) in 2013.

Professor Finelli will enable the SOE to engage in collaborative research endeavors with the College of Engineering. In addition, Professor Finelli can support the work of the Center for Education Design, Evaluation, and Research (CEDER). Professor Finelli has already directed several College of Engineering requests for research on teaching and learning to CEDER. She may also be available to work with graduate students and, potentially, to teach courses.

We respectfully recommend the joint appointment of Cynthia J. Finelli as associate professor of education, without tenure, School of Education, effective September 1, 2016.







With the approval of the Executive Committee of the Department of Women's Studies, and with the endorsement of the Department of English Language and Literature, the College of Literature, Science, and the Arts, we are pleased to recommend the additional appointment of David P. David Gold received his Bachelor of Arts from Florida International University in 1994. Professor Gold specializes in rhetoric and writing studies, and has a particular interest in women's rhetorical practices and the voices of marginalized rhetors. His most recent work includes Educating the New Southern Woman: Speech, Writing, and Race at the Public Women's Colleges, 1884-1945 (co-edited with C. L. Hobbs, 2014) and Rhetoric at the Margins: Revising the History of Writing Instruction in American Colleges, 1873-1947 (2008) for which we received the 2010 Outstanding Book Award from the Conference on College Composition and Communication. His current work focuses on examinations of women's participation in the nineteenth-century elocution movement and the 1920s bobbed hair phenomenon. He is also working on a coedited collection, Women at Work: Rhetorics of Gender and Labor in the US. Professor Gold is a member of the Coalition of Women Scholars in the History of Rhetoric and Composition and a referee for *Peitho*, its professional journal.

Professor Gold regularly teaches courses at the undergraduate level in the history of women's rhetoric, including "Women's Rhetorical Traditions in 20th-Century America" (ENG 403), "Feminism, Rhetoric, and Identity in the Progressive Era" (ENG 415), and the upcoming "Dangerous Women" (ENG 319), which looks at a range of Progressive-era reform voices. Professor Gold seeks to go beyond simple narratives of adversity and triumph to better understand women's rhetorical practices in their rich historical contexts and to pay attention to issues that have both united and divided women, especially along lines of race and class. Professor Gold currently teaches a graduate course in rhetoric and writing studies for students in the Joint Ph.D. Program in English and Education, and would like to expand his offerings to include students in English and Women's Studies as well as in History and Women's Studies.

Opihari, M.D., the Ravitz Foundation Professor and Chair of Pediatrics and Communicable Diseases, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Rajen J. Mody, M.D. as the David G. Dickinson Collegiate Professor of Pediatrics, Medical School, effective September 1, 2016 through August 31, 2021.

The David G. Dickinson Collegiate Professorship in Pediatrics and Communicable Disease was established in October 1990 to recognize a senior faculty member in the Department of Pediatrics and Communicable Diseases who has furthered the care of children with special needs and who emulates Dr. Dickinson's personal and professional interests. The appointment period may be up to five years and may be renewed.

Rajen Mody received his M.D. degree from the N.H.L. Medical School in Ahmedabad, India in 1988. He completed an internship, residency and fellowship in India prior to completing a residency in pediatrics at the State University of New York. Dr. Mody completed a fellowship in pediatric hematology/oncology and was appointed as a lecturer at the University of Michigan in 2000. He was appointed as a clinical assistant professor in 2002, and was promoted to clinical associate professor in 2009.

Dr. Mody's area of research focuses on life-threatening cancers and clinical trials for the treatment of solid tumors such as advanced stage neuroblastomas. He identified the genetic hallmarks that contribute to the aggressive malignant potential of this cancer and demonstrated the potential for biologic therapies over traditional therapies. Dr. Mody began a career trajectory that has seen him assume the role of principal or co-investigator of over 90 active Phase I-III clinical trials supported by ten grants, including the Children's Oncology Group, the National Childhood Cancer Foundation and industry supported studies of novel therapies for childhood cancer. He has published 27 peer-reviewed articles in top-tier journals, including the *New England Journal of Medicine*, *JAMA* and *Blood*.

Dr. Mody serves as a valuable mentor to medical students, residents, fellows and junior faculty. He is the director of the Pediatric Phase I Program within the Division of Pediatric Hematology/Oncology, a member of the Faculty Advisory Group of the Child Health Research Node and a member of the Translational Oncology Program at the University of Michigan. Dr. Mody is a member of the editorial board for *Translational Pediatrics*, a faculty member of Global Reach, and serves on several committees for the Children's Oncology Group. He is an advisory board member of the Jiv Daya Foundation which strives to improve the outcome of children with cancer in India. Dr. Mody's service commitments are strong locally, regionally, nationally and internationally.

Dr. Mody is an important contributor to the Department of Pediatrics and Communicable Diseases, the university, and the field of pediatric clinical oncology. He is a fitting candidate for this professorship. I am, therefore, pleased to recommend the appointment of Rajen J. Mody, M.D. as the David G. On the recommendation of the dean and Executive Committee of the School of Public Health, and with the endorsement of the Medical School, we are pleased to recommend the joint appointment of David C. Musch as professor of epidemiology, without tenure, School of Public Health, effective June 1, 2016.

Professor Musch earned his B.S. degree from Calvin College in 1976. He received both his M.P.H. and Ph.D. degrees from the University of Michigan in 1978 and 1981, respectively. Professor Musch joined the faculty at the University of Michigan as a research investigator in the Department of Ophthalmology in 1981 and rose through the ranks to professor in 2003. He also has held a joint appointment as an associate research scientist in the Department of Epidemiology since 1991.

Professor Musch advises both clinicians and basic scientists about constructing research proposals, designing valid studies, and collecting outcome data. Once the data have been gathered, he is involved with data analysis and preparation of the study's results. His own research addresses treatment effectiveness, multicenter clinical trial coordination, variation in measurement and diagnostic abilities, and medical outcomes. From 1993 to 2004, Professor Musch directed the Coordinating Center for the NIH-funded Collaborative Initial Glaucoma Treatment Study, and since then has been funded by the National Eye Institute to gain insights from the data gathered on this study's participants. His multicenter clinical trial involvement and methodological expertise has led to teaching courses on clinical trial principles and methods in the US and internationally. He is currently involved on data and safety monitoring boards for clinical trials of proposed new treatments for glaucoma, tissue for corneal transplantation, neovascular and geographic forms of age-related macular degeneration, retinal vein occlusion, uveitis, macular telangiectasia type 2, telemedicine for retinopathy of prematurity, and gene therapy for Leber congenital amaurosis.

Through this joint appointment, Professor Musch will continue collaboration with epidemiology faculty on the Study of Women's Health Across the Nation (SWAN) to investigate hypotheses related to the impact that diabetes has on the cornea and the optic nerve (and thereby on the risk

of glaucoma in diabetics). A study to validate the specific vision test that was performed in the SWAN Study has been conducted and Professor Musch will continue to interact with Professors Harlow and Karvonen-Gutierrez and this study. He also continues work with Professors Adar and O'Neill on a "big data" study of the potential association of environmental exposure to five pollutants (PM10, PM2.5, NO₂, O₃, and SO₂) with signs of corneal toxicity obtained from claims data. This study is now in the active data access and continued planning stages.




With the approval of the 2016 Research Faculty Award Advisory Committee, I am pleased to recommend the establishment of the Don B. Chaffin Collegiate Research Professorship, UM Office of Research, effective August 1, 2016.

A new Collegiate Research Professorship is awarded each year to recognize exceptional scholarly achievement and impact on advancing knowledge in science, engineering, health, education, the arts, the humanities, or other academic field of study. The recipient will be a research professor with at least a 60% appointment who will be appointed to the professorship for five-year renewable terms. The recipient will be awarded a stipend of \$2,000 per year for the initial five-year term, provided by the UM Office of Research.

I am recommending that this year's Collegiate Research Professorship be named in honor of Professor Chaffin, who served the College of Engineering with distinction for more than 35 years, retiring in 2007. He joined the Industrial and Operations Engineering (IOE) faculty in 1969 and led a major expansion of the Center of Ergonomics. He served as IOE department chair from 1979 to 1981. Professor Chaffin was well known for his application of biomechanical modeling to understanding and preventing lower-back injuries, particularly those due to work in industry. He was among the first to use computational models of the human body to improve work design, and founded the Human Motion Simulation Laboratory in 1998 to harness the rapid expansion of 3D graphics capabilities in desktop computers. Professor Chaffin's legacy includes far safer workplaces, particularly in the auto industry, and a suite of computational tools for ergonomics that are used around the world. His former students are the leaders of the field of industrial ergonomics in both academia and industry. He was elected to the National Academy of Engineering in 1994 and served the department, college, and community in many leadership roles.

In recognition of Professor Chaffin's outstanding contributions, I am pleased to recommend the establishment of the Don B. Chaffin Collegiate Research Professorship, UM Office of Research, effective August 1, 2016.

Searle Professor and Chair of the Department of Internal Medicine, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the establishment of the Ivan Duff, M.D. Collegiate Professorship in Geriatric and Palliative Medicine, Medical School, effective June 1, 2016.

This professorship is being established through funds generated from the Fra Loomis-Taylor endowment, and departmental funds. The holder of this professorship will be a faculty member in the Department of Internal Medicine. The intent is to support the research and clinical efforts of a faculty member within the Division of Geriatric and Palliative Medicine. The appointment period may be up to five years and may be renewed.

Ivan Duff received his medical degree in 1940 and completed an internship and residency in internal medicine at the University of Michigan. Following service with the Navy during World War II, he returned to the University of Michigan as an instructor in internal medicine in 1946, and rose through the ranks to professor in 1960. He took part in several epidemiological investigations of rheumatic disease, and in 1964 began a lengthy association with the Atomic Bomb Casualty Commission, studying the occurrence of rheumatoid arthritis among the populations of Hiroshima and Nagasaki. His studies extended to research on rheumatic disease worldwide including Australia, China, Malaysia, Nepal, New Zealand and the Philippines.

Dr. Duff was the chief of the University of Michigan Arthritis Division and served as the director of the Regional Arthritis Control Program from 1969-1971. He directed the Pilot Geriatric Arthritis Center from 1974-1977, and established the Turner Geriatric Clinic which focuses on the special needs of the elderly. Dr. Duff was the director of the Turner Geriatric Clinic from 1977-1980. From 1980-1984, he was the acting chief of the new Division of Geriatric Medicine. In 1986, Dr. Duff was awarded emeritus status and continued to see patients until shortly before his death in 1994, at the age of 79.

This professorship will continue the legacy that Dr. Duff began with his 48 years of service. It will further geriatric research and be used to find ways to help the elderly live independently. I am pleased, therefore, to recommend the establishment of the Ivan Duff, M.D. Collegiate Professorship in Geriatric and Palliative Medicine, Medical School, effective June 1, 2016.

PROPOSED NAME: Hanes Walton, Jr. Collegiate Professorship in Political Science and Afroamerican and African Studies, College of Literature, Science, and the Arts

TERM: Five Years, Renewable

EFFECTIVE DATE: July 1, 2016

The College of Literature, Science, and the Arts seeks to name an existing unendowed collegiate professorship for Hanes Walton Jr., who was a faculty member at the University of Michigan from 1992 until his death in 2013.

This professorship was established through the Provost Office. A stipend funded from college resources will accompany this professorship.

Hanes Walton, Jr. was born September 25, 1941, in Augusta, Georgia. He received his Bachelor of Arts from Morehouse College in 1963, Master of Arts from Atlanta University in 1964, and he became the first person to graduate with a Ph.D. in government from Howard University in 1967. All of Hanes Walton's alma maters were historically black academic institutions, and he advocated for these and similar colleges for the remainder of his life.

Professor Walton began his instructional career as a teaching and research assistant at Howard University (1965-1967) and subsequently held faculty positions at Savannah State College (1967-1971, 1972-1993) and Atlanta University (1971-1972). He was named by the Callaway Foundation as the Fuller E. Callaway Professor at Savannah State College, an honor afforded to those with distinguished teaching abilities. He also served as a Congressional Fellow at the U.S. House of Representatives (1983-1984). He joined the faculty at Michigan as a professor in 1992 and was appointed as a research professor in the Center for Political Studies in 2001.

Professor Walton was a pioneer in the study of Black politics in America. Over the course of his nearly fifty years as a professor, he proved to be a prolific writer and a vigorous scholar, especially in the areas of African-American politics, presidential elections, and public policy. In 1972, he published a book entitled Black Politics: A Theoretical and Structural Analysis, which became the foundation of his career. In the years that followed, Professor Walton penned an additional twenty-four books, including seminal textbooks, as well as twenty-six book chapters, eighty-three articles, and fifty-five book reviews. Professor Walton also gave more than two dozen presentations at professional conferences and contributed several sections to encyclopedias. He played an active role as a reader and editorial board member of numerous professional journals, critiquing and selecting work by some of the nation's top scholars.

Throughout his career as an academic, Professor Walton exhibited incisive insight and blazed trails that codified black American political science as a field, leading many colleagues to endow him with the unofficial honorific, "Dean of Black Politics." Professor Walton was also active in professional organizations, serving as vice president of the American Political Science Association and cofounding the National Conference of Black Political Scientists.

Although Professor Walton's scholarly research left a remarkable legacy, it was his gifted teaching that his students most vividly remembered. In the classroom, he peppered his lectures with gripping anecdotes and witty jokes about American politicians and current events. His dedication to connecting with students at a personal level on the topics at hand prompted many undergraduate students in his courses to pursue degrees in political science and to become professors themselves.

Hanes Walton, Jr. enjoyed a long and prestigious career as a respected professor of political science. He died unexpectedly at his home in Ann Arbor on January 7, 2013, at the age of seventy-two. The UM Political Scientists of Color continue to honor Professor Walton's legacy by annually hosting the Dr. Hanes Walton Jr. Distinguished Speaker Lecture.

A distinguished faculty member will be nominated to receive this honor. The initial term of appointment will be for five years with the possibility of renewal.
