With the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Pierre A. Coulombe, Ph.D. as professor of cell and developmental biology, with tenure, and professor of dermatology, without tenure, effective August 1, 2017, and chair, Department of Cell and Developmental Biology, Medical School, effective August 1, 2017 through July 31, 2022.

Academic Degrees:

Dr. Coulombe received his Ph.D. in pharmacology from the Université de Montréal in 1987.

Professional Record:

Dr. Coulombe was a post-doctoral fellow in the Department of Anatomy at the Université de Montréal from 1987 to 1988. From 1988 to 1992, he completed a fellowship in the laboratory of Dr. Elaine V. Fuchs, Department of Molecular Genetics and Cell Biology, at the University of Chicago. He joined the faculty of Johns Hopkins University in 1992 as an assistant professor in the Department of Biological Chemistry in the School of Medicine. He was promoted to associate professor in 1998 and to professor in 2002. In 2008, he was appointed as the E.V. McCollum Professor and chair of the Department of Biochemistry and Molecular Biology at the Johns Hopkins Bloomberg School of Public Health.

Summary of Evaluation:

Dr. Coulombe's research focuses on the regulation of cell differentiation and tissue homeostasis in complex epithelia such as skin, which he studies from the perspective of keratin intermediate filament genes and proteins. Through this research it was discovered that keratins impact the survival, growth, and architecture of keratinocytes in skin epithelia, and that such contributions can be important during wound repair, in the lifelong growth cycle of hair follicles and in the context of cancer, psoriasis, and related diseases. He currently is assessing whether targeting select keratin expression could be beneficial in the setting of chronic diseases. Dr. Coulombe's international reputation is evidenced by his numerous invited presentations and extensive peer-reviewed activity, including several invitations to be the keynote speaker at the Gordon Research Conference. He has received numerous honors for his research, including election to the American Society for the Advancement of Sciences. Dr.

Coulombe has a strong track record of funding, and is currently the principal investigator of two NIH R01 grants, which have both been funded for over 20 years. He is also the principal investigator on a NIH/NCI T32 grant. He has over 140 peer-reviewed publications, one book, and holds one patent.

Dr. Coulombe has a strong commitment to teaching that is reflected in all aspects of his academic career. He is heavily involved in the mentoring of graduate students and post-doctoral fellows in the research laboratory, and many of his former trainees have gone on to successful careers in academia or at research institutes. Dr. Coulombe was the director of the Cellular and Molecular Medicine Ph.D. graduate training program from 2002-2008. Under his leadership, student enrollment increased and the program achieved success in recruiting and retaining students from underrepresented minority backgrounds. Since 2009, Dr. Coulombe has served as the co-director for the training program Fundamental Training in the Area of Cancer Biology at the Bloomberg School of Public Health. This program supports both Ph.D. students and post-doctoral fellows. The training grant has been renewed twice under Dr. Coulombe's leadership.

She is also knowledgeable about Freudian psychoanalysis and its uptake, affect and trauma theory, and feminist scholarship. Her first book, How to Read African American Literature, addresses post-civil rights era African American literature and, in particular, its persistent engagement with the history of American slavery, as well as the types of reading practices this historical fiction is understood to entail. Her article in the *South Atlantic Quarterly* (2013) entitled "'Black Rage' and 'Useless Pain: Affect, Ambivalence, and Identity after King,'" offers a reading of Andrea

Lee's 1984 novella, Sarah Phillips, as a means to assess Black U.S. political feeling in the quarter century after King's assassination, or, in her words, "the psychic dimensions of post-civil rights black representation." Professor Levy-Hussen is one of three editors of the collection, The Psychic Hold of Slavery: Legacies in American Expressive Culture. Work is well underway on her second book, The Black Contemporary.

Professor Levy-Hussen teaches courses on topics such as "Contemporary African American Literature," "Cultural Theories of the Subject," "Feminism and the Literary Imagination," "Interracial Literature," and "Literature After Identity." She was awarded a teaching excellence award by her department, and she is highly sought as a dissertation committee member having served on thirteen committees in six years. Her service record is excellent and includes serving as book review editor and as a member of the editorial board for the journal *Contemporary Literature*. Among her many departmental service roles, she chaired an ad hoc committee on under-represented students.







Lantos (CA) for his long-term service as a member of the board of directors of the William Davidson Institute. Congressman Lantos has greatly assisted the William Davidson Institute with his experience and guidance, and has influenced the Institute's mission with his passionate concern about issues in developing countries. Candidates for this professorship shall be engaged in the study of emerging and transitional market economies. It is the donor's preference that the incumbent generally be the faculty member acting as executive director of the William Davidson Institute at the University of Michigan. Appointments to this professorship may be up to five years and may be renewed.

Professor Clyde received his B.S. in business finance from Indiana University in 1985 and his M.A. and Ph.D. in economics from the University of California, Los Angeles in 1986 and 1990 respectively. He has conducted research on markets in emerging economies and organizational economics. He has published his work in a number of journals including the *Journal of Finance*, *Managerial and Decision Economics* and *Economic Inquiry*.

Professor Clyde's recent work has focused on health care delivery to the poor in emerging markets. Over the past fifteen years, he has advised or run 70 health-care projects in twelve different low or middle-income countries. He has worked with faculty from the Medical School, School of Nursing and Law School in developing a financially self-sustainable health care business model that serves the poor. He has also worked on collaborations with numerous institutions on the development of business education programs in Russia, Ukraine and Kazakhstan and projects with state-owned and private firms in India, Singapore and Romania.

In his work, Professor Clyde also has engaged with corporations ranging in size from small biotech startups to large corporations such as Johnson & Johnson, Novo Nordisk and DTE Energy, on

projects involving a wide range of issues in organizational economics and strategy. They have included supply chain management projects, privatization projects, market entry strategies, and business plans for entrepreneurial ventures, in more than twenty countries around the world.



Sweetland Professor of International Economics, College of Literature, Science, and the Arts, effective September 1, 2017 through August 31, 2022.

The John W. Sweetland Professorship in International Economics in the College of Literature, Science, and the Arts and the Horace H. Rackham School of Graduate Studies was established in May 1996 by a gift from John W. and Gayle Morris Sweetland and J. Ira Harris. The gift reflects the Sweetlands' commitment to education and their belief that an international perspective will be critical to a better understanding of the world's economies. The individual holding this appointment will teach at both the undergraduate and graduate levels. Appointments to this professorship may be up to five years and may be renewed.

Professor Deardorff is a vital contributor to the research, teaching, and service missions of his department and of the college. He is a world-renowned expert in international trade. His research has addressed multiple topics using a wide variety of methodologies. Professor Deardorff continues to make contributions to the theoretical foundations of international trade. He is particularly known for theoretical results giving conditions where standard theorems of international trade hold (or not) when there are multiple factors of production or multiple goods traded. He has devoted considerable attention in recent years to expanding his online Glossary of International Economics, which benefits the broader public by increasing economic literacy about this important field. Professor Deardorff has always been a productive scholar. His high rate of productivity has continued during his current five-year term as the Sweetland Professor. He published four articles in scholarly journals and made contributions to edited volumes and similar venues. His published work has a wide scope and ranges from traditional topics in international trade to political science. His recent research has appeared mainly in specialized



journals. His ranking among the top 5% of authors in the field of economics is evidence of the authoritative stature of Professor Deardorff's work.

Professor Deardorff is one of the most productive teachers in the department. His favorite teaching assignment is Economics 340, a large-section course on international economics. It provides students with an accessible overview of this important topic. He regularly teaches in the international trade sequence in the Economics Ph.D. program. He has served on committees for 13 economics doctoral students who have defended their dissertations in the last five years. He was chair or co-chair of five committees.

Professor Deardorff is also a consummate citizen in his department and to the wider community. He is active in the editorial process and sits on the board of editors of six international economics journals. He serves as a formal and informal mentor to several junior faculty in his department. He has served on an array of the departmental committees. Professor Deardorff has a joint appointment in the Ford School and served as an associate dean from 2007 to 2015. He was president of the Midwest Economics Association from 2015 to 2016, and remains active in that organization.


was promoted to associate professor, with tenure, in 2007. In 2012, Professor D'Silva was promoted to professor of dentistry.





On the recommendation of the dean and Executive Committee of the Stephen M. Ross School of Business, we are pleased to recommend the reappointment of Fred M. Feinberg as the Joseph Handleman Professor, Stephen M. Ross School of Business, for a five-year renewable term, effective September 1, 2017 through August 31, 2022.

The Handleman Professorship was established by the Regents in October 2008 upon a generous gift from the Joseph and Sally Handleman Charitable Foundation to support the research and/or teaching of the appointed incumbent relating to marketing innovations. Joseph Handleman was born August 5, 1905 and was the son of late Philip Handleman, founder of the Handleman Company which is currently based in Troy, Michigan. Joseph was an internationally known sales consultant and business manager. He established himself as a business pioneer in the distribution of health and beauty products to supermarkets. Today the Handleman Company remains an industry leader. Joseph was married to Sally Handleman for 69 years. Joseph died on February 28, 2005 followed by his wife Sally on December 6, 2006. The Handlemans are survived by their three daughters and many grandchildren and great-grandchildren. Appointments to this professorship may be up to five years and may be renewed.

Fred M. Feinberg received his S.D. degree in 1983 and his Ph.D. in 1989 from the Massachusetts Institute of Technology. He joined the Ross School in 1998 after spending his first four years at Duke (1989-1993) and his next five at the University of Toronto. He was tenured at Toronto but gave that up to join us here. He has been a professor, with tenure, since 2007.

Professor Feinberg's research focuses primarily on how people make choices in uncertain environments. He also works in mathematical psychology, Bayesian econometrics, and dynamic programming, as well as models of advertising and consumer variety-seeking. Specifically, he uses statistical models to explain complex decision patterns, particularly among related items (e.g., brands in the same category) in "Big Data" applications. For example, he has worked on algorithms to allow Bayesian inference on very large data sets; on the formulation of dyadic utility theory; and on characterizations of optimal search in uncertain environments. In terms of



applications, his work usually involves large-scale (marketing-based) choice data, for example, click-throughs on web sites; or reactions to “menus” of options; dating site data; geographic / spatial modeling; and discrete survey responses.


Professor Feinberg currently is the president-elect at the INFORMS Society for Marketing Science. He also serves as a senior editor at *Marketing Science* and an associate editor at the *Journal of Marketing Research*. In 2011, he was awarded the Ross School of Business CORE award, an award given to an outstanding scholar for their Contribution to the Research Environment. Since 2013, Professor Feinberg also holds an appointment in the Department of Statistics at the University of Michigan.





His current research activities focus on corporate governance and the interplay between the firm's three main governing bodies; the board of directors, the CEO office, and employees. He studies







In addition, he has contributed several critical translations from the Yiddish, which have served to expand the Yiddish literary canon.

Professor Levinson's current project, "Israelites Among Us: Imagining Jews in Protestant America," explores the ways in which the image of the Jew has been constructed by Protestant literature and texts in America. He argues that Protestant literature has endowed Jews with a unique spiritual power, linking them to the Israelites of the Bible and the prophetic tradition. Professor Levinson's research traces the implications of this image through a range of modern cultural works, including poems, novels, short stories, and film.

Professor Levinson is a gifted teacher at all levels of the curriculum. His "Introduction to Jewish Civilization" is one of the core courses for the Judaic studies major. He has developed new courses on the Book of Genesis and other aspects of American Jewish literature, which are popular among undergraduate students. He also serves as the graduate student advisor for Judaic studies and regularly teaches the core methods course for the Judaic studies graduate students and the capstone course. Finally, Professor Levinson has served admirably on the Executive Committee of the Frankel Center for Judaic Studies. 





Professor Spreitzer has been honored by numerous accolades, including most recently her election as a fellow of the Academy of Management (in 2015), her 2012 Academy of Management





He is collaborating with former fellows at the University of Jena, Germany currently overseeing the use of monoclonal antibodies they developed for use in phase II-b clinical trials in septic humans.

Dr. Ward has published an impressive 693 peer-reviewed articles, and holds six patents. He received an honorary lifetime membership in the Society of Leukocyte Biology in recognition of his contributions to the knowledge of leukocyte biology. He continues to be funded by the NIH for his research, and is very active in journal review.



The Lynn and Ruth Townsend Professorship in Communication Disorders was established in August 1995 through a generous gift from Lynn and Ruth Townsend, as well as contributions from the James and Lynelle Holden Fund, the National Organization for Hearing Research, and other funding efforts. Gabriel Corfas received his Ph.D. degree in neurobiology from the Weizmann Institute of Science, in Rehovot, Israel in 1990. He completed a fellowship at Washington University and a research fellowship in neurobiology at Harvard University. He was appointed as an instructor at that institution in 1995 and rose through the ranks to professor in 2008. Dr. Corfas joined the faculty at the University of Michigan in 2014 as a professor in the Department of Otolaryngology. He was also appointed as the associate chair for research, and as the director of the Kresge Hearing Research Institute.

Dr. Corfas' research focuses on the biological roles of several trophic factors, including the neuregulins, the neurotrophins neurotrophin 3 and brain-derived neurotrophic factor, and glial-derived neurotrophic factor family, as well as all their cognate receptor tyrosine kinases. Using a combination of tissue culture and animal studies, he has been able to determine the pivotal roles that glial cells play in the function and health of the nervous system and the importance of those signaling pathways in these processes. His work in the inner ear has provided important insights into the mechanisms of deafness and vestibular dysfunction, and has led to the development of potential new therapeutic avenues for hearing loss. He is well-funded through the NIH and



institutional grants. Dr. Corfas has published more than 70 peer-reviewed articles, and has been an invited speaker and visiting professor at numerous top universities and research institutions.

Dr. Corfas is a highly accomplished and internationally recognized neuroscientist with an extensive background and scholarly accomplishments in hearing and balance research which makes him the ideal candidate for appointment to this prestigious professorship. 




Professor Fischer received his B.S. degree in psychology in 1983 and his M.S.W. degree in 1984 from the University of Michigan.

Since 2001, he has served as the associate chair of the Department of Cariology, Restorative Sciences and Endodontics in the School of Dentistry where he is responsible for the restorative dentistry components of the pre-doctoral education program involving over sixty courses. He is the lead dental school faculty member in the Interprofessional Education program at the University of Michigan. He has been involved in creating interprofessional education and interprofessional care opportunities for students in community health centers, creating interprofessional opportunities for students in campus-based



With the endorsement of the Executive Committee of the School of Nursing, we are pleased to recommend the appointment of Christopher R. Friese as the Elizabeth Tone Hosmer Professor of Nursing, School of Nursing, for a five-year renewable term, effective September 1, 2017 through August 31, 2022.

Elizabeth Tone Hosmer Professorship in Nursing was established in February 2016 from a generous gift of \$1,500,000. This professorship shall be used to promote, through teaching and research, a strong leadership position in the planning and policy processes of health care systems. This professorship will focus on assisting and encouraging nurses, as well-trained professionals, to put themselves forward as equal participants in the planning and policy processes, and to serve as forceful advocates for the rights and interests of patients in all aspects of the delivery of health care. It is desired that nurses, particularly those at the master's and doctoral levels, advocate ethics as they pertain to patient rights, to balance the economic and scientific perspectives presently dominating decision making processes. Appointments to this professorship may be up to five years and may be renewed.

Professor Friese received his Bachelor of Science in nursing with a minor in healthcare management, and his Master of Science in nursing degrees from the University of Pennsylvania in 1997 and 2001, respectively. He was a pre-doctoral fellow at the Center for Health Outcomes and Policy Research at the University of Pennsylvania from 2000-2005, and he received his Doctor of Philosophy in nursing degree from the same institution in 2005. Professor Friese is a registered nurse (RN) and an Advanced Oncology Certified Nurse (AOCN®).

Professor Friese's first academic appointment was as a post-doctoral research fellow at the Center for Outcomes and Policy Research at Harvard University from 2005-2008. In 2008, he was appointed as an assistant research scientist at the University of Michigan (UM) School of



Nursing. He was later appointed as an assistant professor in 2009. He was promoted to professor, with tenure, in September 2016.

Professor Friese is an outstanding researcher and is nationally recognized for his contributions to cancer research related to the measurement and improved quality of care for patients with cancer. His research is yielding an important body of work that is systematically informing science. He has been consistently funded by NIH grants since arriving at UM and is currently the PI of an active NIOSH R01 and serves as a mentor for an AHRQ funded K09 award, and has several grant applications under review. His research has been published in *Medical Care*, *Cancer*, *Health Services Research*, *Nursing Research*, and has been presented at national and international meetings. He has taught a number of undergraduate and graduate courses with excellent student evaluations, as well as lectures widely on evidence-based oncology nursing practice, nursing workforce, and health care policy. He frequently guest lectures in the graduate program on health services and quality of care research, as well as symptom and side effect management for patients with cancer. Professor Friese is also a faculty advisor to the School of Nursing Undergraduate Honors Program, as well as the doctoral-level nursing systems interest group. He currently advises six PhD students. Professor Friese has integrated and balanced his teaching, service and scholarly interests. He is an admirable citizen and leader in the School of Nursing, UM, the nursing profession and the community at large.

The Anthony C. Lembke Department Chair in Chemical Engineering was established by the Regents in March 2016 and is funded by gifts from Anthony C. Lembke (B.S. CHE 1980).

Professor Glotzer received her B.S. (cum laude) in physics from the University of California, Los Angeles in 1987. She received her Ph.D. in physics from the Boston University in 1993. Following graduation, Professor Glotzer spent eight years at NIST where she was a co-founder and director of the NIST Center for Theoretical and Computational Materials Science. She joined the University of Michigan faculty as an associate professor, with tenure, in 2001. She was promoted to professor in 2005.

Professor Glotzer's research on computational assembly science and engineering aims toward predictive materials design of colloidal and soft matter, and is sponsored by the NSF, DOE, DOD, Simons Foundation and Toyota Research Institute. Among other notable findings, Professor Glotzer invented the idea of "patchy particles," a conceptual approach to nanoparticle design. She showed that entropy can assemble shapes into many structures, which has implications for materials science, thermodynamics, mathematics, and nanotechnology. Her group's "shape space diagram" shows how matter self-organizes based on the shapes of the


constituent elements, making it possible to predict what kind of material – glass, crystal, liquid crystal, plastic crystal, or quasicrystal – will emerge.

Professor Glotzer runs a large computational research group of 35 students, post-doctoral fellows, and research staff, and has published over 220 refereed papers and presented over 330 plenary, keynote and invited talks around the world. She has provided leadership and input on roadmapping for federal granting agencies on many research topics, including simulation-based engineering and science, and three of her reports are among the first six references cited by the Materials Genome Initiative. She serves on several boards and advisory committees of the National Science Foundation, the Department of Energy, and the National Academies, and is currently a member of the Scientific Policy Committee at the Stanford Linear Accelerator (SLAC) National Accelerator Laboratory and the National Academies Board on Chemical Sciences and Technology. She is a Simons Investigator, a former National Security Science and Engineering faculty fellow, and the recipient of numerous other awards and honors, including the 2016 Alpha Chi Sigma Award from the American Institute of Chemical Engineers, the 2014 MRS Medal from the Materials Research Society and the 2008 Charles M.A. Stine Award from the American Institute of Chemical Engineers.

Professor Glotzer's academic achievements fully merit her appointment to this endowed department chair. We are pleased to recommend the appointment of Sharon C. Glotzer as the Anthony C. Lembke Department Chair of Chemical Engineering, Department of Chemical Engineering, College of Engineering, effective July 1, 2017 through June 30, 2022.

Marvin Pollard Professor and Chair of the Department of Molecular and Integrative Physiology, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Scott D. Dr. Pletcher was promoted to an associate professor at that institution, and was recruited to the University of Michigan in 2009 as an associate professor in the Department of Molecular and Integrative Physiology, and as a research associate professor in the Institute of Gerontology. He was promoted to a professor and research professor, respectively, in 2014.

Dr. Pletcher is considered among the world leaders in the field of biogerontology research, and is currently serving as a co-principal investigator and associate director of the Paul F. Glenn Center for the Biology of Aging at the University of Michigan. He is the principal investigator of three NIH R01 grants that address sensory modulation of aging in *Drosophila* and modulation of lifespan through mechanisms of hunger and satiety. Dr. Pletcher has published more than 70 peer-reviewed articles, many in high profile journals including *PNAS*, *Science* and *PLoS Genetics*. He has received numerous honors, including being named as an Ellison Medical Foundation New Scholar, a Senior Scholar in Aging, and being inducted into both the League of Research Excellence and the League of Educational Excellence at the University of Michigan.

Dr. Pletcher has developed several analytical computer software tools, including DTrack, DLife, and FLIC that are widely used to track individual fly behavior, lifespan and food encounters. He was the director of Ph.D. graduate studies from 2011-2014, and is the principal investigator of an NIH T32 Biology of Aging grant.

Dr. Pletcher is an outstanding teacher and mentor, an innovative researcher, and productive investigator. He will continue the legacy of Dr. Howell as he continues making significant contributions to the field of physiology. I am, therefore, pleased to recommend the appointment of Scott D. 

Dr. Schnell is an internationally renowned computational physiologist and serves as the president of the Society for Mathematical Biology. His research focuses on combining chemical kinetics, protein informatics, biochemical measurements and computational modeling to investigate enzyme catalyzed and protein aggregation reaction mechanisms under physiological conditions. Dr. Schnell has published 75 peer-reviewed articles, and has a mathematical equation named after him. He serves as a co-director of a Ph.D. Systems Biology NIH training grant, and oversees an NIH supported undergraduate summer research program. Dr. Schnell is an essential collaborator on multiple NIH research grants held by University of Michigan faculty. He is the faculty research lead for the Office for Health Equity and Inclusion, and in 2016 was selected as a fellow of the American Association for the Advancement of Science.



Dr. Schnell is the consummate mentor, teacher, investigator, and collaborator. His research in the field of mathematical biology mirrors Dr. Jacquez, who was also the president of the Society for Mathematical Biology. I am, therefore, pleased to recommend the appointment of Santiago D. Schnell, D.Phil. as the John A. Jacquez Collegiate Professor of Physiology, Medical School, effective June 1, 2017 through August 31, 2021.





The College of Literature, Science, and the Arts is pleased to recommend the renaming an existing unendowed collegiate professorship from the Richard D. Brauer Collegiate Professorship in Mathematics to the Sally L. Allen Collegiate Professorship in Ecology and Evolutionary Biology and Molecular, Cellular, and Developmental Biology, College of Literature, Science, and the Arts, effective June 1, 2017.

This professorship was established through the Provost Office and named as its current title in September 2011 as the Richard D. Brauer Collegiate Professorship in Mathematics. A stipend funded from college resources will accompany this professorship. Appointments to this professorship may be up to five years and may be renewed.

Sally L. Allen was born on August 3, 1926 in New York City to Alexander Victor and Dorothy Lois Lyman. She attended Vassar College where she received her Bachelor of Arts in 1946. She completed her Ph.D. at the University of Chicago in 1953. At Chicago, she investigated mouse genetics with two of the most famous geneticists of the twentieth century, Sewall Wright and George Snell, who later received a Nobel Prize for the work on which she participated. Professor Allen was appointed as a research assistant in the Department of Zoology (1953-1973), where she focused her research on single celled ciliates. She was appointed as an associate professor of botany, with tenure, in 1967 and was promoted to professor in 1971. She also served as the chair of the Department of Biology (1975-1977) and as an associate dean of the College of Literature, Science, and the Arts (1988-1991). She retired from the University of Michigan in 1998.

For most of her career, Professor Allen's research focused on the genetics and evolution of the ciliated protozoa, an unusual group of organisms with a bizarre life cycle that have produced many fundamental insights into the functioning of all organisms. She was recognized as a national and international leader in this field, maintaining a laboratory in which many Ph.D. Candidates were nurtured. Professor Allen was the author of Instructor's Resource Manual for

Modern Genetic Analysis (W. H. Freeman and Company, 1999) and co-author of Instructor's Resource Manual for an Introduction to Genetic Analysis (with E. Harrison, 2000). For many years, she also served as the editor of *Genetics*, the field's premier scientific journal. She was also a member of the editorial boards for the *Journal of Protozoology* (1974-1978) and *Developmental Genetics* (1990-1992).

Professor Allen was a fellow of the American Association for the Advancement of Science and member of the American Institute of Biological Science, Genetics Society of America, Society Protozoologists, American Naturalists Society (vice president 1978), American Society for Cell Biology (member council 1973-1975), Phi Beta Kappa, and Sigma Xi. She was also an honorary member of the Golden Key National Honors Society.

Professor Allen's classroom activities centered on the large junior-senior majors course in genetics. She worked long and hard to make improvements in this course and to have it keep pace with the revolutionary advances in this field. Her devotion to the honors course in genetics was much appreciated by her many students over the years.

Sally L. Allen, Ann Arbor, Michigan, died November 13, 2012 at age 86 following a brief illness.



The College of Literature, Science, and the Arts is pleased to recommend the renaming of an existing unendowed collegiate professorship from the Moses Gomberg Collegiate Professorship in Chemistry to the Elizabeth L. Eisenstein Collegiate Professorship in History and Germanic Languages and Literatures, College of Literature, Science, and the Arts, effective June 1, 2017.

This professorship was established through the Provost Office and was originally named the Moses Gomberg Collegiate Professorship in Chemistry in March 1999. Elizabeth L. Eisenstein, who was a faculty member at the University of Michigan from 1975 until her retirement in 1988. A stipend funded from college resources will accompany this professorship. Appointments to this professorship may be up to five years and may be renewed.

A native of New York City, Elizabeth Eisenstein received her Bachelor of Arts from Vassar College in 1944. She attended Radcliffe College and completed her Master of Arts in 1947 and her Doctorate in 1953. Professor Eisenstein taught history part-time at the American University in Washington, D.C. from 1959 to 1974. She joined the faculty at the University of Michigan as the Alice Freeman Palmer Professor of History in 1975. Professor Eisenstein was the second person to hold the chair, succeeding Professor Sylvia Thrupp on her retirement. Her contributions to teaching and to the intellectual life of the Department of History were exemplary.

Professor Eisenstein was widely recognized as an expert on the history of the French Revolution. Her dissertation was published in 1959 as The First Professional Revolutionist: F.M. Buonarroti; a study that established her as a significant American historian of the French Revolution. Her articles on the social origins of the French Revolution are much cited, and they continue to hold a significant place in current scholarship. In 1979, Professor Eisenstein won the Ralph Waldo Emerson Prize of Phi Beta Kappa for her two-volume masterwork, The Printing Press as an Agent of Change. Republished in many languages in Europe and Asia, and the subject of many subsequent symposia and essay collections, its carefully researched arguments about how



printing shaped the Renaissance, the Reformation, and the Scientific Revolution are now staples of the scholarly literature. She received awards from the Guggenheim Foundation, the National Endowment for the Humanities, and the Rockefeller Foundation. In 1981, she was elected as a fellow of the American Academy of Arts and Sciences. In 2002, she received the American Historical Association's Award for Scholarly Distinction. In 2004, the University of Michigan awarded her the honorary degree, Doctor of Humane Letters.

Elizabeth L. Eisenstein died in January 2016 at the age of 92.

With the approval of the 2017 Research Faculty Award Advisory Committee, I am pleased to recommend the establishment of the Rensis Likert Collegiate Research Professorship, UM Office of Research, effective August 1, 2017.

A new collegiate research professorship is awarded each year to recognize exceptional scholarly achievement and impact on advancing knowledge in science, engineering, health, education, the arts, the humanities, or other academic field of study. The recipient will be a research professor with at least a 60% appointment who will be appointed to the professorship for five-year renewable terms. The recipient will be awarded a stipend of \$2,000 per year for the initial five-year term, provided by the UM Office of Research.

I am recommending that this year's collegiate research professorship be named in honor of Professor Likert, who helped found UM's Institute for Social Research in 1949 and served as its director until his retirement in 1970. A graduate of UM (A.B., 1922), Professor Likert earned a Ph.D. in psychology at Columbia University and worked at New York University and the Life Insurance Agency Management Association before returning to UM in 1946.

Early in his career, Professor Likert sought more effective and systematic means of studying human attitudes and the factors that influence them. His research led him to develop a scale for attitude measurement, now known as the Likert Scale, that offers a means of determining attitudes along a continuum of choices, such as "strongly agree," "agree," and "strongly disagree." A numerical value is assigned to each category. He also devised more formal and better-structured interviewing techniques that have since become standard survey research practices.

In recognition of Professor Likert's outstanding contributions as an educator, researcher, and leader of what has become the world's foremost academic social research organization, I am pleased to recommend the establishment of the Rensis Likert Collegiate Research Professorship, UM Office of Research, effective August 1, 2017.

On the recommendation of the University of Michigan-Dearborn Helen Mataya Graves Collegiate Professor Selection Committee and the provost and vice chancellor for Academic Affairs, I am pleased to recommend the appointment of Suzanne L. Bergeron as the Helen Mataya Graves Collegiate Professor, College of Arts, Sciences, and Letters, for a five-year renewable term, effective September 1, 2017 through August 31, 2022.

The Helen Mataya Graves Collegiate Professorship was established by the Regents in April 2017. Helen Mataya Graves was a political scientist, a lifelong activist for women's rights and social justice, and a professor who was devoted to her students' success. In 2005, her work focused on assumptions about gender and sexual norms in economic theory, published in the journal *Frontiers*, an edited collection on *Sexual Rights and Global Governance*, *International Feminist Journal of Politics* and the collection *Feminist Economics and the World Bank*. Professor Bergeron is a leading scholar on the complexities of the "business case" model in development.

Professor Bergeron's campus contributions include development of the Women's and Gender Studies (WGST) program, creation of the WGST major, founding director of the Women in Learning and Leadership (WILL), LGBTQ Task Force member, creation of a LGBTQ coordinator position, co-chair of the General Education Task Force which created the Dearborn Discovery Curriculum, Experiential Education Task Force member, CASL Strategic Planning group lead member, and steering committee member of the Institute for Research on Women and Gender in Ann Arbor.

I am pleased to recommend the appointment of Suzanne L. Bergeron as the Helen Mataya Graves Collegiate Professor, College of Arts, Sciences, and Letters, for a five-year renewable term, effective September 1, 2017 through August 31, 2022.




