On the recommendation of Michael W. Mulholland, M.D., Ph.D., the Frederick A. Collier Distinguished Professor and Chair of the Department of Surgery, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Mark R. Hemmila, M.D. as associate professor of surgery, with tenure, Medical School, effective July 1, 2010.

Dr. Hemmila received the M.D. degree from the University of Michigan in 1994. He completed his general surgery training also at this institution, followed by a fellowship in surgical critical care and extracorporeal membrane oxygenation (ECMO) during 1998-1999 and a fellowship in trauma and burn surgery during 2001-2002. In 2002, Dr. Hemmila joined the faculty at the University of Michigan as a clinical assistant professor of surgery and was promoted to his current rank of clinical associate professor of surgery in 2009.

Dr. Hemmila's current research interests include outcomes in trauma, burn, and general surgery, mechanisms of burn-induced cardiac dysfunction, pathophysiology and treatment of bacterial pneumonia, and ECMO to treat respiratory failure. His research is supported by a K08 grant jointly sponsored by the National Institute of General Medical Studies and the American College of Surgeons/American Association for the Surgery of Trauma. His interests have transitioned from the basic sciences to clinically related research focused on trauma quality improvement. Dr. Hemmila is the principal investigator on a Blue Cross Blue Shield of Michigan Foundation grant focused on trauma quality improvement, and he also is co-investigator on a grant from the National Institute of Health Agency for Healthcare Research and Quality. His bibliography reflects 54 peer-reviewed articles, published or in press, with two additional manuscripts accepted for publication. He also has contributed to eight chapters in books and has more than 60 abstracts. Dr. Hemmila has been an invited speaker at national surgical meetings and continuing medical education courses.

Dr. Hemmila's teaching activities are primarily in association with his clinical responsibilities. In this setting, he has taught third- and fourth-year medical students within the trauma and burn surgery clerkship. He also has provided lectures to general surgery and trauma/burn surgery residents. He has taught second-year medical students in the small group component of the pulmonary sequence, in the laparoscopic skills laboratory, and the extracorporeal life support (ECLS) course. Dr. Hemmila has mentored several trainees in basic science or clinical research in trauma and burn surgery, as well as fellows in trauma/burn or acute care surgery. As evidence of his mentoring skills, several of Dr. Hemmila's trainees have received awards and scholarships from foundations and professional organizations.

External Review (Brief excerpts from external reviewers are provided below):

Reviewer A: "Perhaps his greatest contribution to the trauma community has been his work in developing the TQIP program. This program, which has been supported by the American College of Surgeons Committee on Trauma, is critical to the future of quality improvement and benchmarking among trauma centers. This work has led to several important publications and has achieved considerable national recognition."

Reviewer B: "He is a perceptive and clear thinker. His understanding of the broad area of trauma, burns and critical care is quite simply impressive. Additionally, his ability to move laterally within the field as represented by his work with Blue Cross Blue Shield of Michigan Foundation in the area of trauma quality improvement programs is a further comment on his capacity to think broadly."

Reviewer C: "His clinical skills and productivity have also been recognized by other institutions as evidenced by the many invitations he has had to speak at surgical symposia and the number of papers that he has presented at regional meetings, particularly the Central Surgical Association which is the main surgical association of the Midwest."


Reviewer D: “The use of nanotechnology in all of medicine is a burgeoning field and Dr. Hemmila is certainly at the forefront of those investigations in trauma/burn/critical care patients. . . . Dr. Hemmila was the primary author on one of the leading references in the field of ECMO for severe adult respiratory distress syndrome. Those efforts, along with his efforts in better recognition and treatment of pneumonia in injured and ill patients, have been major advances.”

Reviewer E: “Mark has made considerable contribution in both basic science as well as clinical care. His work in quality and development of the Trauma Quality Improvement Project (TQIP) has truly been seminal work. We have adopted his methods at [this institution]. . . . Through my leadership role in all the trauma organizations, I am quite aware of Mark’s cohort. He clearly ranks among the top of the group in his accomplishments.”


Dr. Hemmila has a significant service record, both institutionally and nationally. His clinical specialty is burn surgery. He is board certified in surgery and surgery critical care and is an attending physician on the acute care surgery service, with follow-up clinical care in the Taubman Health Care Center. Since 2007, he has been director of the Trauma/Burn Research Laboratory at the University of Michigan. Administratively, he serves on the quality of care committees for the trauma and burn services and is chair of the trauma resuscitation committee in the Department of Surgery. Regionally, he is a member of the data oversight committee for the State of Michigan Trauma Registry. Nationally, Dr. Hemmila is an ad hoc reviewer for several prominent specialty journals including the *Journal of Burn Care and Research; Surgery*; and the *Journal of Trauma, Injury, Infection and Critical Care*.



On the recommendation of the School of Music, Theatre & Dance Executive Committee, I am pleased to recommend the appointment of Priscilla Lindsay as associate professor of theatre and drama, with tenure, effective September 1, 2010, and chair, Department of Theatre and Drama, School of Music, Theatre & Dance, for a five-year term, effective September 1, 2010 through June 30, 2015.

ACADEMIC DEGREES

Ms. Lindsay attended the University of Michigan as a professional theatre program fellow receiving a B.A. and M.A.

PROFESSIONAL RECORD

Following her formal training, Ms. Lindsay performed professionally at the Alley Theatre in Houston, Texas and elsewhere. Subsequently, she was appointed as an associate professor at the University of Missouri-Kansas City, as well as a member of the Missouri Repertory Theatre in Kansas City. Since 1999, Ms. Lindsay has been the associate artistic director at the Indiana Repertory Theatre (IRT). In addition to the duties of acting and artistic planning with this engagement, she teaches and directs the IRT's Summer Conservatory for Youth Program.

SUMMARY OF EVALUATION

The appointment of Ms. Lindsay would make a critical contribution to the intellectual diversity of leadership in the School and U-M theatre program. Ms. Lindsay has developed a wealth of professional/training connections in several theatrical disciplines that would make a very strong contribution to the department. She combines classical training with extensive experience in the commercial realm of her profession. She is ideally suited to illuminate approaches to current and future issues in the field and to broaden and deepen the intellectual diversity of the department.

Ms. Lindsay has an outstanding professional profile, particularly with regard to acting for the theatre and directing. These talents were confirmed last fall when she was invited as a guest director of *Tartuffe* at the School of Music, Theatre & Dance, a major success on all counts. She is well known for her professional voice with commercial marketing, and working with professionals at every level in the theatre and theatrical administration. Her combination of substance and stature are rare in this field, and we are fortunate that she would consider such a move at this time in her career.



SUMMARY OF RECOMMENDATION



On the recommendation of the Promotion and Tenure Committee, and with the approval of the Executive Committee of the Taubman College of Architecture and Urban Planning, I am pleased to recommend the appointment of John McMorrough as associate professor of architecture, with tenure, A. Alfred Taubman College of Architecture and Urban Planning, effective September 1, 2010

Academic Degrees:

Professor McMorrough received a Bachelor of Architecture from the University of Kansas, School of Architecture and Urban Design (1992), and a post-professional Master of Architecture with Distinction (1998) and PhD in architectural history (2007) from the Harvard Graduate School of Design.

Professional Record:

Since 2009, Professor McMorrough has been an associate professor of architecture and an assistant professor of architecture (2005-2009) at the Austin E. Knowlton School of Architecture, Ohio State University. Prior to that time he taught at Northeastern University, Harvard's Graduate School of Design, the Massachusetts Institute of Technology, Yale University, and the University of Applied Arts in Vienna. In addition, he has held professional positions in a number of architectural firms, including the Office of Metropolitan Architecture (OMA/AMO) with Rem Koolhaas in Rotterdam (1999-2002); Rothman Partners in Boston (1996-1998); Oaklander, Coogan & Vitto Architects, New York (1994-1996); and Ellerbe Becket in Kansas City (1992-1994). He is principal of studioAPT (Columbus, Ohio, since 2000). Professor McMorrough is a registered architect in the State of New York and a member of the Society of Architectural Historians.

Summary of Evaluation:

Teaching: As architecture section head at OSU, Professor McMorrough coordinates graduate program studios and teaches history/theory seminars. Professor McMorrough receives consistently high student evaluations, reaping praise for his teaching in both design studios and lecture/seminars. He has the ability to encourage diversity of thought; stimulate students to work to their highest potential; provide constructive criticism; expand students' conceptual understanding of design; and be rigorous yet fair. He introduces extended ideologies in architectural production in an attempt to encourage new ways of understanding disciplinarity and architectural creation. His course materials generate connections between various perspectives of architectural discipline and its broader cultural relevance. He has a keen ability to understand what a student is trying to accomplish and to suggest better approaches to achieve results. An intuitive critic, he situates his criticisms to the particular needs of a student's work.

Research/Creative Work: Professor McMorrough is a licensed architect and a founding member of studioAPT, formed in 2000 in partnership with Julia McMorrough. Their work is pursued primarily through national and international architecture competitions. As a principal in the firm, he won first prize in the Modern Affordable Homes Design Competition co-sponsored by the Boston Society of Architects and Habitat for Humanity (2002). As seen in two house proposals (the prize-winning Habitat for Humanity House and the 99K House), he responds directly to the particular circumstances of the projects, addressing their economic and social contexts, without resorting to the excessive form-making born of the new digital technology that characterizes the work of many designers of his generation.

Professor McMorrough is a prolific author and architectural critic, publishing essays in several edited volumes as well as architecture periodicals such as *Domus*, *Perspecta*, *Hunch*, *Volume*, *Praxis* and the Yale School of Architecture news magazine *Constructs* on topics ranging from the apocalypse, program, and supergraphics to urbanism. He has also written critical reviews on the work of Ant Farm, Rem Koolhaas, Philip Johnson, I. M. Pei, Peter Eisenman, Robert Venturi and Denise Scott Brown, Toyo Ito, Diller and Scofidio, Mark Goulthorpe and MOS (Meredith and Sample).

Most of Professor McMorrough's writings appear in edited books and journals – venues chosen based on their potential to reach a broader audience of architectural educators, theorists, and students. Professor McMorrough is primarily recognized as a writer, with a unique position as critic, scholar, and designer, with the difficulty of describing his contribution to the field within one particular mode of production.

Service: Professor McMorrough has been a solid and active contributor at the program, college and the university levels at OSU. His service initiatives are integrally related to his research and teaching efforts as well as his administrative roles. On a national level, he regularly lectures and serves as a guest critic on design studio reviews. In addition to regular service as a member of curriculum, search and admissions committees, Professor McMorrough organized themed lecture series – on Territory, Economy, Overlap, Inorganic, Confluence, and Environment – intended to engage the diverse disciplines of architecture, which included landscape architecture and urban and regional planning.





Summary of Evaluation:

Teaching – Professor Porter has an impressive teaching record. He has developed a number of new courses and new teaching methods. Although he is a demanding instructor who requires an impressive amount of reading and writing from his students, especially undergraduates, his student evaluations have continued to rise. Professor Porter has also been a pioneer in instructional technology, developing one website on eighteenth-century studies and another for intermediate and advanced students of the Chinese language. He is a dedicated instructor who continues to look for ways to improve and deepen his pedagogical skills.

Research – Professor Porter has completed his second book on the cultural impact of the European encounter with China in the early modern era, *The Chinese Taste in Eighteenth-Century England*, forthcoming from Cambridge University Press. He has also published seven essays and two reviews, mostly on the same topic. The new book shows a broad-ranging and impressive command of both European and Chinese cultural history, not only in literature and the visual arts but in architecture, gardening, domestic furnishings, and the aesthetics that governed taste in all these categories. With its publication, he will certainly be recognized as one of the world's leading authorities in his field. Professor Porter also has a third book currently under way, part of which has already been published.

Service – Professor Porter is completing his second year as associate chair of the Department of English, and during fall term 2009 he served as interim chair. He has also served as acting director of the LSA Honors Program (2005-2006), academic director of the University of Michigan/Peking University Joint Institute’s Program in Chinese Studies and Social Theory in Beijing (2006-2007), and interim director of the Global Ethnic Literatures Seminar (2008-2009). He currently serves on the Center for Chinese Studies Executive Committee. He is a trustee of the Telluride Association and played an active role in establishing the Telluride House on this campus. Nationally he has held important committee responsibilities in the Modern Language Association and the American Society for Eighteenth-Century Studies.



On the recommendation of the School of Music, Theatre & Dance Executive Committee, I am pleased to recommend the appointment of Carlos Xavier Rodriguez as associate professor of music, with tenure, School of Music, Theatre & Dance, effective September 1, 2010.

ACADEMIC DEGREES

Professor Rodriguez holds a B.A. degree from Pitzer College, CA Multi-Subject Credential from the College of Developmental Studies in California, M.A. from the University of California, and a Ph.D. from Northwestern University.

PROFESSIONAL RECORD

After several years in the public school system in California, Professor Rodriguez began his academic career as an instructor at National-Louis University and Northwestern University. He joined the faculty at Ohio State University as an assistant professor of music education in 1992. In 1995, he was appointed as an assistant professor at the University of Iowa. While at the University of Iowa, he was also the associate director of undergraduate studies in the School of Music. In 2006, Professor Rodriguez joined the University of South Florida as an associate professor of music education, with tenure, and in 2009, he was also appointed as coordinator of music education of that institution.

SUMMARY OF EVALUATION

Professor Rodriguez is a scholar of national prominence in the field of music education. He also has superior teaching skills as evidenced by his recent visit to the University of Michigan, where he received an outstanding response from the students with whom he interacted. He was able to share his knowledge and talents with students in ways that engaged and inspired them. Professor Rodriguez is extremely knowledgeable about the music education research and literature and is himself a skillful practicing musician. He speaks with great ease and authority and is impressive in his delivery. Professor Rodriguez has an engaging personality and will be a great colleague, advocate for music education and leader in the department and in the education community in the region and state

Reviewer A: "His work has been published in the most selective scholarly journals in music education. PROFESSIONAL ACTIVITY

Professor Rodriguez's research focuses on popular music pedagogy in secondary music education, teaching composition, and musical expression. His publications and scholarship appear in premier research journal in music education such as *Criticism and Theory in Music Education*, *Philosophy of Music Education Review*, *Journal of Research in Music Education*, *Music Education Research*, and *Research Studies in Music Education*. In addition, Professor Rodriguez has authored three book chapters and has been invited to submit a chapter to the *Oxford Handbook of Music Education* (in progress), testimony to his international reputation in the area of popular music in education. Professor Schironi was a Randall McIver Junior Research Fellow at Somerville College, Oxford (2001-2004) before being appointed as a lecturer at Exeter College, Oxford (2003-2004). She joined the faculty at Harvard University as an assistant professor in 2004 and was promoted to John L. Loeb Associate Professor of the Humanities in 2009.

Professor Schironi's research is of very high quality. Her current work focuses on Aristarchus, Homer, and the relevance of Greek science to practical technologies, and the reception of classical literature in modern times. On the recommendation of the Executive Committees of the Medical School and the College of Engineering, we are pleased to recommend the appointment of Lisa M. Larkin, Ph.D. as associate professor of molecular and integrative physiology, without tenure, Medical School, and associate professor of biomedical engineering, without tenure, College of Engineering, effective July 1, 2010. Dr. Larkin also will hold the title of research associate professor in the Institute of Gerontology, Medical School, effective July 1, 2010.

Dr. Larkin received her Ph.D. degree from the University of California-Davis in 1992, followed by four years as a postdoctoral fellow in the Institute of Gerontology at the University of Michigan. In 1996, Dr. Larkin was appointed as an assistant research scientist in the Division of Geriatric Medicine in the Department of Internal Medicine. In 2003, she received a joint appointment as an assistant research scientist in the Department of Biomedical Engineering. Dr. Larkin transferred to the Department of Molecular and Integrative Physiology as a research assistant professor in 2006, with a secondary appointment in the Institute of Gerontology. Since 2009, Dr. Larkin has held the title of research associate professor in molecular and integrative physiology, and she was promoted to associate research scientist in biomedical engineering in 2008.

Dr. Larkin's research focuses on musculoskeletal tissue engineering, including the development of three-dimensional structures that could at some point be applied to human use. This is a relatively new area and external reviewers attest to the fact that Dr. Larkin is an emerging leader in this field. Dr. Larkin's bibliography reflects 35 peer-reviewed publications, with more than 75 reviews and abstracts. Her work is highly collaborative with medical and engineering faculty facilitating novel discoveries resulting in two patent applications for three-dimensional skeletal muscle construct systems. Her research is recognized by peers as shown not only by her publications in excellent journals, but also by her successful record of funding.

Dr. Larkin currently is the principal investigator of an R01 grant funded by the National Institute of Arthritis and Musculoskeletal and Skin Diseases (NIAMS) and a foundation grant, as well as principal investigator on a recovery act award that provides summer research experiences for students and science educators. Dr. Larkin also is co-investigator on a program project grant funded by the Institute on Aging of the National Institutes of Health.


Professor Börgers serves as a mentor to three junior theorists in the department. He has headed recruitments in theory and applied theory, and has played an important role on the committee that






This collegiate professorship was established in 2004 through a fundraising effort in the Department of Radiology. Dr. Holt was loved by his trainees and colleagues alike, and, upon learning of his passing in 1996, they began to offer their contributions toward the establishment of a collegiate professorship in his honor. Dr. John "Jack" Holt was an internationally recognized leader in the field of pediatric radiology. He spent his entire academic career at the University of Michigan, first training as an assistant resident in 1939 and retiring from active faculty service in 1984.

Dr. DiPietro received the M.D. degree from the State University of New York, Upstate Medical Center, in 1974. He trained in diagnostic radiology at the Yale-New Haven Hospital, and served as chief resident in radiology at the Children's Hospital Medical Center in Boston, Massachusetts. In 1982, Dr. DiPietro joined the faculty at the University of Michigan as assistant professor of radiology. He advanced through the academic ranks to achieve his present title of professor of radiology in 1996.


Dr. DiPietro is a highly respected pediatric radiologist. He has published more than 80 peer-reviewed publications and has received awards for his scientific exhibits and papers. His most outstanding contribution has been to medical education, and he is well regarded as a talented mentor and an excellent role model for trainees and junior faculty. He has received several departmental teaching awards for excellence in the teaching of medical students, as well as a similar teaching award from the Society for Pediatric Radiology. Dr. DiPietro has been an invited speaker at numerous national and international meetings and has served as the course director for many of these conferences. Since 2003, he has served as director of the medical student education committee in the Department of Radiology.




The Psarouthakis Professorship was established in 1990 to support a senior faculty member who will establish eminent standards for collaborative research among interested scholars and to support the School's strategy to maintain a leadership position in the field of production and operations management.

Professor Duenyas has been a member of the University of Michigan faculty since completing his Ph.D. degree in 1991. He began as an assistant professor in the College of Engineering, was promoted to associate professor, with tenure, in that college before joining the Stephen M. Ross School of Business in 1999, and was promoted to professor in 2000. Professor Duenyas served as an associate dean from 2002-2006 and has served as area chair of the operations and management science area since 2008.

Professor Duenyas' research is focused on operations management problems that are of significant industrial relevance, particularly in developing analytical models of manufacturing systems that managers can use to develop insights into the main tradeoffs that they face. His particular strength, and what sets him apart, is his ability to interact with industrial sponsors, distill important problems from these interactions, and rigorously analyze them while maintaining an allegiance to the problem, instead of to analytical tractability as an end unto itself. His colleagues have described his research as superb, important, exceptional and path breaking. He has served in the professorship with great distinction.



With the approval of the Executive Committee of the College of Literature, Science, and the Arts, we are pleased to recommend the reappointment of Philip D. Gingerich as the Ermine Cowles Case Collegiate Professor of Paleontology, College of Literature, Science, and the Arts, for a five-year renewable term, effective September 1, 2010 through August 31, 2015.

Ermine Cowles Case was a professor and a curator of paleontology at the University of Michigan from 1907 until his retirement in 1941. The Ermine Cowles Case Collegiate Professorship in Paleontology was established by the Regents in July 2000. A stipend funded from College resources will accompany this professorship.

Philip Gingerich received his Bachelor of Arts, *summa cum laude*, from Princeton University in 1968. He attended Yale University where he earned his Master of Arts in 1972 and Doctorate in 1974. Professor Gingerich joined the faculty at the University of Michigan in 1974 as an assistant professor and an assistant curator was promoted through the ranks to professor and curator in 1983. He was given additional appointments in the Departments of Biology (now Ecology and Evolutionary Biology) and Anthropology.


Professor Gingerich continues to be very active in his field of research. He has unusually broad research interests which are reflected in his ongoing studies of the profound changes in life forms at the Paleocene-Eocene boundary (approximately 55 million years ago), the origin of modern orders of mammals, and the rates of evolution on the time scale of the evolutionary process. He is currently appointed as a senior fellow of the Michigan Society of Fellows. He is a world authority on the evolution of whales and horses, and is sought after by various news organizations to provide an informed perspective on evolution.

Professor Gingerich still teaches an undergraduate course entitled "Fossils, Primates, and Human Evolution" and he is very active working with graduate students who are completing their PhDs. Over the years may have been placed in good research universities and are thriving.



In support of the Horace H. Rackham School of Graduate Studies continuing efforts to enhance graduate education for international students, the dean and vice provost for academic affairs-Graduate Studies recommends the reappointment of John B. Godfrey as assistant dean for international education, Horace H. Rackham School of Graduate Studies, for a five-year term, effective August 1, 2010 through July 31, 2015. His responsibilities will not include teaching obligations.

John B. Godfrey earned his B.A. degree with honors from the University of Toronto in 1973 and his M.A. and Ph.D. degrees from Johns Hopkins University in 1980 and 1985, respectively. He served as a lecturer in the Department of History and as dean of Calhoun College at Yale University from 1985-1989; as a lecturer in the Department of History and associate director of the Programs of African Studies and International Studies at Northwestern University from 1989 to 1993; and as associate director of the International Institute at the University of Michigan from 1993 to 1998 and special assistant to the provost at the University of Michigan from 1998 to 2000. While at the International Institute, Mr. Godfrey served on several committees including the Executive Committee and Governing Board and the Graduate Board. As special assistant to the provost, he coordinated the University reaccreditation by the North Central Association/Commission on Institutions of Higher Education. Mr. Godfrey has served as the assistant dean for international education in the Horace H. Rackham School of Graduate Studies from June 2000 to the present.

In the Graduate School, John Godfrey is responsible for international and interdisciplinary programs and initiatives, and acts as internal and external liaison on federal training grants and other matters regarding graduate education. He served as statewide graduate school coordinator for Michigan Graduate Education Day, 2010; provided oversight for the development the Milestone Meetings and PLAN (Professions, Life, Academics, Networks) graduate student career development initiative, 2009-present; served as chair of the International Families Outreach Project, 2001-04; director of training workshops for officials from China's Ministry of Personnel, 2003-04; and planning coordinator of Michigan-China Leadership Forum initiative under development with China's Ministry of Education.

John Godfrey's University administrative service includes service as a member of the President's African Advisory Committee, 2009-present; chair of the Safety and Security Workgroup, Council on Global Engagement, 2008-present; membership on the Knight-Wallace Fellows at Michigan Fellowship Board, 2010-present; membership on the University All-Hazards Planning Group, 2003-present; co-chair of the SEVIS Implementation Team, 2002-2003; membership on the Faculty and Staff Immigration Task Force, 2004-2005; chair of the International Travel Oversight Committee, 2001-present; and co-chair, U-M SARS Planning Committee, 2003-04. He is a member of the International Advisory Committee of the Council of Graduate Schools and was a delegation organizer of the Rackham mission to meet Chinese Ministry of Education officials and university administrators in Beijing and Shanghai, 2002, 2003, and 2004. 




Professor Lieberman's scholarship continues to bring luster to his department, the college and to the University of Michigan. He has published four articles in major journals with another four essays and articles in press or under submission to leading journals of the relevant fields. He has also published the second volume of *Strange Parallels: Southeast Asia in Global Context* which has been retitled as *Mainland Mirrors: Europe, Japan, China, South Asia, and China* (Cambridge University Press, 2009). The first volume was published in 2004 and was awarded the World History Association Book Prize. At 973 pages the second volume is an extraordinary monument to erudition and a veritable *tour de force* of a book. On the recommendation of the dean and the Executive Committee of the College of Literature, Science, and the Arts, we are pleased to recommend the reappointment of Deborah Dash Moore as the Frederick G. L. Huetwell Professor, College of Literature, Science, and the Arts, for a five-year renewable term, effective September 1, 2010 through August 31, 2015.

As a result of a generous gift from the estate of Frederick G. L. Huetwell in May 1995, the provost and the president awarded the College four endowed professorships. The primary objective of the professorships is to attract and honor distinguished senior faculty in the social sciences and humanities.

Professor Moore remains a highly respected Jewish historian and Jewish studies scholar. Her work on Jewish immigration, gender, and most recently American Jewish identity politics is internationally recognized as having made a significant contribution to modern Jewish studies. Her most recent book, *GI Jews: How World War II Changed a Generation* (2004), was named a *Washington Post* Best Book of the Year award in 2005. Other awards include the Marshall Sklare Award from the Association for the Scientific Study of Jewry (2006) and The Ohio State University granted her a Distinguished Humanist Award (2007). Professor Moore has edited a book on American Jewish identity politics (2008) and has two co-edited volumes on Jewish civilization and culture and on Jewish history and gender, respectively. Both are scheduled to appear in 2010.


Professor Moore continues to play a prominent professional role in the national and international communities, as evidenced by the constant demand she is in to give invited presentations, to consult, and to serve on the editorial boards of the major journals in her field. Moreover, she remains a respected educator, committed to undergraduate and graduate education, who has regularly offered courses at both levels across Judaic Studies, the Program in American Culture, and the Department of History.

This outstanding record of scholarly productivity has not been slowed by her leadership of the Frankel Center for Judaic Studies. She have over the past five years served the Center and the University in an exemplary capacity, fielding and mentoring international cohorts of scholars who have applied to the Frankel Institute for Advanced Judaic Studies, chairing the faculty of the Center and shepherding the Center into enhanced program status, chairing hiring committees that have successfully brought to Michigan distinguished junior faculty, and in general continuing to enhance both the Center's and the University's ties with local, national, and international Jewish communities.



With the approval of the Executive Committee of the College of Literature, Science, and the Arts, we are pleased to recommend the reappointment of William R. Paulson as the Edward Lorraine Walter Collegiate Professor of Romance Languages and Literatures, College of Literature, Science, and the Arts, for a five-year renewable term, effective September 1, 2010 through August 31, 2015.

Edward Lorraine Walter was a faculty member at the University of Michigan from 1868 until his death in 1898. The Edward Lorraine Walter Collegiate Professorship in Romance Languages and Literatures was established by the Regents in June 2005. A stipend funded from College resources accompanies this professorship.

William Paulson earned his Bachelor of Arts, *summa cum laude*, from Rockford College in 1976. He attended Princeton University where he received his Master of Arts in 1978 and Doctorate in 1981. Professor Paulson began his teaching career as an assistant professor at Mount Holyoke College in 1981. He joined our faculty as an assistant professor in 1987, received tenure in 1989, and was promoted through the ranks to professor in 1995. He was chair of the Department of Romance Languages and Literatures from 1992 to 1997.

Professor Paulson is a highly respected scholar of the French Enlightenment and of the 19th century who has also made important interventions in the relation between literature and science and in the role of the humanities in the modern world. He is currently continuing his research on a manuscript in progress entitled *Reading in Real Time* and on two articles.

Professor Paulson is a respected and appreciated teacher of undergraduate and graduate students. He willingly takes on teaching assignments which meet the department's curricular needs. He has supervised honors theses and served as honors advisor in French for the last few years.

Professor Paulson continues to be a mainstay of his department where he has served for nearly 25 years. At the departmental level he served as acting chair for the Department Romance Languages and Literatures (2007-2008) and on the Graduate Committee (2009-2010). He has also served on search committees and numerous promotion committees. He plays a prominent role in the profession at large through editorial consulting and reviewing, promotion reviews, and program reviews.

Perhaps most significant, he has prepared the first de novo designed metalloprotein catalyst. Taken together these research achievements are major accomplishments. He has published over 50 manuscripts during the past five years and has given numerous lectures at universities and conferences around the world.



Professor Bayraktar has been selected as the initial recipient of the recently endowed Susan Meredith Smith Professorship, which is a chair in actuarial and financial mathematics that is aimed at the associate professor level. Professor Bayraktar was approved by the Regents for promotion to associate professor at their May 2010 meeting.

Professor Bayraktar's research deals with the problem of making decisions on the basis of limited and possibly random information, with investment strategies, and with optimal stopping problems, among many others. These topics only represent a small fraction of the scope of his work. All indications are that he will be one of the leading researchers in financial mathematics in the future. He has been extremely productive, publishing more than forty papers in refereed journals plus several more in conference proceedings. The papers contain difficult mathematics with real applications in finance. They cover a broad range of topics in finance and make use of many sophisticated mathematical methods. He has been successful at obtaining research funding, in particular from the National Science Foundation. He has received numerous invitations to present his work at conferences and is generally regarded as one of the top financial mathematics researchers of his generation.


Professor Bayraktar plays an important role in the mathematics' teaching program. Financial mathematics is in high demand among students and few departmental faculty are qualified to teach it. As a result, his classroom teaching has been concentrated in the financial math program and in

service courses for the financial engineering program. Unlike most service courses, these are aimed at graduate students. He has also served as the mentor of three postdoctoral scholars and is currently advising four Ph.D. students. He was advisor of two others who have now obtained their doctorates (in 2008 and 2009).



on at least seven national committees including the NSF Division of Environmental Biology and the NSF Integrative Research Challenges.



He is studying their importance in orbital cancer, craniofacial syndromes, congenital eye disorders, and thyroid-related eye disease. He has published 19 articles in peer-reviewed publications and has contributed to four book chapters. Dr. Kahana's work has been recognized by grants from the National Eye Institute, and he was awarded a four-year career development award from the Research to Prevent Blindness health organization in 2009.




It is recommended that Sridhar Kota be granted an extension of leave of absence effective September 1, 2010 through August 31, 2010.

The School of Information wishes to recommend a change in an existing academic administrative title from associate dean for academic affairs to associate dean for academic programs, School of Information, effective July 1, 2010.

The School of Information continues to grow and develop innovative programs. Our student body has increased by 72% over the last 10 years. In addition, we have, together with the College of Literature, Science, and the Arts, and the College of Engineering, started a new undergraduate concentration (informatics). Given the growing size and complexity of our academic programs, the size and complexity of the workload expected of the associate dean for academic affairs has significantly increased. We will be able to better serve our students by changing this administrative position to a more narrowly focused appointment specifically in charge of academic programs; the current position title also encompasses many responsibilities for faculty life.

The associate dean for academic programs will have lead responsibility for student experience and the content and management of our academic programs (master's, doctoral, and our participation in the undergraduate Informatics program). This will include oversight over student recruiting, admissions, orientation, advising and student life, practical engagement and career placement; curriculum planning, teaching assignments and scheduling; degree and other academic program development; and program assessment.

This position will take leadership on special projects and be responsible for the academic programs budget. The associate dean for academic programs will coordinate with a new administrative position we are creating, senior associate dean for faculty, and will report to the dean. We therefore request the change in academic administrative title, effective July 1, 2010.



He has served as a technical consultant to industry and government agencies and served on advisory boards for universities, industry, and government agencies. He supervised 49 PhD and 38 MS students. He was elected as a fellow of the Institute of Electrical and Electronics Engineers (IEEE) in 1984 and received the IEEE Computer Society's Harry M. Goode Memorial Award in 1992 and its Taylor L. Booth Education Award in 1996. In 2000, he received the highest professional society award in computer architecture, the Eckert-Mauchly Award.





We are pleased to recommend to the Board of Regents the appointment of Professor David M. Halperin as the W. H. Auden Distinguished University Professor of the History and Theory of Sexuality, effective September 1, 2010.

The first Distinguished University Professorships were created in 1947 by the Board of Regents to recognize members of the faculty for exceptional achievement and reputation in their appointive fields of scholarly interest and for their superior teaching skills. Each professorship is named in honor of an eminent individual – preferably one associated with the University – in the scholar's same general field of interest. Appointment to a Distinguished University Professorship continues to be one of the most prestigious honors conferred by the University upon a member of its faculty.

Professor Halperin received his graduate degrees from Stanford University, including an M.A. from the Department of Classics in 1977 and the Ph.D. from the Department of Classics and the Graduate Program in Humanities in 1980. From 1979 until 1996 he served on the literature faculty of the Massachusetts Institute of Technology, as an assistant professor from 1979-83, associate professor from 1983-89, and as professor from 1989 to 1996. He has held visiting appointments on the faculties of the American Academy in Rome, the University of California, Santa Cruz, and in several Australian universities, including the University of Queensland, Monash University, the University of New South Wales, and the University of Technology, Sydney. Professor Halperin came to the University of Michigan in 1999 as the W. H. Auden Collegiate Professor of English Language and Literature (later changed to the W. H. Auden Collegiate Professor of the History and Theory of Sexuality). He has received additional academic appointments, as professor of women's studies in 2002, professor of classical studies in 2004, and professor of comparative literature in 2005.

Professor Halperin is one of the leading figures in Lesbian, Gay, Bisexual, Transgender (LGBT) Studies. Since the publication of *One Hundred Years of Homosexuality* (1990) and *Saint Foucault: Towards a Gay Hagiography* (1995), he has helped to shape the field with his provocative books and edited collections and with *GLQ: A Journal of Lesbian and Gay Studies*, which he co-founded and co-edited for

many years. Professor Halperin's *What do Gay Men Want? An Essay on Sex, Risk, and Subjectivity* (2007) led to his recent work with the Centers for Disease Control and the San Francisco Department of Public Health. The 2009 anthology *Gay Shame* (co-edited with Valerie Traub) emerged from a controversial conference he co-organized at the University of Michigan. A theorist and critic deeply engaged with activism (both within and outside the academy), Professor Halperin has woven his remarkably diverse areas of expertise (which include classical studies and its relation to contemporary cultural history; gay men's cultural practices and subjectivity; the history and theory of homosexuality; HIV/AIDS) into a singular body of work.

His scholarship has brought him honors. He was awarded a John Simon Guggenheim Fellowship in 2008-09. He has won two highly competitive internal research fellowships, the Michigan Humanities Award and the Institute for the Humanities Faculty Fellowship. The scholarly organizations that have acknowledged his remarkable contributions with awards and citations include the Council of Editors of Learned Journals, the American Historical Association, and the Modern Languages Association.

Professor Halperin currently sits on the editorial or advisory boards of seven scholarly journals. Since he has been at the University, he co-founded the LGQ Research Initiative, co-organized two major conferences, and served for multi-year terms on the Executive Committees of the English Department, IRWG, and the Institute for the Humanities. He is a senior fellow at the Michigan Society of Fellows.

As he assumes the Distinguished University Professorship, Professor Halperin wishes to be named the W. H. Auden Distinguished University Professor of the History and Theory of Sexuality.

Wystan Hugh (W. H.) Auden was an Anglo-American poet, born in England, later an American citizen, regarded by many as one of the greatest writers of the 20th century. His work is noted for its stylistic and technical achievements, its engagement with moral and political issues, and its variety of tone, form and content. The central themes of his poetry are love, politics and citizenship, religion and morals, and the relationship between unique human beings and the anonymous, impersonal world of nature. Mr. Auden came to the University of Michigan in 1940 to judge the Hopwood Awards. He also served as a lecturer in the English Department during the 1941-42 academic year.

The appointment of Professor David M. Halperin as the W. H. Auden Distinguished University Professor of the History and Theory of Sexuality, effective September 1, 2010, recognizes his extensive and outstanding scholarly achievements, his commitment to excellence in education for his students, and his extensive contributions to the University of Michigan and far beyond. We are delighted to make this recommendation.

We are pleased to recommend to the Board of Regents the appointment of Professor Yoram Koren as the James J. Duderstadt Distinguished University Professor of Manufacturing, effective September 1, 2010.

The first Distinguished University Professorships were created in 1947 by the Board of Regents to recognize members of the faculty for exceptional achievement and reputation in their appointive fields of scholarly interest and for their superior teaching skills. Each professorship is named in honor of an eminent individual – preferably one associated with the University – in the scholar’s same general field of interest. Appointment to a Distinguished University Professorship continues to be one of the most prestigious honors conferred by the University upon a member of its faculty.

Professor Koren received his graduate training at the Technion – Israel Institute of Technology, earning an M.Sc. in electrical engineering in 1968 and a D.Sc. in mechanical engineering in 1971. He remained on the faculty of the Technion except for two year-long research positions (at the University of Wisconsin and McMaster University) and additional two years (1980-1982) serving as the Paul G. Goebel Visiting Professor of Engineering at the University of Michigan. In 1981, when Professor James Duderstadt became the dean of Engineering he established the Center for Robotics and Integrated Manufacturing, and nominated Professor Koren as the director of its Integrated Design and Manufacturing Division. Professor Koren worked jointly with Dean Duderstadt to establish the University of Michigan as a prime research institute for manufacturing. Professor Koren joined the faculty of the University of Michigan in 1986.

Professor Koren is internationally recognized for innovative contributions to robotics, flexible automation and reconfigurable manufacturing systems. He is a member of the U.S. National Academy of Engineering, and is credited with conceiving of the reconfigurable manufacturing paradigm and as a pioneer in establishing flexible automation, computer numeric control and adaptive control of machine tools as research fields and an educational discipline.

According to Google Scholar, more than 9000 papers have cited Professor Koren’s work on reconfigurable manufacturing, mobile robots, and flexible automation. He is the author of 270 papers, four award-winning books, and holds 14 U.S. patents. Professor Koren has won numerous prestigious manufacturing awards, including the Merchant Medal of ASME & SME, the Society of Manufacturing Engineering Gold Medal, the William T. Ennor Manufacturing Technology Award, and the Hanasufa Outstanding Investigator Award

in flexible automation. He received the UM College of Engineering (CoE) Excellence in Research Award, and the Attwood Award (the highest award in the U-M CoE). In 2007 he was the first holder of the Edmond J. Safra Distinguished Visiting Professor Chair at the Technion (Israel).

Professor Koren is the founding director, in 1996, of the Engineering Research Center (ERC) for Reconfigurable Manufacturing Systems (RMS), sponsored by the National Science Foundation. During 11 years of NSF sponsorship, the Center —comprised of 20 professors, 10 investigators, 300 hundred graduate students and 25 companies— received \$48 million in funding. The RMS Center was the first NSF-sponsored ERC in the U-M College of Engineering. Tools developed there, using Professor Koren's patents, designs and principles, have already made their way to factory floors. The world's-first full-scale Reconfigurable Machine Tool, which is based on Professor Koren's patent and conceptual design, was introduced by the ERC/RMS. The Center has held three Reconfigurable Manufacturing Conferences with participants from 40 countries and conducted outreach, including building museum exhibitions and spearheading programs to increase participation of underrepresented minorities in the field. Some of Professor Koren's earlier accomplishments include the 1973 development of the world-first computerized real-time adaptive controller for a milling machine, long before computers were commonly used in industrial applications, as well as the 1993 development of a mechanical snake-robot whose movement was remarkably true to life.

As he assumes the Distinguished University Professorship, Professor Koren wishes to be named the James J. Duderstadt Distinguished University Professor of Manufacturing. Professor Duderstadt was pleased to agree to this title.

James J. Duderstadt is president emeritus and University Professor of Science and Engineering at the University of Michigan. He received a Ph.D. in engineering science and physics from the California Institute of Technology in 1967. He joined the Michigan faculty in 1968 in the Department of Nuclear Engineering, rising through the ranks to professor in 1975. Professor Duderstadt became dean of the College of Engineering in 1981 and provost in 1986. He was elected president of the University of Michigan in 1988 and served in the role until July, 1996. He currently holds a university-wide appointment as University Professor of Science and Engineering, co-chairing the program in Science, Technology, and Public Policy and directing the Millennium Project, a research center exploring the impact of over-the-horizon technologies on society.

The appointment of Professor Yoram Koren as the James J. Duderstadt Distinguished University Professor, effective September 1, 2010, recognizes his extensive and outstanding scholarly achievements, his commitment to excellence in education for his students, and his extensive contributions to the University of Michigan and far beyond. We are delighted to make this recommendation.

We are pleased to recommend to the Board of Regents the appointment of Professor David E. Meyer as the Clyde H. Coombs and J. E. Keith Smith Distinguished University Professor of Mathematical and Cognitive Psychology, effective September 1, 2010.

The first Distinguished University Professorships were created in 1947 by the Board of Regents to recognize members of the faculty for exceptional achievement and reputation in their appointive fields of scholarly interest and for their superior teaching skills. Each professorship is named in honor of an eminent individual – preferably one associated with the University – in the scholar’s same general field of interest. Appointment to a Distinguished University Professorship continues to be one of the most prestigious honors conferred by the University upon a member of its faculty.

Professor Meyer received an M.A. in mathematics from the University of Michigan in 1966 and a Ph.D. in psychology from the University of Michigan in 1969. From 1969 to 1977, he served as a member of technical staff at the Bell Laboratories, Murray Hill, NJ. In 1977, he returned to the University of Michigan as an associate professor in the Department of Psychology, and was promoted to professor in 1984. He has remained at Michigan ever since, participating as a senior fellow at the U.M. Institute of Gerontology, and becoming the Clyde H. Coombs and J. E. Keith Smith Collegiate Professor of Mathematical and Cognitive Psychology in 2008.

Professor Meyer’s research has investigated the fundamental nature of basic mental and physical processes that underlie human cognition and action, including perception, attention, learning, memory, language, thinking, judgment, decision making, cognitive control, and movement production. His approach to these topics has included seminal empirical studies of human behavior involving measurements of reaction time, response accuracy, and event-related brain potentials. These studies have been complemented with Professor Meyer’s development of precise, detailed, mathematical and computational models of human performance in a variety of laboratory and real-world contexts. He is especially well known for his contributions to the scientific understanding of human semantic memory, which enables people to recognize and process word meanings during spoken and written language comprehension. Other major facets of his pioneering research have significantly advanced the theoretical characterization of mechanisms that govern the speed and accuracy of rapid aimed limb movements, and the executive cognitive-control operations whereby mental and physical processes are coordinated during

complex realistic human performance. Professor Meyer is considered to be among the world's current leading experts on human multitasking.

For his pioneering scientific investigations, Professor Meyer was elected to the U.S. National Academy of Sciences in 2009. Previously, the American Psychological Association has honored him with its Distinguished Scientific Contribution Award, and the Association for Psychological Science has given him its William James Fellow Award for lifetime contributions to basic scientific research. Professor Meyer is also a fellow in the Society of Experimental Psychologists and the American Association for the Advancement of Science.

Professor Meyer's professional service at the local level has included stints as chair of the Cognition and Cognitive Neuroscience Program in the U.M. Department of Psychology, and memberships on the Psychology Department's Graduate Committee and Augmented Executive Committee. In addition, he has served on the Executive Committee of the Combined Program in Education and Psychology, the Rackham Faculty Board, and the Steering Committee of the Michigan Transportation Research Institute. At the national level, he has served on the editorial boards of numerous scientific journals, committees of the Society of Experimental Psychologists and American Psychological Association, grant-proposal review panels of the National Institute of Mental Health, and advisory boards of other government agencies. For several years, Professor Meyer also served on the Executive Committee of the International Association for the Study of Attention and Performance. Currently, he is an active member of the Mind and Life Institute, a private non-profit organization devoted to promoting intellectual exchanges and collaborative research involving academic scientists, contemplative practitioners, and Buddhist scholars, including His Holiness, the 14th Dalai Lama.

Professor Meyer's contributions have likewise extended to the public news media. Numerous interviews with him have occurred on national radio and television stations. A variety of newspapers and magazines have interviewed him too, including the *New York Times*, *Los Angeles Times*, *Chicago Tribune*, *Boston Globe*, *Wall Street Journal*, *Chronicle of Higher Education*, *Time*, *The Atlantic*, *Business Week*, and *Scientific American*.

Professor Meyer is equally well known for his mentoring of undergraduate and graduate students. Among his several dozen doctoral graduate students over the years, many have gone from the University of Michigan to prominent scholarly scientific careers in their own right. Specifically, the Association for Psychological Science has cited Professor Meyer for "a phenomenal track record of mentoring young scientists" and "personal devotion to the well-being of his students which has made his influence on their research and careers truly transformative".

As he assumes the Distinguished University Professorship, Professor Meyer wishes to be named the Clyde H. Coombs and J. E. Keith Smith Distinguished University Professor of Mathematical and Cognitive Psychology.

Clyde Hamilton Coombs was a long-time faculty member in the Department of Psychology at the University of Michigan. An internationally recognized expert on psychological measurement, human judgment, and decision making, Professor Coombs created the Michigan Mathematical Psychology Program, which made Michigan one of the premier institutions in mathematical psychology. He was Professor Meyer's academic mentor as a University of Michigan graduate student.



We are pleased to recommend to the Board of Regents the appointment of Professor Fawwaz T. Ulaby as the Emmet Leith Distinguished University Professor of Electrical Engineering and Computer Science, effective September 1, 2010.

The first Distinguished University Professorships were created in 1947 by the Board of Regents to recognize members of the faculty for exceptional achievement and reputation in their appointive fields of scholarly interest and for their superior teaching skills. Each professorship is named in honor of an eminent individual – preferably one associated with the University – in the scholar’s same general field of interest. Appointment to a Distinguished University Professorship continues to be one of the most prestigious honors conferred by the University upon a member of its faculty.

Professor Ulaby received his graduate education at the University of Texas at Austin, earning an M.S. in electrical engineering in 1966 and a Ph.D. in electrical engineering in 1968. In 1968 he joined the electrical engineering faculty of the University of Kansas, Lawrence, serving as an assistant professor from 1968-71, associate professor from 1971-76, and professor as of 1976 (becoming the J. L. Constant Distinguished Professor of Electrical Engineering in 1980). He came to the University of Michigan as professor of electrical engineering and computer science in 1984. He was designated the R. Jamison and Betty Williams Professor in 1993, and named an Arthur F. Thurnau Professor in 1998. He assumed his present title of Chen-To Tai Professor of Electrical Engineering and Computer Science in 2009.

Professor Ulaby has pioneered more than one major field of research in science and engineering. He established the field of terahertz technology and is considered to be the father of the field of microwave remote sensing. He led Michigan’s applied electromagnetic group to national prominence and in 1988 established the Center for Space Terahertz Technology. In 1990, Professor Ulaby established the first international symposium on the topic of terahertz technology.

Professor Ulaby’s contributions to science and engineering were recognized in 1995 through his election to the National Academy of Engineering. In 2006 he was awarded the Thomas Edison Medal, the oldest medal in electrical engineering in the U.S.

Professor Ulaby's service contributions are many. He created the Geoscience and Remote Sensing Society and its journal. He is involved in national service, serving on a committee of the National Academies to evaluate science strategies of major industrialized nations, a AAAS committee to evaluate NSF's Science and Engineering Centers Program, and on the Committee on Human Rights of the National Academies, which works to free scientists and engineers who are prisoners of conscience. He has also served the University of Michigan as director of the University's Radiation Laboratory and as UM's vice president for research (1999-2005). He was the founding provost at King Abdullah University of Science and Technology.

As he assumes the Distinguished University Professorship, Professor Ulaby wishes to be named the Emmet Leith Distinguished University Professor of Electrical Engineering and Computer Science.

Emmett Leith (1927-2005) was a professor of electrical engineering at the University of Michigan and, with Juris Upatnieks of the University of Michigan, the co-inventor of three-dimensional holography. Professor Leith received his Ph.D. in electrical engineering from Wayne State in 1978. Professor Leith and his coworker Juris Upatnieks displayed the world's first three-dimensional hologram at a conference of the Optical Society of America in 1964. He received the Morris N. Liebmann Memorial Award from the Institute of Electrical and Electronics Engineers (IEEE) in 1960 and the Ballantine Medal in 1969. In 1979, President Jimmy Carter awarded Leith with the National Medal of Science for his research. He was awarded the 1985 Frederic Ives Medal by the Optical Society of America.



Since joining the faculty at the University of Michigan-Flint, Professor Wyneken has served as chair, NCATE Education Unit Assessment Committee, member of the School's Strategic Plan and Retreat Planning Committee, Academic Standards Committee, and as a member of the University's Academic Affairs Advisory Committee, Faculty Council, Faculty Code and Revision Committee, and many others too numerous to list. Professor Wyneken has served as a consultant to Mott Community College in the area of improving student success in mathematics and facilitated workshops for teachers of mathematics for Flint Community Schools and the Genesee Intermediate School District. 
