Authorization for the University to Purchase CD's From Melisa Schuster

(University of Michigan Employee, Creator and Distributor)

## Background:

The University of Michigan Department of Psychiatry seeks approval to purchase CD's from Melisa Schuster to support the Mom Power curriculum which teaches moms various self-care skills in relaxation. The CD's, *The Light Within: Meditations for Peace Volume 1 and 2* would be given to moms to take home as a way to extend the self-care education, assisting them with deep breathing, progressive relaxations and other relaxation exercises. The total cost for the CD's is \$2,000. The department chose to purchase the CD's from Melisa Schuster prior to her becoming a University employee.

The proposed agreement falls under the State of Michigan Conflict of Interest Statute as Melisa Schuster is a University employee as Clinical Social Worker-MIHP Coordinator at the Department of Social Work and would be party to the agreement as Creator and Distributor of the CD's. However, the Statute allows the University to enter into such contracts if the following conditions are met:

- a) The public servant promptly discloses any pecuniary interest in the contract to the official body which has power to approve the purchase, which disclosure shall be a matter of record in its official proceedings.
- b) The purchase is approved by a vote of not less than 2/3 of the full membership of the approving body in open session without the vote of the public servant making the disclosure.
- c) The official body discloses the following summary information in its official minutes:
  - i) The name of each party involved in the contract.
  - ii) The terms of the purchase, including duration, financial consideration between the parties, facilities or services of the public entity included in the purchase, and the nature and degree of assignment of employees of the public entity for fulfillment of the purchase.
  - iii) The nature of any pecuniary interest.

The following information is provided in compliance with the statutory requirements contained in Section (c) above:

- i) The parties to the contract are the Regents of the University of Michigan, Department of Psychiatry and Melisa Schuster.
- ii) The agreement is to purchase CD's, which will be given to moms to take home as a way to extend their self-care education. The cost for said CD's is \$2,000.
- iii) The pecuniary interest arises from the fact that Melisa Schuster is a University of Michigan employee as Clinical Social Worker-MIHP Coordinator at the Department of Social Work and Creator and Distributor of the CD's.

Melisa Schuster has met state law requirements with the disclosure of her pecuniary interest and formal appointment arrangements with the University of Michigan. Requirements, if any, that may be applicable under the Medical School's or OVPR's Conflict of Interest Committee's procedures are separately analyzed and managed.

<u>We recommend</u> that the Board of Regents approve the agreement between the University of Michigan and Melisa Schuster subject to requirements, if any, that either the Medical School's or OVPR's Conflict of Interest Committee may impose.
