



Work will be done in Ann Arbor, Michigan.

Adams, Robert J., Associate Professor of Architecture, with tenure, A Alfred Taubman College of Architecture and Urban Planning and Associate Professor of Art and Design, without tenure, Penny W Stamps College of Art and Design, sabbatical January 1 – May 31, 2020, to build on scholarly interests at the intersection of urban infrastructure and architecture with an emphasis on disability culture and design. Work will be done at the National Autonomous University of Mexico, Mexico City, Mexico.

Ahlquist, Sean E., Assistant Professor of Architecture, A Alfred Taubman College of Architecture and Urban Planning, sabbatical January 1 – December 31, 2020, to document current research which explores the relationship between architectural educational environments and behavioral effects for children with autism and other sensory-related special needs. Lapeyrouse, Lisa M., Assistant Professor of Health Science and Administration, Department of Public Health and Health Sciences, College of Health Sciences, UM – Flint, sabbatical September 1 – December 31, 2019, to begin work on the development of a bilingual needs assessment for Latinx adults living in Genesee County using a community-based, participatory research approach. Work will be done in Ann Arbor, Michigan.

Logue, Kyle D., Douglas A Kahn Collegiate Professor and Professor of Law, with tenure, Law School, sabbatical January 1 – May 31, 2020, to complete several law review articles, one on the problem of the gap in catastrophe insurance coverage in the US and worldwide, the second on the opioid addiction problem as a sort of environmental externality, and explores the optimal tax necessary to incentivize large pharmaceutical companies to take reasonable measures to reduce the harms associated with opioid addiction and the third on autonomous vehicles, asking the question: should driverless cars obey the law. Work will be done in Ann Arbor, Michigan.

Mankouche, Steven Y., Associate Professor of Architecture, with tenure, A Alfred Taubman College of Architecture and Urban Planning, sabbatical January 1 – May 31, 2020, to continue investigation into ancient Roman clay tube construction techniques “tubi fittili” using contemporary technology. Work will be done in Italy and The Netherlands.

Manojlovich, Milisa M., Professor of Nursing, with tenure, School of Nursing, sabbatical September 1, 2019 – May 31, 2020, to continue the advancement of patient safety through two mechanisms: 1) to continue to identify ways to improve communication between nurses and physicians by developing and testing a variety of interventions 2) to continue to develop the Pivot Hub as a premier destination for researchers and stakeholders in healthcare systems interested in finding ways to improve patient safety, which will also then position the Pivot Hub to influence patient safety nationally.
