President Schlissel, members of the Board of Regents, and Executive Officers of the University, I am pleased and honored to submit the following report to you on behalf of the Central Student Government. Below is a brief update of our activities, operations, and goals as we continue to serve the students of this University.

The Statement of Student Rights and Responsibilities:

The 2015-2016 academic year is an amendment year. Students and community members have until November 2nd, 2015 to give input and propose amendments, a process that CSG will actively been involved with. We are interested in focusing on:

- Increasing student voice in campus matters, policies, and decisions
- Improving and clarifying the Sexual Assault policy
- Ensuring that diversity, inclusiveness, and safety are top considerations throughout the entire *Statement* amendment process

Changing campus drinking culture:

We have reached out to Umich Dining, requesting that they work with CSG on a solution to make food available to students on games days with a noon home game. Many students wake up and begin to consume alcohol well before the dining halls open, so we're interested in providing a basic continental breakfast in residence halls to students to prevent drinking on an empty stomach. Clearly, this is not a comprehensive solution, but this will improve the safety and well being of many students during game days.

HAIL Scholarship:

I'm excited that the University announced the "High Achieving Involved Leaders" scholarship that will fully fund the education for high-achieving, low-income, in-state students. This is one of many initiatives that will increase the diversity on our campus, and CSG looks forward to doing what it can to make our campus a more inclusive place.

Preparing for the Bicentennial:

CSG is beginning to plan our part of the University's Bicentennial celebration in order to maximize the amount of student input. We have established a CSG executive commission for the Bicentennial and look forward to working with Dr. Gary Krenz from the University's Bicentennial Committee in the coming months.


Athletics and Sexual Assault Prevention and Awareness:
