I am pleased to recommend the appointment of David C. Miller, M.D., M.P.H. as executive vice president for medical affairs and chief executive officer, University of Michigan Health Systems, effective July 1, 2025 through June 30, 2030.

Dr. Miller is the president of University of Michigan (UM) Health System. In this role, Dr. Miller has responsibility for all aspects of strategic, operational, clinical, cultural, and financial performance of the UM Health clinical enterprise. With >\$5B in revenue in 2024, the UM Health clinical enterprise is comprised of adult and pediatric and women's hospitals and outpatient care clinics with over 2,000 clinical faculty and 140 clinics at 40 sites in southern Michigan.


In this role since 2021, Dr. Miller led UM Health through the challenging COVID-19 pandemic with a spirit of continuous improvement, collaborative problem-solving and resolute teamwork. In support of Michigan Medicine's tripartite mission, Dr. Miller has worked with team members to implement multi-year strategic priorities focused on belonging and inclusion, access, safety and quality, experience for patients and team members, strategic growth and financial sustainability. In support of these goals, Dr. Miller has led the evolving integration of the health system's statewide network, including UM Health Sparrow and UM Health West. He has also guided the expansion of ambulatory care services with the new Ypsilanti Health Center (slated to open in 2025) and a planned multi-specialty health center in Troy, while also advancing innovative clinical programs including specialty pharmacy and hospital care at home. Across all these activities, Dr. Miller has focused on enhancing an inclusive environment and furthering commitments to the environment, sustainability and community engagement.

Prior to his current role, Dr. Miller served as the chief clinical officer for University Hospital and the Frankel Cardiovascular Center. Dr. Miller joined the University of Michigan faculty in 2008 and is currently a professor in the Department of Urology. He maintains a clinical practice that focuses on the diagnosis and management of patients with prostate cancer.

Dr. Miller also has a broad background in health services research, including substantial experience using claims data and formal training in the advanced statistical methods used in observational data analyses. With prior funding from the Agency for Healthcare Research and Quality and the National Cancer Institute, Dr. Miller's empirical research agenda focused on comparative effectiveness research, physician-led collaborative quality improvement, and understanding the relationship between physician organizations, integrated delivery systems, and the quality and cost of specialty care. Dr. Miller received his medical school training at the Washington University School of Medicine. His residency was completed in the Department of Urology at UM, and his research training includes both a Master's of Public Health in epidemiology from UM, and completion of health services research fellowships at UM and the University of California, Los Angeles/RAND Corporation.
