President Ono, members of the Board of Regents, and Executive Officers of the University:

As always, and most importantly, the conditions in Gaza have continued to deteriorate directly as a result of the Zionist entity's continued attacks on Palestinian life and society. The UN's independent investigator on the right to food, Michael Fakhri, has found that israel has carried out a campaign of starvation against the Palestinian people since the beginning of the genocide. Fakhri makes clear that the degree of starvation in Gaza is both unprecedented and catastrophic. with Gazans making up 80% of the people in the world experiencing famine. The World Food Programme (WFP) further evidences that, as the genocide enters its 12th month, 2.2 million Palestinians are in urgent need of food and livelihood assistance. Your continued insistence on remaining invested in the Zionist entity means that the University of Michigan has a hand in the starvation and potential death of every man, woman, and child in Gaza. Additionally, the UN Special Representative on sexual violence reports that Palestinian men and women are being subjected to "widespread sexual slurs and threats of rape and gang rape, repeated and humiliating strip searches and prolonged forced nudity, beatings and electrocution of genitals and anus, insertion of objects into detainees' anuses, inappropriate touching of women by both male and female soldiers, and photographing or filming of naked or partially undressed detainees in humiliating positions." This amounts to the use of sexualized torture in the IOF's prison camps.

As we write today, israel's American-funded war machine sets its eyes on the West Bank as it aims to advance its settler colonial project. Since the beginning of its attack on the Jenin governorate, Tubas, and the al-Faraa refugee camp, 36 Palestinians have been murdered, and untold infrastructure devastation has been left in its wake. As we return to school here at the University of Michigan, we must remind you that there is no return to school for the 630,000 children of Gaza. In an attempt to destroy the very fabric of Palestinian life, the Zionist entity has destroyed every university in Gaza and rendered all 200 UNRWA-run schools inoperable. Every child has a right to education. Given the University's continued investment in the israeli terror machine, must the luxury of education here at the University of Michigan come at the cost of that same right for Gaza's children? As time goes on, it becomes clear that you, the Regents and President Ono, are proud of your legacy of violence both here on campus and abroad in the West Bank and Gaza. As the new year begins, we will not forget that the University unjustly and illegally canceled a student referendum on divestment last November and has wholly neglected SACUA's resolution to investigate the ethics of israeli investments, passed last January. We won't forget that a 2021

Worker Rights Consortium report found that garment workers at Hong Seng Knitting, a U-M supplier factory through our \$173.8 million Nike contract, had \$800,000 worth of wages stolen from them, yet your commitment to the Nike contract remains ironclad.

Your ability to performatively advocate for democracy is called further into question as you issue top-down directives that ignore faculty expertise and student input, holding the University's

'values' hostage to the influence of politicians and donors. We are appalled that you unilaterally passed an amendment to The Statement of Student Rights and Responsibilities, which entirely undercuts the purpose of OSCR. The conflict resolution process is intended to be a genuine fact-finding endeavor, bringing just and equitable solutions to concerned students, not a disciplinary division where the amorphous institution of "The University" can act as a dictator and enact punishments without due process against dissenting activists. We find this especially hypocritical amidst your proclaimed "Year of Democracy, Civic Empowerment, and Global Engagement". Dissent and protest is a form of civic empowerment and your repression of that dissent is in violation of your so-called university 'values'. The University's hire of Omar Torres of Grand River Solutions—who has jumped from university to university in a crusade to prosecute students advocating for divestment—proved to be a disastrous investment, as he evidently was not intent on resolving conflict or undoing harm but was concentrated on carrying out carceral punishment. Furthermore, the disruptive action policy that was opposed by a litany of faculty and student organizations is now being discreetly enforced. The University has entirely disregarded community concerns criticizing DAP, as recent official University communications intimidate faculty into withholding "polarizing viewpoints" and encourage students to "call 911" on protesters—an egregious misuse of emergency lines. Additionally, University-directed DPPS continues to enforce brutal police violence against the campus community, rather than address dissent through representative means that make space for the hundreds of student organizations to voice their collective demand for divestment.

With an \$18 billion+ endowment, no Michigan student should ever be housing insecure, hungry, or forced to choose between doing their homework or clocking in for another underpaid student job to buy basic necessities. Every investment is political; every policy crafted at your discretion is conceptualized to safeguard the status quo. In a year of so-called 'democracy and civic engagement,' we unequivocally rebuke you and the suit-and-tie systemic loyalists in University administration who consistently show their true colors as dictators of our campus, pledging allegiance to profits while turning their backs on the people. These people are the heart of the Michigan community—students, faculty, staff, workers, and community members—and deserve the power to shape the University's direction and build a future that reflects and supports their needs.

We know the only way you can repress the divestment movement is to jail and surveil dissenters or foster division among organizers, hoping the movement self-destructs. Your efforts will prove futile; your evils will forever stain this University, and we will remain resolute in our mission to support the global struggle against imperialism and spearhead the demilitarization, decolonization, and liberation of our campus.
