On the recommendation of Charles A. Parkos, M.D., Ph.D., the Carl V. Weller Professor and Chair of the Department of Pathology, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Chang Hwan Kim, Ph.D. as professor of pathology, with tenure, effective December 18, 2017, and as the Kenneth and Judy Betz Research Professor for Food Allergy Research, Medical School, effective December 18, 2017 through August 31, 2022.

Academic Degrees:

Dr. Kim received a bachelor of science and master's degree in molecular biology from the Korea Advanced Institute of Science and Technology, Daejeon Korea. He received his Ph.D. in immunology from Indiana University in 1998.

Professional Record:

Dr. Kim completed a fellowship in immunology at Stanford University from 1999 to 2002. He subsequently joined the Department of Comparative Pathobiology at Purdue University as an assistant professor of immunology in 2002. He rose through the ranks to professor in 2010 and became head of the immunology program there in 2011.

Summary of Evaluation:

Dr. Kim's research has focused on understanding the development of pathogenic immune responses, the impact of microbial metabolites and their regulation of immune cells, and homing of immune cells to mucosal sites for the development of mucosal immune responses. Dr. Kim's early career work identified chemokine and chemokine receptors that directed the migration of immune cells to the site of inflammation and disease. In particular, Dr. Kim demonstrated how chemokines and their receptors organize lymphocyte trafficking into lymphoid organs to regulate immune responses. Subsequently, Dr. Kim's research began to focus on the role of vitamin A (retinoic acid) and regulation of T cell phenotypes in the in gut mucosa to balance inflammation induced damage. Most recently, Dr. Kim has been extensively involved in examining roles that the host and microbe-derived metabolites have on the development of inflammatory disease, particularly with the gut-homing of Innate Lymphocyte Cells (ILCs). In addition, Dr. Kim has been extremely successful working with teams of researchers, nationally and internationally, examining complex immune

responses and various mucosal diseases. Dr. Kim is recognized internationally for his research and has published great than 90 peer-reviewed manuscripts in high impact journals with over 9000 citations. The findings derived from Dr. Kim's research have had and will continue to have a significant impact on the field of immunology and human disease. His work has continuously been funded at high levels from external sources, including the NIH, and he has been invited to present his work numerous times at national and international venues.

Dr. Kim's teaching activities have included didactic and laboratory instruction to graduate, medical, and veterinary students. He has served as the course director for "Principles of Human Immunology" since 2003, developed the "Special Topics in Immunology" course for graduate students, taught advanced immunology and created a formal immunology journal club course. Dr. Kim was appointed as the director of graduate programs for veterinary medicine at Purdue University in 2016.

#### External Reviewers:

Reviewer A: "He has been funded continuously through grants from the NIH, the Leukemia and Lymphoma Society, as well as smaller intramural grant support....His 2015 publication in the journal *Immunity* is one of the strongest publications based on impact and impact factor, however, it is the continued generation of high-quality research publications that stands out as a very strong record of achievement."

Reviewer B: "...Dr. Kim's research has been recognized internationally for its quality and its impact on our understanding of homing and differentiation of immune cell subsets, as well as host response to commensal microbes....Dr. Kim has a solid record of service at his institution and at national and international grant review panels."

Reviewer C: "...his major findings that microbiota production of short-chain fatty acids drives production of IgA and T-reg development are very highly regarded in terms of both helping advance basic understanding of host defense and have proven germane to human health, namely in understanding how consumption of dietary fibers impacts inflammation and cancer...Lastly, I would submit that U. of M. should be a great environment for Dr. Kim's work and, moreover, that he will

add to this environment and fill a key niche in bridging the understanding of how diet influences mucosal immunity and how the latter influences intestinal disease development.”

Reviewer D: “He has a terrific body of work and numerous speaking invitations and a focused track record in the area of Tregs that has matured to more general work on mucosal immunology. His H-index of 52 and numbers of publications in excel of 100 all indicate a productive, quality program....you have managed to recruit a world-class immunologist who appears to be a model citizen and is heavily involve in graduate education and has a track record of significant NIH funding. Congratulations!”

Reviewer E: “Dr. Kim is an extraordinary immunologist with a publication list of ~ 100 scientific articles (over 9500 google citations and h-index of 52) in prestigious journals...In addition, Dr. Kim was invited as a speaker in numerous seminars and conferences, and received a number of honors and awards for his excellent research during his career.”

Dr. Kim’s service includes his role as program leader of the Purdue Institute of Inflammation, Immunology and Infectious Diseases, and as section head of Microbiology, Immunology and Molecular Genetics. He has served as a grant reviewer for the Italian Ministry of Health, and the National Medical Research Council in Singapore. Dr. Kim has served on 14 NIH study sections, as well as on an American Heart Association study section. He is the associate editor for *Frontiers in Cellular and Infection Microbiology* and *Endocrine, Metabolic and Immune Disorders*. Dr. Kim is the academic editor for *PLoS One*, and is the U.S. deputy editor for *Immune Network* for the Korean Association of Immunologists.

Summary of Recommendation:

Dr. Kim is a nationally and internationally renowned immunologist and investigator with scholarship which has shaped the field of mucosal immunology. I enthusiastically recommend the appointment of Chang Hwan Kim, Ph.D. as professor of pathology, with tenure, effective December 18, 2017, and as the Kenneth and Judy Betz Research Professor for Food Allergy Research, Medical School, effective December 18, 2017 through August 31, 2022.

With the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of James H. Morrissey, Ph.D. as professor of biological chemistry, with tenure, and professor of internal medicine, without tenure, Medical School, effective October 1, 2017.

Academic Degrees:

Dr. Morrissey received a master's in developmental biology in 1975 from the University of California, Irvine and a Ph.D. in biology from the University of California, San Diego in 1980.

Professional Record:

Dr. Morrissey was a post-doctoral fellow in the Department of Biochemistry at the University of Oxford from 1981 to 1983. He subsequently finished a one-year senior post-doctoral fellowship at the Scripps Research Institute. He remained there as an assistant member in the Immunology Department. From 1989 to 2000, he held faculty positions at the Oklahoma Medical Research Foundation and the University of Oklahoma Health Sciences Center. In 2000, he moved to the University of Illinois at Urbana-Champaign (UIUC) as a professor of biochemistry and served as the department chair from 2013 to 2014. Since 2012, he has held the title of the Roy & Eva Hong Professor of Molecular and Cellular Biology at UIUC.

Summary of Evaluation:

Dr. Morrissey's primary research interest involves the investigation of how the blood clotting cascade is regulated, with applications to thrombotic diseases, bleeding disorders, and inflammation. His lab has not only uncovered mechanisms of clotting enzyme serine protease structure and activity, but is also investigating how the blood clotting serine proteases assemble with specific proteins on membrane surfaces and how membrane phospholipid components interact and regulate the blood clotting cascade. More recently, the Morrissey lab has discovered that polyphosphate is secreted from human platelet-dense granules and stimulates blood coagulation. Polyphosphate acts in part by enhancing thrombin generation through its actions on multiple points in the coagulation cascade. Importantly, the Morrissey lab has identified high affinity inhibitors of polyphosphate that may represent new avenues for combating thrombosis. Dr. Morrissey's lab is also developing a toolkit of high-resolution methods for solving atomic-scale structures and dynamics of lipids that regulate the biological

functions of membranes. Dr. Morrissey has authored 162 peer-reviewed publications to date, many of them in high impact journals including *Blood*, *PNAS*, and the *Journal of Biological Chemistry*. Of note, he holds 18 patents and has been invited to lecture throughout the world.

Dr. Morrissey's primary educational responsibility has been the teaching of biochemistry courses to first-year medical students. He has also taught in graduate and undergraduate courses, and been a dedicated mentor throughout his career. Evaluations from students are glowing and speak of his commitment and creativity in teaching. His teaching abilities were recognized with awards including "Outstanding Advisor of the Year Award" from UIUC, and being named to the "Teachers Ranked as Excellent by their Students" list multiple times.

External Reviews:

Reviewer A: "Dr. Morrissey ranks among a handful of investigators who have made important contributions to our understanding of hemostasis and thrombosis...His service to the community as a member of the HT Study Section from 2011-2017 (Chair from 2014-2016) and in other review functions, meeting organizer (including the recent Gordon Conference on Hemostasis), etc. has been remarkable."

Reviewer B: "The hallmarks of Jim's work have been his ability to identify important problems, see the big picture and make important advances by thinking outside the box...The one area that has had the highest scientific impact in the field relates to his delineation of the numerous roles played by platelet-released polyphosphate in the regulation of coagulation. His contributions that have uncovered this potentially important regulatory mechanism, missed by all others in the hemostasis field, reads like a true research adventure."

Reviewer C: "He is at the top of his field; Michigan can't do much better than to attract him to your institution...I will just tell you that he is an absolutely stellar researcher and is extraordinarily respected in our field. Of late, his research on platelet polyphosphates has been a game changer, as is the case with much of his research...He has the potential for National Academy status and more. Best of luck in this magnificent recruitment."

Reviewer D: "His stature in hemostasis research is reflected in his many invited talks throughout the world, his service on study sections, his committee responsibilities for a many professional societies, and his experience on the editorial boards of several major journals. The recent award of an R35 grant from NHLBI is another sign of the respect shown to him for his scientific contributions....Dr. Morrissey is a creative scientist who is careful, tenacious, and extraordinarily productive. I feel strongly that his future studies will continue to yield important biochemical insight into the regulation of hemostasis."

Reviewer E: "When we recently started work on neutrophil extracellular DNA traps (NETs), he was working on similar material the polyphosphates released from platelets. He demonstrated that they promote clotting and clot stability, similarly to NETs. Needless to say, I found this research extremely important and exciting..."

Dr. Morrissey has served on a number of national and international study sections as well as on the editorial boards for *Blood* and the *Journal of Biological Chemistry*. He has held several positions for the International Society of Thrombosis and Hemostasis, and served as chair of the American Society of Hematology Scientific Committee on Hemostasis. He has had considerable institutional service at UIUC including participation on the Postdoctoral Affairs Advisory Committee and the Promotions and Tenure Committee.

Summary of Recommendation:

Dr. Morrissey is an established and leading scientist who has made seminal contributions to the understanding of coagulation and hemostasis with potential clinical applications. He has excelled as a teacher and a leader and has provided service to the research community. I am pleased to recommend the appointment of James H. Morrissey, Ph.D. as professor of biological chemistry, with tenure, and professor of internal medicine, without tenure, Medical School, effective October 1, 2017.

With the approval of the Executive Committee of the College of Literature, Science, and the Arts, we are pleased to recommend the reappointment of Daniel C. Fisher as the Claude W. Hibbard Collegiate Professor of Paleontology, College of Literature, Science, and the Arts, for a five-year renewable term, effective September 1, 2017 through August 31, 2022.

The Claude W. Hibbard Collegiate Professorship in Paleontology was established in the Provost Office and was named in July 2002. Claude Hibbard was a faculty member at the University of Michigan from 1946 until his death in 1973. A stipend funded from college resources accompanies this professorship. Appointments to this professorship may be up to five years and may be renewed.

Professor Fisher is an internationally renowned expert in the paleobiology and extinction of mastodons and mammoths, and in using tooth and tusk compositions to elucidate the paleobiology of proboscideans. The geographic span of his studies includes the Great Lakes region locally, Siberia, and in southern California, where he and his colleagues recently found evidence of human occupation some 130,000 years ago at a mastodon site. This startling discovery, published in *Nature*, is the oldest documented archaeological site in North America and revises the arrival of Homo by more than 100,000 years. In 2015, he led the excavation of the Bristle mastodon skeleton found in Chelsea, Michigan.

Professor Fisher is an exceptional teacher who has long had sole responsibility for the department's core course covering the breadth of paleontology and paleobiology. He has attracted and trained some of the department's most successful graduate students. He also continues his long history of involving undergraduate students in his research. Professor Fisher

has also made numerous, substantial contributions to his research community and to the general public. He is a frequent participant on science committees and advisory boards relating to mammoth sites and research, and currently serves on the editorial board of *PaleoAmerica*. 

On behalf of the College of Pharmacy Executive Committee, we are pleased to recommend the reappointment of Vicki Ellingrod Ringold as the John Gideon Searle Professor, College of Pharmacy, effective December 1, 2017 through November 30, 2022.

The John Gideon Searle Professorship was established by the Regents in October 2012 through a generous endowment gift from Mr. John G. Searle in 1977. It was created in addition to the John G. Searle Professorship and the John Gideon Searle Assistant Professorship, with permission from the Searle family, to utilize the substantial income from the endowment to recognize a promising scholar at the senior level in any discipline within the College of Pharmacy. Appointment periods may be up to five years and may be renewed.

Professor Ringold received her Bachelor of Science degree in 1992 and her Doctor of Pharmacy degree in 1994, both from the University of Minnesota. In 1996, she completed a two-year clinical research fellowship in psychopharmacology at the University of Iowa College of Pharmacy, and she received board certification in psychiatric pharmacy in 1997. Professor Ringold was appointed as the director of the Pharmacogenetics Laboratory at the University of Iowa College of Pharmacy in 1998. She became assistant professor in 1999 and was promoted to associate professor, with tenure, in 2004. She was also appointed as chair of the Clinical Pharmaceutical Sciences Graduate Program. She joined the University of Michigan in 2006 as an associate professor of pharmacy and was promoted to professor in 2012. In 2015, Professor Ringold was appointed as the program director for the Education and Mentoring Group of the Michigan Institute for Clinical and Health Research, and in 2016, she was appointed as the associate dean for research and graduate education in the College of Pharmacy.

Professor Ringold is considered a pioneering leader in the field of psychiatric pharmacogenetics. She is one of only a few clinical pharmacy faculty in the country to conduct research in this area and is one of a very small number of pharmacy translational scientists who have received federal funding for their work. She has published numerous papers in leading scientific journals, and she has had a significant impact on the knowledge in her field.




Professor Ringold is an extremely dedicated and innovative educator whose philosophy is to help students become successful critical thinkers. She utilizes active learning strategies and a team-based learning approach, requiring student preparation prior to class and then offering opportunities to apply what they have learned through in-class discussions and laboratory activities. Professor Ringold is also an outstanding mentor, highly sought after by pharmacy students, research fellows, and other clinical scientists.

Professor Ringold has been an outstanding contributor in terms of service to science, pharmacy, and the university. She is a founding member of the College of Psychiatric and Neurologic Pharmacists, which was established in 1998, and continues to contribute to that organization in many ways, including service as the chair of the Research Committee (2006-2009), secretary of the Board of Directors, and member of the Programming Committee. She has also been very active in the American College of Clinical Pharmacy (ACCP). She was elected to the ACCP Research Institute Board of Trustees for 2010-2014, serving as the president from 2012-2013. Beyond pharmacy, she was appointed to the National Alliance on Mental Illness' Scientific Research Council and is one of only two pharmacists on this committee. Professor Ringold also provides significant service to the University of Michigan through her work with the Depression Center and the Michigan Institute for Clinical and Translational Research. She has been the leading force behind the college's recent faculty development activities, as well as a leader in adopting the college's new team-based learning pedagogy.

We are very pleased to recommend the reappointment Vicki Ellingrod Ringold as the John Gideon Searle Professor of Pharmacy, College of Pharmacy, for a five-year renewable term, effective December 1, 2017 through November 30, 2022.



Scarle Professor and Chair of the Department of Internal Medicine, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Dean E. Brenner, M.D. as the Moshe Talpaz M.D. Professor of Translational Oncology, Medical School, effective October 1, 2017 through August 31, 2022.

The Moshe Talpaz M.D. Professorship in Translational Oncology was established in June 2013 through funds from an anonymous donor. It is intended to support the research and clinical efforts of a tenured faculty member who focuses on translational oncology. Appointment period may be up to five years and may be renewed.


Dr. Brenner is a clinical oncologist and translational cancer researcher whose scientific career has been devoted to translational research in cancer therapeutics with the long term goal of reducing morbidity and mortality from cancer. He has worked to define and address complex components of cancer preventive research including the use of analytical pharmacology, epidemiology, clinical trial design, biomarker endpoints, adherence and recruitment and retention of trial participants. Dr. Brenner has also focused his research in fields of colon and breast cancer prevention. He has identified dose, tissues endpoints, and side effects for a group of drugs and nutritional products that target tissue prostaglandins, key molecules that regulate inflammation in the tissues.

Dr. Brenner and his collaborators at the University of Michigan have focused on creating and using three dimensional organ culture methods that enable long term growth of primary human organoid cultures of colonic adenoma, invasive neoplasms, and normal crypts. He is a successful researcher with funding through the National Cancer Institute, the American Cancer Institute, the Veterans Administration and industry. He has published 180 peer-reviewed articles, and has served on numerous national and international committees, including study sections for the NIH and the NCI,

and as an editorial board member for *Cancer Prevention Research*. Dr. Brenner held the Kutsche Memorial Chair of Internal Medicine from 2005 - 2017.

Dr. Brenner has a strong commitment to advancing clinical care through research. His work has broad clinical translational research application which aligns with that of Moshe Talpaz. I am, therefore, pleased to recommend the appointment of Dean E. Brenner, M.D. as the Moshe Talpaz, M.D. Professor of Translational Oncology, Medical School, effective October 1, 2017 through August 31, 2022.





Her book, Direct Social Work Practice: Theories and Skills for Becoming an Evidence-Based Practitioner, is widely used and regarded in social work education. Professor Ruffolo is a dynamic researcher and has exhibited innovative leadership skills in curriculum development throughout her career in higher education. This includes work with the Council on Social Work Education, the University of Dayton, Syracuse University, and here at the University of Michigan. Professor Ruffolo has been a key member of the faculty group that has developed the new Clinical Scholars Program, in which selected MSW students, through their coursework and field practicum, focus on “adolescent/child mental and behavioral health” and directly serve high-need populations in Detroit. She was also a key leader in developing the new Community Action & Social Change (CASC) minor for undergraduates, which has been very successful.

Professor Ruffolo was appointed the associate dean for educational programming in January 2017. As associate dean for educational programs, Professor Ruffolo leads the academic programs at the School of Social Work. She has led innovation in instructional technology initiatives within the, including the development of a MicroMaster MOOC in Social Work. Her efforts focus on the development of courses and interdisciplinary web-based certificates using a range of digital and web-based instructional technologies to enhance learning.

Professor Ruffolo is a leader in social work and higher education. I am pleased to recommend the appointment of Mary C. Ruffolo as the Rosemary A. Sarri Collegiate Professor of Social Work, School of Social Work, effective October 1, 2017 through August 31, 2022.

The dean of the School of Nursing, in consultation with members of the Executive Committee and the Administrative Group, is pleased to recommend the appointment of Julia S. Seng as associate dean for strategic affairs, School of Nursing, effective January 1, 2018 through December 31, 2020.

Professor Seng received her Bachelor of Arts and Master of Arts in French degrees from the University of Michigan (UM) in 1983 and 1985, respectively. She received her Bachelor of Science in nursing degree from George Mason University in 1991. She received her Master of Arts in nurse-midwifery and Doctor of Philosophy in nursing degrees from the UM in 1995 and 1999, respectively. Professor Seng is a registered nurse (RN) and Certified Nurse Midwife (CNM). She was appointed as an assistant research scientist at the UM, School of Nursing from 2002-2006; a research investigator in the Medical School, Department of Obstetrics and Gynecology, from 2002-2006; and an assistant research scientist at the Institute for Research on Women and Gender (IRWG) from 2005-2006. In 2006, she was promoted to research associate professor at IRWG and research assistant professor in the Medical School, Department of Obstetrics and Gynecology. She was appointed as an associate professor, with tenure, in the UM School of Nursing in 2008. She was jointly appointed as an associate professor, without tenure, in the College of Literature, Science, and the Arts, Department of Women's Studies, in 2009. She was an interim associate director for research development and administration at IRWG from 2011-2012. She was appointed as an associate professor, without tenure, in the Department of Obstetrics and Gynecology in 2013. She was promoted to professor and research professor in 2015.

Professor Seng's research focuses on the effects of post-traumatic stress disorder (PTSD) on women's health and childbearing. Her projects approach this topic from a variety of perspectives. She used qualitative, participatory action research to understand women's experiences and to inform intervention development. Epidemiological analyses have established that PTSD is associated with pregnancy complications and worse physical health across the lifespan for women. Clinical studies currently are examining neuroendocrine and genetic pathways that link PTSD to preterm birth, lower birth weight, and pregnancy complications. Clinical trial testing of a psychoeducation program for women with abuse-related PTSD, known as the "Survivor Moms' Companion" are underway in the U.S. and Australia. In addition to studying PTSD, Professor Seng is working with collaborators in a new trajectory focusing on studies of oxytocin in relation to health outcomes in women.


Professor Seng is an experienced teacher, having become a nurse after teaching French at the university and high school levels. She is currently teaching in both the UM School of Nursing and the Department

of Women's Studies. She particularly enjoys teaching research methods—for nurse researchers and for non-scientists—including doctoral courses on measurement and qualitative methods. Courses in the women's health doctoral track which she teaches often include students from outside the school, including graduate students in public health, psychology, social work, women's studies, and sociology, living out the university's commitment to interdisciplinary training for students. Students Professor Seng has mentored have been successful at publishing papers on their own or as a member of the research team. Mentees at all levels, from Undergraduate Research Opportunity Program research assistants, to Honors students in Nursing and Biological Psychology, to Master's students in public health, nursing, and social work, to PhD students in nursing and psychology, to junior colleagues contribute from diverse standpoints.

She has received several notable awards/recognitions including the Book of the Year from the American College of Nurse Midwives in 2009, and she became a fellow of the American Academy of Nursing in 2009.

I am very pleased to recommend the appointment of Julia S. Seng as associate dean for strategic affairs, School of Nursing, effective January 1, 2018 through December 31, 2020.



With the approval of the Executive Committee of the School of Social Work, I am pleased to recommend the appointment of Lynn Videka as the Carol T. Mowbray Collegiate Professor of Social Work, School of Social Work, effective October 1, 2017 through August 31, 2022.

The Carol T. Mowbray Collegiate Professorship in Social Work was established through the Provost Office and was named in August 2017. It is intended to honor the distinguished professional academic career of Carol T. Mowbray, professor of social work and a distinguished member of the School of Social Work faculty. In terms of university service, she was a member of the Provost Search Committee, the Ford School of Public Policy's Dean Search Committee. She serves on the Health Science Deans' Council and the Institute for Social Research Executive Committee.

The College of Literature, Science, and the Arts is please to recommend the renaming of an existing unendowed collegiate professorship from the Robert Frost Collegiate Professorship in English Language and Literature to the Robert Hayden Collegiate Professorship in English Language and Literature, College of Literature, Science, and the Arts, effective October 1, 2017.

This professorship was established through the Provost Office and was originally named as the Robert Frost Collegiate Professorship in English Language and Literature in July 1998. Robert Hayden was a faculty member at the University of Michigan from 1969 until his death in 1980. A stipend funded from college resources will accompany this professorship. Appointments to this professorship may be up to five years and may be renewed.

Robert Hayden was born in Detroit in 1913 and educated in local schools before enrolling at Detroit City College where he completed his Bachelor of Arts in 1936. He participated in the WPA Federal Writers Project in the late 1930s. He also attended the University of Michigan where he twice received the Julius and Avery Hopwood Award for poetry (1938, 1942) and completed his Master of Arts in 1944. Professor Hayden studied under W. H. Auden, who directed his attention to issues of poetic form, technique, and artistic discipline. After completing his degree, he was appointed as an assistant professor at Michigan before joining the faculty at Fisk University in 1946 where he remained for 23 years. He returned to Michigan as a professor, with tenure, in 1969.

Professor Hayden was elected to the American Academy of Poets (1975) and was a consultant in poetry at the Library of Congress (1976-1978). He published his first volume of poetry, Heart-Shape in the Dust (1940) and continued to publish nine more volumes from 1948 to 1996. His prose is collected in Collected Prose (University of Michigan Press, 1984). Professor Hayden won the Grand Prize for Poetry at the World Festival of Negro Arts for A Ballad of Remembrance (P. Breman, 1962) and earned the Russell Loines Award from the National Institutes of Arts and Letters.



Professor Hayden distinguished himself as one of the major poets of the postwar generation. His work mirrors the experiences of African Americans as they sought to come to terms with the challenges and opportunities of the period after World War II. Professor Hayden participated in a poetry reading at the White House in 1980. He died in Ann Arbor shortly thereafter.



I am pleased to recommend the establishment of the Glenn F. and Gladys H. Knoll Department Chair in Nuclear Engineering and Radiological Sciences, College of Engineering, effective October 1, 2017.

The College of Engineering is the recipient of a generous gift from Gladys Hetzner Knoll. Each person appointed as chair of the Department of Nuclear Engineering and Radiological Sciences will be known as the Glenn F. and Gladys H. Knoll Department Chair of Nuclear Engineering and Radiological Sciences during the period the appointee holds that administrative position. The resources are to be used at the discretion of the holder to carry out the intended work of the department. Appointments will be made for up to a five-year renewable term.

Upon completing his Ph.D. in the newly established Department of Nuclear Engineering at the University of Michigan in 1962, Professor Knoll joined the nuclear engineering faculty as an assistant professor. He was promoted to associate professor in 1967 and to professor in 1972. He served as the chair of the department for over a decade (1979-1990), and as the interim dean of the College of Engineering during 1995-1996.

Professor Knoll was a superb classroom teacher and a dedicated mentor to numerous undergraduate and graduate students. His highly acclaimed textbook, Radiation Detection and Measurement was used extensively in experimental particle physics and nuclear medicine as well as in nuclear engineering. A measure of his success as a teacher is that many of his 30 doctoral students and numerous other M.S. students assumed leadership positions in academia, industry and national laboratories. His pioneering work in radiation measurement techniques and detector development yielded eight patents in detectors and signal processing. The entire nuclear physics and engineering community benefitted from high-precision neutron cross section data Professor Knoll's laboratory produced over a span of three decades. His creative ideas and techniques for radiation imaging opened a number of new ways to improve the accuracy in diagnosis and reduction in radiation doses for patients undergoing radiation treatment.

In all his administrative duties as department chair and as interim dean of engineering, Professor Knoll served as a forceful leader, who was at the same time, fair and considerate of his colleagues and staff. He made significant and broad contributions to the scientific community,

including the editorship of two prestigious journals, *Nuclear Instruments and Methods in Physics Research* and *IEEE Transactions on Nuclear Science*. He was recognized with numerous awards and honors, including fellow of the American Nuclear Society and Institute of Electrical and Electronics Engineers, a recipient of the Arthur Holly Compton Award of the American Nuclear Society and Glenn Murphy Award of the American Society for Engineering Education. He was elected a member of the National Academy of Engineering in 1999.

In recognition of this significant gift from Gladys Hetzner Knoll, I am pleased to recommend the establishment of the Glenn F. and Gladys H. Knoll Department Chair in Nuclear Engineering and Radiological Sciences, College of Engineering, effective October 1, 2017.

In the September 2017 Regents Communication requesting to rename an existing unendowed collegiate professorship, we mistakenly noted the name of the collegiate professorship as Vijayan N. 

We are pleased to recommend the renaming of an existing unendowed collegiate professorship from the Arthur W. Burks Collegiate Professorship in Information and Computer Science, to the Karl E. Weick Collegiate Professorship in Information, School of Information, effective January 1, 2018.

This professorship was established through the Provost's Office and was named as the Arthur W. Burks Collegiate Professorship in Information and Computer Science in June 2000. The renaming of this professorship recognizes Professor Karl E. Weick as a distinguished scholar whose work influenced many in the School of Information. Appointments to this professorship may be up to five years and may be renewed.

Karl E. Weick is an internationally-recognized scholar in the area of organizational behavior. His work on sensemaking in organizations, the characteristics of high reliability organizations, and organizational learning is regarded as seminal in the several disciplinary communities, such as psychology, business, and information. He authored multiple prize winning articles and books, including The Social Psychology of Organizing (1969), named one of the nine best business books ever written by *Inc. Magazine* in 1996, and Managing the Unexpected: Assuring High Performance in the Age of Complexity (2001) (co-authored by Kathleen Sutcliffe) which received the Best Book of the Year Award from HR.Com in 2002. For his significant research adding conceptual, empirical, and theoretical developments to the field, Professor Weick received the Irwin Award for Distinguished Scholarly Contributions from the Academy of Management in 1990.

Professor Weick joined the University of Michigan in 1988 with appointments as a professor of organizational behavior and industrial relations and a professor of psychology. He also held the title of Rensis Likert Collegiate Professor of Organizational Behavior and Psychology which was changed to the Rensis Likert Distinguished University Professor of Organizational Behavior and

Psychology in 2001. He retired from active faculty status in May 2012 and is now a professor emeritus of organizational behavior and professor emeritus of psychology.







Professor Stern has requested that a portion of her tenure transfer into the Department of History. This will provide an appointment structure that more closely fits and supports her current intellectual and interdisciplinary research, teaching, and scholarly interests. She contributes intellectually and through leadership to professional societies such as the Organization of American Historians (for which she is a distinguished lecturer) and the American Association for the History of Medicine (serving as an elected member of the National Council).

Professor Stern is committed to being an equally productive member and citizen of history. She is already quite active in history as a member or co-chair of the department's dissertation committees and as a supervisor of its honors' theses. She has also served on tenure and promotion panels and is a core faculty member and active participant in the Science, Technology and Society (STS) program, which is housed in the Department of History. Professor Stern participated in the creation of the medicine and public health minor, and one of her courses (Health in America, HIST 356) has been a popular choice for students pursuing this minor.

Professor Stern is conducting interdisciplinary research funded by the National Institutes of Health and the National Endowment for the Humanities. This work incorporates historical, epidemiological, and digital approaches to topics related to health and human rights, and she seeks to connect history to emergent trends in Public Humanities, Digital Studies, and Health Humanities.


