With the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Debra F. Weinstein, M.D. as executive vice dean for academic affairs, Medical School, effective November 15, 2021.

In this capacity, Dr. Weinstein will provide executive leadership to the Medical School and Michigan Medicine. She will be responsible for strategic development, operational oversight, and budgetary accountability. Additionally, she will collaborate with the leadership from the clinical and research enterprises to ensure that the education, research, and clinical missions are aligned.

Debra Weinstein received her M.D. degree in 1984 from Harvard Medical School. Followed by an internal medicine residency at Massachusetts General Hospital and fellowship in Gastroenterology at Harvard Medical School. In 1989, she joined the Harvard Medical School faculty as an instructor in the department of medicine and rose through the ranks to her current position as associate professor.

Dr. Weinstein has considerable administrative experience having served as the director of graduate medical education and the vice president for medical education at Partners HealthCare System. Nationally, she has served as chair of the Journal Oversight Committee for the American Council of Graduate Medical Education and as the chair for multiple planning committees for the National Academies of Science. Dr. Weinstein also served as the deputy editor of *Academic Medicine* for six years.

It is the judgment of the Executive Committee that Dr. Weinstein is well qualified to serve in this administrative capacity. I am, therefore, pleased to recommend the appointment of Debra F. Weinstein, M.D. as executive vice dean for academic affairs, Medical School, effective November 15, 2021.
