On the recommendation of Bishr Omary, M.D., Ph.D., the H. Marvin Pollard Professor of Gastroenterology and Chair of the Department of Molecular and Integrative Physiology, and Timothy R.B. Johnson, M.D., the Arthur F. Thurnau Professor, the Bates Professor of the Diseases of Women and Children and Chair of the Department of Obstetrics and Gynecology, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Michael N. Lehman, Ph.D. as professor of molecular and integrative physiology, with tenure, and professor of obstetrics and gynecology, without tenure, Medical School, effective December 1, 2010. Dr. Lehman also will hold an appointment as research professor in the Reproductive Sciences Program, Medical School.

Academic Degrees:

Dr. Lehman received the Ph.D. degree in neurosciences from the University of Michigan in 1982.

Professional Record:

Dr. Lehman was a postdoctoral scholar in the Reproductive Endocrinology Program at the University of Michigan from 1982 to 1983. He was appointed as an associate research scientist in the Department of Anatomy and Cell Biology at Columbia University from 1983 to 1986. In 1986, he was appointed as an assistant professor in the Department of Anatomy and Cell Biology at the University of Cincinnati and rose through the ranks to professor, with tenure, in 1994. In 2005, Dr. Lehman was named professor and chair of the Department of Anatomy and Cell Biology at the Schulich School of Medicine and Dentistry at the University of Western Ontario.

Summary of Evaluation:

Dr. Lehman is an internationally recognized neuroscientist whose research focuses on two aspects of neurobiology: reproductive neuroendocrinology and circadian rhythms in mammals. He has published over 120 peer-reviewed papers, as well as several book chapters and reviews in high profile journals. He is the principal investigator on two R01 awards, and has been well funded by the National Institutes of Health, the National Science Foundation, and Canadian agencies for more than 20 years. Additionally, Dr. Lehman has served on several NIH and NSF grant review panels.

Dr. Lehman's teaching contributions are outstanding. He established a four-year interdisciplinary neuroscience medical curriculum at the University of Cincinnati, serving as course director and coordinator from 1988-1996. He also served as director of the neuroscience graduate program at that institution from 1994-2005, and was the principal investigator of an NIH predoctoral training grant of that program. While at the University of Western Ontario, Dr. Lehman developed a graduate training program in clinical anatomy. He has supervised a number of graduate students and postdoctoral fellows, and served as lecturer or preceptor to an impressive number of graduate programs while he was chair of the Department of Anatomy and Cell Biology. Dr. Lehman is expected to serve an important role in graduate and medical education at the University of Michigan.

External Reviews:

Reviewer A: "One of the things that is extremely impressive about Mike is his productivity. Even as Chair of his department, he still has the time and excellence to publish numerous papers each year in respected peer-review journals...Mike has a record of continuous NIH funding for decades...I have complete confidence that Mike will be able to continue his excellent record of extramural funding...While I understand that this appointment is for the position of Professor, I encourage you to keep in mind appropriate administrative roles for Mike because this is another area that he truly excels."

In my opinion, Dr. Lehman ranks in the top 10% of researchers in his field."



Dr. Lehman has an exemplary record of service and leadership. He was the neuroscience program director at the University of Cincinnati, and associate dean for the neuroscience center. He has played leading roles in a large number of professional societies including the Society for Neuroscience, Association of Medical School Neuroscience Department Chairpersons, and the American Society of Anatomists. Dr. Lehman has served on a number of review boards and study sections, and was president of the Association of Neuroscience Departments and Programs.





The Dean and Executive Committee of the School of Public Health are pleased to recommend the reappointment of Marc A. Zimmerman as chair, Department of Health Behavior and Health Education, School of Public Health, effective January 1, 2011 through December 31, 2013.


Professor Zimmerman received a Bachelor of Science (psychology) from the University of Massachusetts in 1976, a Master of Science from the University of Oregon in 1980, and a Ph.D. (community psychology) in 1986 from the University of Illinois. From 1986 to 1988, he held the position of assistant professor in the School of Public Affairs at the American University in Washington D.C. From 1988 to 1989 he had a Congressional Fellowship from the American Association for the Advancement of Science. Professor Zimmerman joined the faculty at the University of Michigan as assistant professor of health behavior and health education in 1989, was promoted to associate professor in 1999, and to professor in 2001. He was appointed as an associate professor in the Department of Psychology in 1999 and was promoted to professor in 2002. Professor Zimmerman has served as chair of the Department of Health Behavior and Health Education since January 2005.

Professor Zimmerman has a well-deserved international reputation in the field of health behavior and health education and in his parent discipline of community psychology. His courses consistently receive excellent evaluations and he is a conscientious mentor to both masters and doctoral students. Professor Zimmerman's research focuses on health and resiliency of adolescents, and on empowerment theory. His work on adolescent health examines how positive factors in adolescent's lives help them overcome risks they face. His research includes analysis of adolescent resiliency for risks associated with alcohol and drug use, violent behavior, precocious sexual behavior, and school failure. He is also studying developmental transitions

and longitudinal models of change. Professor Zimmerman's work on empowerment theory includes measurement and analysis of psychological and community empowerment. The research includes both longitudinal interview studies and community intervention research. Professor Zimmerman is the director of the CDC-funded Prevention Research Center of Michigan. He is the editor of *Youth and Society* and is a member of the editorial board for *Health Education Research*.



On the recommendation of the Dean and Executive Committee of the School of Public Health, and with the endorsement of the Medical School, we are pleased to recommend the joint appointment of Charles Burant, M.D., Ph.D. as professor of environmental health sciences, without tenure, School of Public Health, effective January 1, 2011.

Dr. Burant received an M.S. in toxicology in 1981 from the University of Wisconsin. In 1987, he received his M.D. and his Ph.D. from the University of South Carolina. From 1989-91, he was a fellow in endocrinology at the University of Chicago where he also served as an assistant professor from 1992-1998. Dr. Burant joined the University of Michigan faculty as an associate professor in 2001 and was promoted to professor in 2006. In 2006, he was named the Robert C. and Veronica Atkins Professor of Metabolism. He is currently director of the Michigan Metabolomics and Obesity Center (MMOC).

Dr. Burant's joint appointment in the environmental health sciences (EHS) is one of a set of five joint, courtesy appointments being requested for colleagues who will provide the essential, strategic interdisciplinary expertise and leadership in research and training necessary to revitalize the human nutrition program in the Department of Environmental Health Sciences. He was a member of the search committee for the human nutrition program that led to the recruitment of Drs. Peterson, Dolinoy, Baylin and Villamor and he has systematically and energetically created research and training collaborations to support the growth of human nutrition at the School of Public Health. Dr. Burant's research and training activities are an essential basis for mounting a T32 interdisciplinary training grant in nutrition in 2011, an effort he will co-lead with Dr. Peterson as PI. In addition, he will continue to provide guest lectures and facilitate seminar courses in EHS. He has served as an informal advisor and mentor to students in the human nutrition program.

With a joint appointment in EHS, Dr. Burant will be able to serve as a primary advisor or a member of research committees for the growing number of M.S. and Ph.D. students affiliated with human nutrition, particularly those focusing on metabolism, obesity and/or chronic disease outcomes relevant to nutrition, toxicology and environmental epidemiology in adults.





She also serves as a research investigator at the Ann Arbor VA Center of Excellence in Health Services Research & Development.

Professor Hawley is a nationally-recognized expert in the field of cancer health services research and cancer-related decision aids. She is well published and also has an impressive track record in terms of NIH funding. She has several current projects with Steven Katz, M.D. and Jennifer Griggs, M.D., both of whom have joint appointments in health management and policy. In addition, Professor Hawley and Professor Paula Lantz, chair of the Department of Health Management and Policy, have collaborated on some publications regarding surgical treatment decision-making among breast cancer patients, and expect to do more work together in the future. A joint appointment will strengthen existing research connections, and also enhance potential new connections with other departmental faculty. In addition, Professor Hawley is willing and eager to assist in our teaching mission. She would like to be a guest lecturer in courses and serve on dissertation committees as appropriate. She also has offered to provide a training seminar on NIH grant writing and the review process for our doctoral students and post-doctoral fellows.

Professor Philbert earned his Bachelor of Science degree in 1984 from the College of Arts and Technology in Cambridge, United Kingdom, and his doctorate from the London University Royal Postgraduate Medical School in London, UK in 1987. He was awarded a postdoctoral fellowship in the Neurotoxicology Laboratories at Rutgers University from 1988 to 1990. Following that he was appointed as a research assistant professor, in Rutgers's Neurotoxicology Laboratories.


In 1995, he joined the University of Michigan faculty in the School of Public Health as an assistant professor of toxicology. A promotion to associate professor followed in 2000 and to professor in 2004. He was appointed as associate chair for research and development in the Environmental Health Sciences Department from 2000 to 2003. Beginning in 2004, in his role as senior associate dean for research, Professor Philbert managed a major building and renovation project at the School of Public Health, while maintaining oversight of a broad range of administrative responsibilities in the school. He also served as interim director of the Center for Risk Science and Communication from 2004 to 2010.

Professor Philbert is a highly regarded researcher, having maintained a continuously federally funded portfolio of basic research activities throughout his career. Most recently his work has been funded by the National Institutes of Health, the Department of Air Force, and the National Cancer Institute. At the national level, he is recognized for his expertise in neurotoxicology and experimental neuropathology. He is engaged in the development of optical nanosensors for

intracellular applications in *in vitro* toxicology and dynamic platforms for the early detection and treatment of brain tumors. His work has resulted in two important patents and two patents pending. Professor Philbert is the author of numerous research publications in top peer-reviewed journals, and one book. Among his professional affiliations, Professor Philbert served as the vice chair of the National Research Council Committee for the Review of the Federal Strategy to Address Environmental, Health, and Safety Research Needs for Engineered Nanoscale Materials, and chaired the FDA Science Board Committee on Bisphenol A. He served on the National Advisory Environmental Health Council of the National Institute of Environmental Health Sciences and provides consultation to federal agencies on a variety of issues surrounding emerging nanotechnologies. He is a standing member of the US FDA Science Advisory Board and the US EPA Board of Scientific Counselors.

I am very pleased that Professor Philbert is assuming this vital leadership role in the School of Public Health. I am confident that he will provide impressive leadership for the School of Public Health, strengthening an already excellent school. I am pleased to recommend his appointment, effective January 1, 2011.






It is recommended that Penny F. Pierce be granted a two-year leave of absence, effective January 1, 2011 through December 31, 2012.

With the concurrence of the School's Executive Committee, we are pleased to recommend the establishment of the Irwin M. Rosenstock Collegiate Professorship in Public Health in the School of Public Health. A stipend funded by School resources will accompany this professorship.

Professor Rosenstock was appointed as an associate professor in the School of Public Health in 1961 and was promoted to professor in 1965. He provided leadership in developing the School's research and teaching program in health behavior and health education, and participated in the creation of the Department of Health Behavior and Health Education in 1975, which he chaired from its inception until 1983. Professor Rosenstock retired in 1987. He was a highly regarded teacher and mentor for hundreds of students in the School of Public Health. Professor Rosenstock was internationally known for being one of the developers of the Health Belief Model, a theory to explain health-related behavior. This model has inspired thousands of research studies both in the United States and abroad, which have contributed substantially to interventions aimed at altering behavior to improve health status. He served as a consultant to national, state, and local voluntary and professional organizations.

Professor Rosenstock's outstanding contributions to the field, his dedication to the School of Public Health, and his commitment to students are among the many reasons why establishing this professorship in his honor is appropriate.

In July 1999, the Regents approved the creation of a new position, vice provost for international affairs and director of the International Institute. Prior to that, the position had been more narrowly defined as director of the International Institute, with a reporting line to the dean of LS&A. At its inception, the new vice provost and director position was filled by Professor Michael Kennedy, followed by Professor Mark Tessler in July 2004. Professor Tessler's appointment was extended in June 2009 for an additional four years through June 30, 2013.


With the increasing emphasis on global engagement throughout the campus, the need for coordination and leadership at the central University level has surpassed what can be accomplished by an individual serving in a part-time capacity. To address this problem, the vice provost for international affairs and the director of the International Institute will be separated into two full-time positions, effective on January 1, 2011. The vice provost will report to the provost and the director of the International Institute will report to the dean of LS&A.

Professor Mark Tessler has agreed to serve out the remainder of his term as the vice provost for international affairs. In this expanded, full time role, he will be responsible for providing campus-wide leadership to advance global engagement by the University of Michigan. He will coordinate and promote the academic components of the University's international activities, including: promoting international activities and drawing attention to global engagement; pursuing opportunities for enhanced international relationships and global engagement; providing central coordination in support of unit and faculty-driven initiatives; publicizing

U-M's accomplishments; and working closely with advisory committees to the provost and academic units whose work is centrally involved in global engagement.

We respectfully request that the position vice provost for international affairs and director of the International Institute, be changed to vice provost for international affairs, effective January 1, 2011, and that Professor Mark Tessler assume the role on that date.

I am pleased to recommend the appointment of Vahid Lotfi as acting dean for the School of Management effective November 1, 2010.


