With the endorsement of the Executive Committee of the School of Nursing, I am pleased to recommend the appointment of Debra L. Barton as professor of nursing, with tenure, effective January 1, 2014, and as the Mary Lou Willard French Professor of Nursing, School of Nursing, effective January 1, 2014 through December 31, 2016.

ACADEMIC DEGREES

Professor Barton received her bachelor's degree in social work from the University of Illinois, Champaign-Urbana in 1979. She received her associate's degree in nursing from Parkland College in 1985; her masters of science in nursing, adult health from the University of Illinois, Champaign-Urbana in 1991; and her PhD in nursing from Indiana University in 2002.

PROFESSIONAL RECORD

Professor Barton held the title of assistant professor of oncology at the Mayo Clinic, Rochester, MN from 2003-2007. She was promoted to associate professor of oncology, with tenure, at the Mayo Clinic Rochester, MN in 2007. She has been a clinical research scientist at the Mayo Clinic Comprehensive Cancer Center in Rochester, MN since 2005, and a nurse administrator in the Division of Nursing Research at the Mayo Clinic in Rochester, MN since 2011.

SUMMARY OF EVALUATION

Professor Barton is a consummate researcher who is highly committed to advancing the science of symptom management in patients with cancer. She has advanced the frontier of knowledge by examining the underlying physiology of symptom presentation, and tested both pharmacologic and complementary treatments for reducing symptom distress. In the last 11 years Professor Barton has been the principal investigator (PI) or co-PI on 15 studies supported by the National Cancer Institute's (NCI) National Cancer Clinical Trials Network. In addition she has been the

PI on two studies funded by the Breast Cancer Research Foundation, one R21 funded by the NCI, one funded by the American Society of Clinical Oncology (ASCO) and one funded by the Department of Defense. She is a clinical investigator, and has been a PI or co-PI on at least 25 clinical trials. These are important and practice changing trails, which have already led to high impact publications.

Professor Barton regularly disseminates her findings at scientific meetings and through publications in well-established major journals as well as smaller specialty journals. Professor Barton publishes in a wide array of journals including some of the most respected journals in oncology: *Journal of Clinical Oncology*, *Journal of National Cancer Institute*, *Clinical Pharmacology and Therapeutics*, *Cancer*, *Supportive Cancer Care*, and *Oncology Nursing Forum*. She has published 84 peer reviewed papers since 1991, with 71 of these being published since obtaining her PhD in 2002. Of the 71 publications, 24 are as first author. She also has seven book chapters, four as the first author. In addition to strong research productivity, Professor Barton's publications have had major impact both in quality and quantity. In addition to her publications Professor Barton is regularly invited to present at scientific meetings, research seminars and other forums and has given 54 presentations. Most of these presentations (34) were at national conferences sponsored by the Oncology Nursing Society (ONS), and the ASCO, both major professional oncology organizations. This is an impressive track record and it speaks to the relevance of her science.

Professor Barton has a reputation for excellence as a researcher and her work is recognized by her peers at the national and international level. She is a fellow in the American Academy of Nursing, an honor that is based on her contribution to the field. Professor Barton's expertise as a scientist is recognized by her appointment to multiple National Institutes of Health (NIH)/Federal review panels.

Professor Barton's employment has been based mainly in clinical settings rather than educational settings. With this non-traditional background, Professor Barton has the potential to expand the diversity of our faculty and to enrich the learning experience for our students. Her teaching experience in nonacademic settings certainly speaks to her ability to teach. Professor Barton has been the member of two dissertation committees and mentored junior scientists including three masters committees, two other health professionals (KL2, concept development), and five nurse scientists. Her extensive experience in speaking to professional scientific audiences and her expertise as a researcher will enable her to fulfill the teaching expectations at the University of Michigan.

Professor Barton is an outstanding citizen of the nursing community and has made impressive contributions to the nursing profession, and to the broader scientific community. Most notably she has established a track record as a leader in scientific organizations at the national level including being a peer reviewer for the NIH, and leader within the ONS. She served as a leader in the American Society of Clinical Oncology, an interdisciplinary scientific organization with more than 30,000 members, most recently as a track leader on the Scientific Planning Committee for the annual meeting (2012). She has been active in the Alliance for Clinical Trials in Oncology, a national clinical trials network sponsored by the NCI that consists of nearly 10,000 cancer specialists at hospitals, medical centers, and community clinics across the United States

and Canada. She was vice chair of the Symptom Intervention Committee and member of the concept review committee.



On the recommendation of the Dean, and with the endorsement of the Executive Committee of the A. Alfred Taubman College of Architecture and Urban Planning, we are pleased to recommend the appointment of Sharon H. Haar as professor of architecture, with tenure, A. Alfred Taubman College of Architecture and Urban Planning, effective January 1, 2014.

ACADEMIC DEGREES

Sharon H. Haar received her Bachelor of Arts from Wesleyan University in 1984 and her Master of Architecture from Princeton University in 1988.

PROFESSIONAL RECORD

Professor Haar joined the faculty at the University of Illinois at Chicago as an assistant professor in 1996. She was promoted to associate professor, with tenure, in 2003 and to professor, with tenure, in 2012.

SUMMARY OF EVALUATION

Professor Haar is an architect and scholar whose current research investigates the role of entrepreneurship, design innovation, and global networking in the transformation of architectural practices devoted to social activism and humanitarian relief. Her books include: The City as Campus: Urbanism and Higher Education in Chicago and Schools for Cities: Urban Strategies which have established Professor Haar among our most important urbanists concerned with the social and design issues of educational institutions. From elementary schools to research universities, Professor Haar has explored the ways in which city and school interpenetrate, and, at their best, mutually reinforce each other. The university campus is a strangely overlooked topic in the history of American urbanism, so The City as Campus is particularly welcome and original. In addition to her books, Professor Haar's articles and book reviews appear in respected journals including the *Journal of Architectural Education*, the *Journal of Planning Education and Research*, *Architect's Newspaper*, and *Architectural Design*, and her recent book chapters appear in: Embodied Utopias, Shanghai Transforming and On Location: Heritage Cities and Sites. She has presented her research in conferences and lectures across the United States, Latin America, Asia, and Europe. Professor Haar is the recipient of numerous grants from various institutions including the Graham Foundation,

Richard H. Driehaus Foundation, Fannie Mae Foundation, National Endowment for the Arts, and American Architecture Foundation. She is also the former reviews editor for the *Journal of Architectural Education*.

Professor Haar's teaching has explored creatively the intersection of urbanism and globalism. Starting in 2004, Professor Haar has led a series of studios to China, thus exposing her students to global urbanism at its most explosive. Among the many topics her China studio has dealt with are domestic architecture, landscape development, and zoning codes. Professor Haar, moreover, has complemented her China studios with "Chicago studios" that look at Chicago as a global city in its own right. She has taught her students to regard American urbanism not only as an "export" to other countries, but as potentially the product of the "import" of best practices from around the world. In addition to studios, Professor Haar regularly teaches graduate seminars and an undergraduate lecture courses. Both the studios and the classroom courses have received outstanding student evaluations.



The Dean and Executive Committee of the School of Public Health are pleased to recommend the reappointment of Trivellore E. Raghunathan as chair, Department of Biostatistics, School of Public Health, for a one-year term, effective January 1, 2014 through December 31, 2014.

Professor Raghunathan received a B.Sc. in 1977 and a M.Sc. in 1979, both from Nagpur University, India. In 1983, he received a M.S. in statistics from Miami University, Oxford, Ohio. He received a Ph.D. in statistics from Harvard University in 1987.


Professor Raghunathan served as an assistant professor of biostatistics at the University of Washington from 1987-1994. In 1994, he joined the University of Michigan with a primary appointment as an associate research scientist at the Institute for Social Research (ISR) and as an associate professor of biostatistics, without tenure; he was awarded tenure in 2000. Professor Raghunathan is internationally recognized for his research on the statistical analysis of surveys and epidemiological data. His primary research interest is in developing methods for dealing with missing data in sample surveys and in epidemiological studies. He has developed SAS based software, IVEWARE, for performing multiple imputation analysis and the analysis of complex survey data. Other research interests include Bayesian methods, methods for small area estimation, combining information from multiple surveys, measurement error models,

longitudinal data analysis, privacy, confidentiality and disclosure limitations and statistical methods for epidemiological studies. His applied interests include cardiovascular epidemiology, social epidemiology, health disparity, health care utilization, and social and economic sciences.


Professor Raghunathan is highly respected by his colleagues, and provides strong and effective leadership for the department. We endorse, with enthusiasm, the reappointment of Trivellore E. Raghunathan as chair, Department of Biostatistics, School of Public Health, for a one-year term, effective January 1, 2014 through December 31, 2014.

From 1997 to 2012, he was a member of the Law School's Affiliated Overseas Faculty, more recently as a William W. Cook Global Law Professor. He is now a part-time professor of law, currently serving as one of the three third-party judges/arbitrators of the Iran-United States Claims Tribunal at the Hague.

Professor Ratner earned his A.B., *magna cum laude*, from Princeton University in 1982. He received an M.A. from the Institut Universitaire de Hautes Etudes Internationales, Geneva in 1983, and a J.D. from Yale Law School in 1986. After graduation, Professor Ratner worked as an attorney-advisor, Office of the Legal Adviser, U.S. Department of State, and was an international affairs fellow for the Council on Foreign Relations. In 1993, Professor Ratner joined the University of Texas School of Law as an assistant professor in 1993. He was promoted to professor in 1997 and became the Albert Sidney Burleson Professor of Law in 1999. Professor Ratner joined our faculty in September 2004.

Professor Ratner is an internationally respected scholar and teacher of international law, with specific expertise in human rights, the law of war, terrorism, international organizations, and ethnic conflict. In addition to a prolific scholarly record in these fields, Professor Ratner has served as a Fulbright Scholar at the Hague, as a member of the board of editors of the *American*

Journal of International Law, a member of the United Nations Secretary-General's three-person Group of Experts for Cambodia, and more recently as a member of the UN's three-person Panel of Experts on Accountability in Sri Lanka. Watson, M.D., Ph.D. the Ralph Waldo Gerard Professor, and co-directors of the Molecular and Behavioral Neuroscience Institute, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the establishment of the Bernard W. Agranoff Collegiate Professorship in Neuroscience, Medical School, effective December 1, 2013.


This professorship is being established through a generous donation from Ralph F. Colton, friends, family and colleagues of Dr. Agranoff, and departmental gift funds. This professorship will support the research efforts of an exceptional neuroscientist in the Molecular and Behavioral Neuroscience Institute. The appointment period may be up to five years and may be renewed.

Bernard William Agranoff was born in Detroit in 1926. He graduated from Cass Tech High School and entered the Navy, under whose auspices he attended the University of Michigan. Dr. Agranoff received his M.D. from Wayne State University in 1950. After a fellowship at the Massachusetts Institute of Technology, he returned to the Navy, where he served at the U. S. Naval Medical Center in Bethesda, Maryland. Dr. Agranoff was appointed as a research biochemist at the National Institute of Neurological Diseases and Blindness at the NIH from 1954-1960. He discovered cytidine diphosphate diglyceride, a liponucleotide precursor of the membrane lipid phosphatidylinositol. Dr. Agranoff spent 1958 at the Max Planck Institute for Cellular Chemistry with Professor F. Lynen, where he co-discovered the conversion of isopentenyl pyrophosphate to dimethylallyl pyrophosphate, a step in cholesterol biosynthesis.


Dr. Agranoff joined the faculty at the University of Michigan in 1960 with a joint appointment in biological chemistry and the Mental Health Research Institute. He has held the rank of research scientist at the MHRI since 1965, and served as its director from 1985-1995. Dr. Agranoff has received numerous awards, including the Fogarty Scholar-in-Residence at the NIH on an intermittent schedule, and the Ralph Waldo Gerard Professor of Neurosciences at the University of Michigan. He is known as an educator and mentor, and has published over 500 articles. Dr. Agranoff has co-edited all six editions of *Basic Neurochemistry*, and it serves as the authoritative treatise on neurochemistry. In 1996, he initiated the Ralph W. Gerard Summer Program in Laboratory Research for Undergraduate Students.



EFFECTIVE DATE: December 1, 2013

On the recommendation of James O. Woolliscroft, M.D., the Lyle C. Roll Professor and Dean, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the establishment of the Alice Hamilton Collegiate Professorship in Medicine, Medical School, effective December 1, 2013.

This professorship is being established through the Provost's Office. The appointment period may be up to five years and may be renewed.


Alice Hamilton was born in 1869 in New York City. She was raised in Fort Wayne, Indiana. Dr. Hamilton received her M.D. degree from the University of Michigan in 1893 and completed internships at the Minneapolis Hospital for Women and Children, and the New England Hospital for Women and Children. She traveled to Europe to study bacteriology and pathology at universities in Munich and Leipzig from 1895-1897. Dr. Hamilton continued her post-graduate studies at Johns Hopkins University, and moved to Chicago in 1897 where she was appointed professor of pathology at the Woman's Medical School of Northwestern University. She became interested in industrial medicine, which proved to be an understudied discipline in America. Dr. Hamilton published her first article on industrial medicine in 1908. She was then appointed to the first investigative body in the United States in this field, the Occupational Diseases Commission of Illinois.

In 1919, Dr. Hamilton was appointed as an assistant professor in the Department of Industrial Medicine at Harvard Medical School. She was the first woman appointed to the faculty at Harvard, however, felt discrimination because she was a woman; she was excluded from social activities and the all-male graduation processions. From 1924-1930, Dr. Hamilton served as the only woman member of the League of Nations Health Committee. She was the most prominent critic of adding tetraethyl lead to gasoline at the 1925 Tetraethyl lead conference in Washington D.C.

Dr. Hamilton retired from Harvard in 1935 as professor emerita. She served as a medical consultant to the U.S. Division of Labor Standards. In 1944, Dr. Hamilton was included in the list of Men in Science, and in 1947 received the Lasker Award. Dr. Hamilton died in 1970, and was inducted posthumously into the U.S. National Women's Hall of Fame in 1973.


Dr. Hamilton was a trailblazer in the field of occupational epidemiology and industrial hygiene in the United States. This professorship will honor her accomplishments and the advancements she made for all women in science in the United States. I am pleased, therefore, to recommend the establishment of the Alice Hamilton Collegiate Professorship in Medicine, Medical School, effective December 1, 2013.

I am pleased to recommend the appointment of Matthew L. Kaplan as interim director, Center for Research on Learning and Teaching, effective February 1, 2014 and continuing until a new director is hired and can begin his or her appointment.

Mr. Kaplan earned a B.A. cum laude in comparative literature from the State University of New York at Stony Brook in 1983, an M.A. in comparative literature from the University of North Carolina at Chapel Hill in 1985, and a Ph.D. in comparative literature from the University of North Carolina at Chapel Hill in 1993. He has been employed at the University of Michigan's Center for Research on Learning and Teaching (CRLT) since November 1994, and has been the managing director since July 2007.

Mr. Kaplan's current administrative responsibilities include day-to-day operations of the center, including oversight of budget, publications and publicity, and CRLT's seminar series. He has published articles on the academic hiring process, the use of interactive theatre as a faculty development tool, and the evaluation of teaching. He has co-authored a chapter of McKeachie's Teaching Tips on technology and teaching, co-edited The Scholarship of Multicultural Teaching and Learning (Jossey-Bass, 2007) and a volume of New Directions for Teaching and Learning, and edited two volumes of To Improve the Academy (New Forums Press, 1998, 1999). With executive director Connie Cook, Mr. Kaplan edited Advancing a Culture of Teaching on Campus: How a Teaching Center Can Make a Difference (Stylus Publishing, 2011), a book describing CRLT programs and strategies authored by them and their CRLT colleagues. He is highly respected by the current director and the faculty and staff of CRLT.

It is my pleasure to recommend the appointment of Matthew L. Kaplan as interim director, Center for Research on Learning and Teaching, effective February 1, 2014.






