On the recommendation of the chair of the Department of Health Management and Policy, and with the endorsement of the Executive Committee of the School of Public Health, we are pleased to recommend the appointment of Jeffrey McCullough as associate professor of health management and policy, with tenure, School of Public Health, effective January 1, 2016.

Academic Degrees

Professor McCullough received a Bachelor's in biochemistry from Harvard in 1994 and a Ph.D. in health economics from the University of Pennsylvania in 2005.

Professional Record

After three years as an assistant professor at the Medical University of South Carolina, Professor McCullough moved to the University of Minnesota as an assistant professor in 2007, and was promoted to associate professor, with tenure, in 2014.

Summary of Evaluation

Professor McCullough's research focuses on technology and innovation in health care and the economics of health IT in particular. Health IT is a relatively new field in health economics, and Professor McCullough was among the first health economists to study the topic. A major research focus involves the economics of health IT and its effects on quality metrics and productivity. His work has advanced the empirical methods used to study health IT and has been broadly disseminated to the policy community. His studies on the effect of health IT on quality and efficiency of health care helped advance the methodological rigor of health IT research and helped rationalize expectations of IT value. Professor McCullough's work on mechanisms that affect the adoption and value of health IT found that realizing the full potential from electronic health records (EHR) systems may require changes in delivery system organization. In studies measuring the complexity of hospital productivity, he found that information technology was highly productive and under-utilized at the margin, contributing far more to efficiency than conventional hospital inputs. Furthermore, the latter studies showed that IT had modest effects on aggregate output, despite high marginal effects, because it constitutes a small share of total

inputs. This work has advanced the hospital productivity literature and demonstrated that hospitals receive substantial efficiency gains from health IT investments.

Professor McCullough is an outstanding teacher, recognized for teaching innovations in finance and empirical methods education at the University of Minnesota where he led the development and reorganization of the MHA curriculum in finance and accounting. In 2012, he received the Class of 1981 Faculty Award for Excellence in Teaching. He has shown deep commitment to teaching innovation, notably in the use of information technology and distance learning. The Department of Health Management and Policy has noted that Professor McCullough's online teaching experience will be of great value as the department increases the size of each executive master's annual cohort. He has been active in doctoral student mentoring, having served on seven doctoral committees, two of which he chaired. He has also directed five master's theses and advised numerous students in the MS, MHA, and PHAP programs.

Nationally, Professor McCullough has an impressive record of service having contributed substantially to the development of the relatively new field of Health Information Technology in health economics. In 2009, he co-founded the Workshop on Health IT and Economics that provides an annual forum to disseminate health IT research and facilitates interaction between researchers, policy makers, and practitioners. Professor McCullough participates in health IT policy panels including for the Office of the National Coordinator of Health IT and the National Science Foundation. He also prepares policy briefs on rural health IT policy. Professor McCullough served as the health IT theme leader for AcademyHealth and on their Health Economics Interest Group's advisory board from 2008 to 2014. He regularly organizes health IT sessions for the American Society of Health Economics and the International Health Economics Association. He participated in the launch of a new journal, *Health Care: The Journal of Delivery Science and Innovation* as the health IT section editor. He also served as the health IT editor for the American Journal of Managed Care through 2015.

On the recommendation of the chair of the Department of Health Behavior and Health Education, and with the endorsement of the Executive Committee of the School of Public Health, we are pleased to recommend the appointment of Alison Miller as associate professor of health behavior and health education, with tenure, School of Public Health, effective January 1, 2016.

Academic Degrees

Professor Miller received a Bachelor's degree in psychology from Wesleyan University in 1992, a Masters' degree and a PhD in developmental psychology from the University of Michigan in 1997 and 2000, respectively.

Professional Record

Following a two-year post-doctoral fellowship, Professor Miller served as a research assistant professor from 2002-2006 at the Warren Alpert Medical School of Brown University. She joined the University of Michigan Department of Health Education and Health Behavior faculty as a research assistant professor in 2006 and was promoted to research associate professor in September 2015. In 2007, she was also appointed as an assistant research scientist at the Center for Human Growth and Development; she was promoted to research associate professor, effective September 2015.

Summary of Evaluation

Professor Miller has made important research contributions on the effects of psychosocial stress on the early childhood development of regulatory systems in three areas: energy metabolism and obesity, sleep, and emotion. She has also contributed to the design and evaluation of interventions to improve parenting skills with a focus on the needs of low-income families and vulnerable populations. Professor Miller has had success in obtaining NIH funding for her research. Since arriving at Michigan, she has been awarded an R21 from NIMH to develop a prevention program for children of incarcerated mothers. She received an American Heart Association Award and a multi-PI R21 (with Dr. Lumeng) to study stress reactivity and obesity in low-income children. She has also been awarded two multi-PI R01 awards (with Dr. Lumeng) from NICHD to continue her work on stress and obesity in young children. Dr. Miller's publication record is solid, and demonstrates a clear trajectory of rapidly increasing productivity. Since arriving at Michigan, she has 49 peer-reviewed publications, 13 as first author and five as senior author. Her papers are in strong journals that span the research spectrum including basic developmental science journals, public health journals and journals focused on biological processes, reflecting her translational work that spans from basic biological processes to public health interventions.

Despite the fact that Professor Miller has been on a non-tenure track, she has been active in masters and doctoral student mentoring, having served at the School of Public Health as internship supervisor for a number of MPH students and on the dissertation committee of several doctoral students. In addition, she has advised students in the student biomedical research program at the Medical School, and served on undergraduate honors theses and on dissertations in psychology. She regularly gives guest lectures in both psychology and health behavior and health education courses.

Professor Miller serves as the director for the Community Outreach and Translation Core of the NIEHS-funded Children's Environmental Health Center, as the director for the pilot and feasibility grants program for the Momentum Center, and on the executive committee and as the director of the Clinical-Community Interventions Group for the Center for Human Growth and Development. These administrative roles demonstrate a substantial level of service. In addition, she is a reviewer for numerous journals and has served as a peer reviewer on special emphasis panels for NIH, and has recently been appointed as a regular member of a NIH study section.

Dr. Burke received his Ph.D. degree in molecular biology from the Washington University in 1988. Dr. Burke has 73 publications in top-tier journals and has received several awards throughout his career, including the University of Michigan Basic Science Research Award in 2004, and the Basic Science Teaching Award in 2012.

Dr. Burke is an excellent scientist whose work has garnered international recognition. He has made significant contributions to the Medical School through his teaching and service contributions. In addition to teaching, Professor Zint mentors both master's projects and PhD students. She has advised successful master's projects that have resulted in job offers to team members and articles in peer-reviewed publications. She has also developed and supported graduate seminars to respond to students' interest in climate change communication. Professor Zint has served on PhD committees across the university, and her own two PhD students have been successful in developing careers of their own. She has also consistently published with students in top journals in her field. She has effectively prepared students for the challenges of professional careers.

Professor Zint has participated on a variety of school committees, serving as coordinator of her field of study and as a member of the doctoral admissions committee. She has also provided considerable university-level service, including stints on the CRLT Faculty Advisory Board, the Erb Institute Executive Committee and the UM Research Impacts Team. She is actively associated with the Program in the Environment, teaching a large enrollment 200-level class, serving as a member of the PitE Advisory Committee, and, for one semester, serving as acting associate director. In addition, Professor Zint has developed a national reputation as a rigorous program evaluator. She has been on the editorial boards of three journals and served as a reviewer for several others, and for grants to NSF and the U.S. Department of Agriculture.

It is recommended the change of title for Sue A Gelman from Heinz Werner Distinguished University Professor of Psychology to Heinz Werner Distinguished University Professor of Psychology and Linguistics, effective December 1, 2015.

The first Distinguished University Professorships were created in 1947 by the Board of Regents to recognize members of the faculty for exceptional achievement and reputation in their appointive fields of scholarly interest and for their superior teaching skills. Each professorship is named in honor of an eminent individual—preferably one associated with the university—in the scholar's same general field of interest. Appointment to a Distinguished University Professorship continues to be one of the most prestigious honors conferred by the university upon a member of its faculty.

Professor Gelman graduated with a B.A. from Oberlin College, where she double-majored in psychology and classical Greek. In 1984, she received her Ph.D. in psychology from Stanford University. That same year, she joined the Department of Psychology at the University of Michigan as an assistant professor in psychology, was promoted to professor in 1991, and held the Frederick G. L. Huetwell Professorship from 1999 to 2013.

Professor Gelman has served in numerous administrative capacities at the university. These include acting as a member of the Executive Committee of the College of Literature, Science, and the Arts, as an assistant to the dean of faculty appointments in that college, as well as associate dean of the College of Literature, Science, and the Arts, where she was responsible for faculty appointments and research in the Social Science Division. In addition, she chaired the college's Committee on Promotion and Tenure that resulted in an overhaul of promotion and tenure reviews in the college, with more transparent processes.

Professor Gelman is an internationally renowned developmental psychologist who has significantly changed the way we look at children's memory, learning, categorization, and language. She is the author of over 200 scholarly publications, including a prize-winning monograph, <u>The Essential Child</u> (Oxford University Press, 2003). Her research has been funded by the National Science Foundation, the National Institute of Child Health and Human Development, the National Academy of Education, and other sources. She is a fellow of the American Academy of Arts and Sciences, the Association for Psychological Science, the American Psychological Association, and the Cognitive Science Society. Her honors include a J. S. Guggenheim Fellowship, and the American Psychological Association Distinguished Scientific Award for Early Career Contribution to Psychology. She served as a senior fellow of the Michigan Society of Fellows. In 2012, Professor Gelman was elected to the National Academy of Sciences.

As she continues the Distinguished University Professorship, Professor Gelman wishes to be renamed to the Heinz Werner Distinguished University Professor of Psychology and Linguistics.

Heinz Werner (1890-1964) was born and educated in Vienna. Following academic and research appointments in Vienna and Munich, he emigrated to the United States in 1933. For the next fourteen years, he was affiliated with the University of Michigan, Harvard University, and Brooklyn College. Professor Werner worked on perception and cognition in typically developing children as well as those with intellectual disabilities. He was appointed as a professor and chair of the Department of Psychology at Clark University in Worcester, Massachusetts in 1947. There he expanded his work on perception, language, and symbolic thought, taking a deeply interdisciplinary, comparative approach to these topics. This work led to the formulation of an influential theory of developmental psychology.
