Institutionally, Dr. Miller is a member of the executive and finance committees for University Hospital and the Cardiovascular Center. Since 2018, he has served as the chief clinical officer for University Hospital/Cardiovascular Center.

Dr. Miller is an outstanding example of the tripartite mission. Serving as an excellent investigator, clinician, and administrator he is most qualified to serve in these administrative capacities. I am very pleased, therefore, to recommend the appointment of David C. We are pleased to recommend the appointment of Cynthia A. McCurren as dean, School of Nursing, effective March 1, 2021 through December 31, 2025.

Cynthia McCurren received her B.S.N. in nursing and her M.S. in nursing, adult nursing, clinical nurse specialist degrees from the School of Nursing, University of Missouri, Columbia, Missouri. She then went on to earn her Ph.D. in nursing from the College of Nursing, University of Kentucky, Lexington, Kentucky. She began her academic career as an instructor at the School of Nursing, Southeast Missouri State University, and continually progressed through both academic and administrative ranks, to her most recent appointment of dean and professor, Kirkhof College of Nursing, Grand Valley State University in 2007.

At the national level, Professor McCurren's credibility as a leader in nursing education has been recognized by her increasing responsibility within the American Association of Colleges of Nursing (AACN) – the national voice for academic nursing education, with over 830 member schools. Her roles in AACN include board chair-elect from 2020-2022 and chair from 2022-2024; election for two terms to the Board of Directors; and multiple appointments to influential committee and task force assignments. In addition, she has served as a mentor for seven new deans. She has led numerous activities required by the Commission on Collegiate Nursing Education (CCNE) that include accreditation self-study/site visits, substantive review submissions, and continuous improvement progress reports. She is also an active participant in the Michigan Association of Colleges of Nursing and has served as the president for five years.

Professor McCurren has been recognized by Crain's Detroit Business with the 2019 Crain's Notable Women in Educational Leadership Award based on career accomplishments, track record for success in the field, contributions to community, and mentorship of others as one of her many career awards. Professor McCurren's research activities have been extensive including the publication of numerous journal articles along with two book reviews. In addition, she has written as a guest columnist for MLive and has served as a reviewer for professional journals.

Professor McCurren has a practical understanding of the complexities of academics in an urban institution and a proven commitment to cultural diversity, equity, and inclusion. Her commitment to community engagement partners with her drive for generating opportunities in an urban setting

while providing a pedagogy of teaching and scholarship for addressing and solving real-world issues.

With twenty years of proven successful progressive leadership experience in higher education, including several years as dean, Professor McCurren is well suited to succeed as our next dean of the School of Nursing.
