Subject:	Regental Action Required Under the State of Michigan Conflict of Interest Statute
Action Requested:	Authorization for the university to transact with NeoNest Global (University of Michigan Employee, Dhiya Krupashankar, Director and Board Member).

Background:

The University of Michigan Zell Lurie Institute seeks approval to transact with NeoNest Global for the Mayleben Venture Shaping/Dare to Dream grant program.

The proposed contract falls under the State of Michigan Conflict of Interest Statute as Dhiya Krupashankar is employed by the University as a Research Assistant I with the Mechanical Engineering Department and would be party to the contract as director and board member of NeoNest Global.

However, the Statute allows the University to enter into such contracts if the following conditions are met:

- a) The public servant promptly discloses any pecuniary interest in the contract to the official body which has power to approve the purchase, which disclosure shall be a matter of record in its official proceedings.
- b) The purchase is approved by a vote of not less than 2/3 of the full membership of the approving body in open session without the vote of the public servant making the disclosure.
- c) The official body discloses the following summary information in its official minutes:
 - i) The name of each party involved in the contract.
 - ii) The terms of the purchase, including duration, financial consideration between the parties, facilities or services of the public entity included in the purchase, and the nature and degree of assignment of employees of the public entity for fulfillment of the purchase.
 - iii) The nature of any pecuniary interest.

The following information is provided in compliance with the statutory requirements contained in Section (c) above:

- i) The parties to the contract are the Regents of the University of Michigan and its Zell Lurie Institute and NeoNest Global.
- The contract is for the Mayleben Venture Shaping/Dare to Dream grant program for one year at a total cost of \$8,500. NeoNest Global will be supplying all the necessary resources and personnel to fulfill this contract. The remaining base contract terms and conditions are typical of those used in Procurement Services standard templates for other similar contracts entered into by the Regents.
- iii) The pecuniary interest arises from the fact that University of Michigan employee, Dhiya Krupashankar, is a director and board member of NeoNest Global.

Dhiya Krupashankar has met state law requirements with the disclosure of her pecuniary interest and formal appointment arrangements with the University of Michigan. Requirements, if any, that may be applicable by the supervisor of Dhiya Krupashankar under the Medical School's or OVPR's Conflict of Interest Committee's procedures are separately analyzed and managed.

<u>We recommend</u> that the Board of Regents approve the contract between the University of Michigan and NeoNest Global subject to requirements, if any, that the supervisor of Dhiya Krupashankar or the Medical School's or OVPR's Conflict of Interest Committee may impose.
