On the recommendation of John M. Carethers, M.D., the John G. Searle Professor of Internal Medicine and Chair of the Department of Internal Medicine, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Richard J. Auchus, M.D., Ph.D. as professor of internal medicine, with tenure, Medical School, effective January 1, 2011.

Academic Degrees:

Dr. Auchus received the M.D. degree and the Ph.D. degree in pharmacology from Washington University in St. Louis in 1988.

Professional Record:

Dr. Auchus completed his residency in internal medicine at the University of Iowa Hospitals and Clinics in 1991, and a fellowship in endocrinology at the University of Texas Health Sciences Center in San Antonio. He then pursued postdoctoral research training in pediatric endocrinology at the University of California, San Francisco. From 1993-1995, he served as a staff physician at Wilford Hall United States Air Force Medical Center in Texas, and subsequently moved to the University of California, San Francisco as an assistant research endocrinologist in the Department of Pediatrics. In 1999, he was appointed as an assistant professor in the Department of Internal Medicine at the University of Texas Southwestern Medical School in Dallas. Dr. Auchus was promoted to associate professor, with tenure, in 2005, and then to professor in 2008.

Summary of Evaluation:

Dr. Auchus is a respected member of the scientific community who has been invited to speak at numerous regional, national, and international venues. His research focuses on adrenal disease and adrenal steroid biosynthesis. He is highly accomplished in this field, with more than 100 peer-reviewed publications and 19 book chapters. Dr. Auchus is also co-inventor on two patents. He has a solid record of grant funding; currently he has a Burroughs Wellcome Clinical Scientist Award in Translational Research and a March of Dimes grant, and is principal investigator on a center grant and two foundation awards.

Dr. Auchus has amassed an impressive record of teaching in didactic courses for graduate students, as well as bedside teaching in clinics. He is active in providing continuing medical education to fellows and residents. In 2007, he received the Jean D. Wilson, M.D. Award for Excellence in Scientific Mentoring at the University of Texas Southwestern Medical School. Dr. Auchus served as associate program director for the University of Texas Southwestern Medical Scientist Training Program and received outstanding teaching evaluations from residents at that institution.

It is anticipated that he will assume the directorship of the endocrinology fellowship program at the University of Michigan at the end of his first year of appointment.

On the recommendation of the chair of the Department of Epidemiology, and with the endorsement of the Executive Committee of the School of Public Health, we are pleased to recommend the appointment of Carlos Mendes de Leon, Ph.D. as professor of epidemiology. with tenure, School of Public Health, effective January 1, 2011.

Academic Degrees

Professor Mendes de Leon received a Ph.D. in 1988 from the University of Texas Medical Branch, Graduate School of Biomedical Sciences, Galveston, Texas. He majored in preventive medicine and community health.

Professional Record

Upon completion of the Ph.D. degree, Professor Mendes de Leon was a postdoctoral fellow in the Department of Medical Psychology, University of Limburg Medical School (The Netherlands) and a postdoctoral fellow in the Department of Epidemiology and Public Health at Yale University. He was later appointed as an assistant professor in the same department at Yale. From 1996 to 2005, Professor Mendes de Leon served as associate professor of medicine (epidemiology) and associate professor of preventive medicine at Rush University Medical Center. In 2005, he was promoted to professor in both departments. In 2008, he became the director of the Section on Community Epidemiology Research, Department of Medicine, Rush University Medical Center.

Summary of Evaluation

Professor Mendes de Leon's research focuses primarily on psychosocial influences in health during late life. Included within this work is an emphasis on disability, cognitive functioning, and health disparities (especially those involving Latinos). He has substantial expertise in the methodological aspects of community-based epidemiologic research and he works closely with a wide range of multidisciplinary research teams. Professor Mendes de Leon has published 113 articles in peer-reviewed journals and 10 chapters in edited volumes. Of these peer-reviewed papers, he is either the first or sole author of 30. Since becoming a professor in 2005, Professor Mendes de Leon has published a total of 43 peer-reviewed papers. His work has consistently been published in the best journals, including: the American Journal of Public Health, the

American Journal of Epidemiology, Archives of Internal Medicine, and the Journal of Gerontology: Social Sciences. Professor Mendes de Leon has a solid record of funding from the National Institutes of Health. He is presently the principal investigator of two RO1s and co-investigator of three RO1s all of which have been funded by the National Institute on Aging.

Professor Mendes de Leon has taught at Rush University for the past 14 years as a lecturer in epidemiology and biostatistics. Moreover, he has been an individual research mentor for 11 junior faculty members at Rush University Medical Center. He has been a faculty member of the National Institute of Health Summer Institute on Randomized Clinical Trials Involving Behavioral Interventions.

Professor Mendes de Leon has been very active in service at the national level. He has served on several grant review panels for the National Institute on Aging, the National Institutes of Health Center for Scientific Review Epidemiology of Chronic Disease/Cardiovascular and Sleep Epidemiology, the American Heart Association, and the Netherlands Organization for Scientific Research. He currently serves on the editorial boards of four journals: *Journal of Aging and Health, International Journal of Behavioral Medicine, Psychosomatic Research,* and the *Archives of Internal Medicine.* In addition, he was the associate editor for the *Journal of Gerontology: Social Sciences* from 2006-2009.

Ward Professor of Dentistry Emeritus, professor emeritus, and research scientist emeritus in 1989.

At the University of Michigan, Professor Ash founded and chaired the first occlusion department in the United States from 1969-1987, directed the TMJ/Oral Facial Pain Clinic and Stomatognathic Physiology Laboratory from 1969-1987 and was a member of many School of Dentistry committees, including several appointments to the Executive Committee. Professor Ash was also active throughout his career with numerous local, state, national, and international dental and periodontal associations. Professor Ash published more than 200 articles in scientific journals and was well known for his 70 textbooks. During his career, Professor Ash did field research with the Nubians in Southern Egypt, developed the first miniaturized electronic tooth, and was mentor to over 100 graduate students.

During his distinguished 53-year career with the University of Michigan, School of Dentistry that began in 1953 and continued after he retired in 1989. Professor Ash established a global reputation as a clinical researcher, prolific writer, mentor, and professor extraordinaire.

A distinguished faculty member will be nominated to receive this honor. The initial term of appointment will be for five years with the possibility of renewal.

On the recommendation of John M. Carethers, M.D., the John G. Searle Professor and Chair of the Department of Internal Medicine, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the establishment of the Eric J. Topol Collegiate Professorship in Cardiovascular Medicine, Medical School, effective January 1, 2011.

This collegiate professorship is being established through resources within the Division of Cardiovascular Medicine in the Department of Internal Medicine. The University of Michigan Cardiovascular Center also intends to support this professorship through funds derived through philanthropy. The Topol Collegiate Professorship in Cardiovascular Medicine is intended to support the academic endeavors of a senior faculty member in the Department of Internal Medicine with expertise in cardiovascular medicine. The recipient also may serve as the clinical or research director of the Cardiac Catheterization Laboratory in the Division of Cardiovascular Medicine. The initial appointment period for the Topol Collegiate Professor may be up to five years, and the appointment may be renewed.

Dr. Topol is a world renowned cardiologist who was a faculty member at the University of Michigan from 1985-1991, where he rapidly rose through the academic ranks to achieve the title of professor of internal medicine. From 1987-1991, he served as director of both the Cardiac Catheterization Laboratory and the Interventional Cardiology Program in the Department of Internal Medicine at the University of Michigan. This was a time of rapid advancement in the treatment of acute myocardial infarction. Dr. Topol was instrumental in defining the role of coronary thrombolysis as a lifesaving treatment for acute myocardial infarction, with later seminal contributions in understanding the role of platelets, percutaneous coronary interventions, and genetics in acute coronary syndromes. Dr. Topol has been recognized by the Institute of Scientific Information (ISI) to be in the top 10 cited biomedical researchers in medicine over the past decade. He was elected to the membership of the Institute of Medicine, National Academy of Sciences in 2004.

This professorship will honor Dr. Topol for his many clinical and research contributions to the subspecialty of interventional cardiology at the University of Michigan and to the field of cardiology. Joseph P. Gone completed his Bachelor of Arts at Harvard College in 1992. He attended the University of Illinois where he received his Master of Arts in 1996 and Doctorate in 2001. Professor Gone began his teaching career as an assistant professor at the University of Chicago in 2000 and was appointed to the tenure track at Michigan in 2002. He was promoted to associate professor, with tenure, in 2010.

Professor Gone plays an important role in the Native American ethnic studies group, Program in American Culture, but it is difficult for him to find appropriate courses to teach. In the Department of Psychology he has played a central role in revamping the clinical psychology training program. He endorses the importance of training students in cultural variations in how mental illness becomes apparent, how it is diagnosed, how the community responds to such a diagnosis, and how it is treated. Diagnosis and treatment are not the same for everyone. He models for students the ability to attend to cultural differences while engaging in scientifically valid research on mental health diagnosis, treatment, distributions of services, etc.

On the recommendation of the Executive Committees of the Honors Program and the College of Literature, Science, and the Arts, we are pleased to recommend the appointment of Dick Siegel as the Helen L. DeRoy Visiting Professor in Honors, College of Literature, Science, and the Arts, effective January 1, 2011 through April 30, 2011. Mr. Siegel held this title during winter term 2010. The course was so well received by the students in the Honors Program that we are inviting him back to serve in this role for a second term.

In 1981 the Helen L. DeRoy Visiting Professorship in Honors was established to support the University's Honors Program. The Honors Program's DeRoy Visiting Professors Subcommittee selects and nominates distinguished visitors, with preference to those outside the academy, to teach in the Honors Program.

Dick Siegel graduated with honors in English from the University of Michigan, where he was also a Hopwood Award winner. He has achieved renown in an active performance and composing career around the country. A member of the Detroit Music Hall of Fame and the recipient of awards such as multiple Detroit Music Awards and the Kerrville Music Festival's New Folk Award, Mr. Siegel is known for his engagingly unconventional lyrics and a dynamic musical style that incorporates modern folk and jazz. Trained in classical music, he discovered the powerful imagery in Dylan Thomas' and T. S. Eliot's poetry while studying English literature; these influences are still seen in his lyrics. Mr. Siegel was named in WDET's list of the most important and influential artists in the history of Detroit, alongside such legends as Stevie Wonder and Aretha Franklin. A longtime National Public Radio staple, his songs have been featured on stations such as Austin's KUT, New York's WFUV, and San Francisco's KPFA, as well as syndicated shows including *Mountain Stage* and *All Things Considered*.

Mr. Siegel will again teach a course for the Honors Program entitled "Singing Out of Our Minds": A Songwriting Workshop. He and the students in this course will also present a public performance at the end of the semester. He has already given a "Lunch with Honors" presentation to students. This course is part of our endeavor to encourage interdisciplinarity and creativity. Music is a vital part of the life of many students; this course seeks to develop that interest in the context of their intellectual lives.
